3. Waste Management

- The Council as joint lead authority with Tipperary County Council launched a 6 year Waste Management Plan on the 14th May 2015 at the Limerick Institute of Technology campus in Thurles: "The Southern Region Waste Management Plan 2015-2021."
- More information is available on <http://www.southernwasteregion.ie>
- Signing of the Conditional Agreement to Lease lands at Gortadroma Landfill to enable Cadence Environmental Ltd. to seek planning permission and a waste licence for a Waste to Energy Gasification plant. The proposed plant will if it goes ahead convert up to 1,000 tonnes per day of Household waste into 36 MW of Power.

4. Awareness

- The Environment Department stepped up its Dog Fouling Awareness Campaign aimed at encouraging dog owners to clean up after their animals when they foul in public areas.
- Issued press release and raised awareness through radio interview.
- Officials and Environmental Inspectors have been on patrol meeting with dog walkers to raise awareness about their responsibilities.
- Waste Management & Prevention Talk to the Galbally Tidy Towns Group and local residents.
- Representatives from Tidy Towns across the City & County attended a Tidy Towns Application Workshop in Dooradoyle Offices.
- Launch of Limerick Going for Gold Environment Improvement Grant Scheme & Competition (incorporating Limerick in Bloom) in the Medieval Garden in Merchants Quay Office.
- 50 Limerick Schools were awarded their Green Flag at an awards ceremony in Cork.
- Waste Management & Prevention Talk to the Caherdavin Tidy Towns Group and local residents.

5. PPN/LCDC Progress

Public Participation Network

- The Public Participation Network (PPN) Secretariat was established using a purpose-built voting platform, PPN.ie.
- There are 9 members on the Secretariat representing the 4 Municipal Districts and the 3 Sectors (Community & Voluntary, Social Inclusion, Environment). There remains one seat to be filled from the Environment Sector.
- Its initial priorities are to establish its own operating protocols and procedures, and to undertake a pilot process to select PPN representatives onto the Environment SPC in June.
- At its most recent meeting it made the decision to complete filling of PPN seats onto Council committees (SPCs, JPC & LCDC) in September.
- The Secretariat has been requested by the Council to facilitate public consultation on the Local Economic & Community Plan (LECP) and the Heritage and Biodiversity Plan.

Local Community Development Committee (LCDC)

- Rural Development Programme: An agreed single Rural Development Programme Expression of Interest for Limerick was submitted by deadline of 15 May, 2015.
- LECP: Final draft of Socio-Economic Statement and High Level Goals was adopted by LCDC and Economic Development and Planning SPC. Public consultation for Socio Economic Statement (SES) and High Level Goals (HLG) to be undertaken.

6. Africa Week / Limerick Intercultural City

A successful week of events has just been completed to mark Africa Day 2015. The main events were:

- Seminar on Integration and Interculturalism "Footprints: Our Shared Journey, Our Integration".
- Ethiopian Modern Dance Performance in University of Limerick.
- A Dance and Art Workshop was held in Watchouse Cross Community Library.

- Africa Day Festival in the Milk Market was held. Food stalls, dancing, singing, drumming, fashion show, children's games and activities (provided by Limerick Sports Partnership).

7. Caherdavin Community Centre

- Community section has committed to supporting the Centre to improve its infrastructure and services in 2015. To this end an architect has been appointed to undertake a feasibility study which will inform the Community Centre's application for planning permission and for funding to undertake improvement works.
- PAUL Partnership has been appointed to provide community development support to the Centre
 - strengthening its management and governance processes
 - develop a plan for its growth over the next few years
 - develop a funding proposal for JP Benevolent Fund.

8. Estate & Tenancy Support

1. Watergate Flats - New Residents Committee elected. Ongoing meetings between Council officials and residents regarding upgrade works in CCTV and access security.
2. Thomondgate Residents Association - Initial meeting held with secretary and number of issues discussed. CCTV camera installed opposite laneway identified as trouble spot for anti-social behaviour.
3. Abbeyfeale Council Estates Committee - Security fencing installed at Hillview Drive and Fr. Casey Close.
4. Mountain View Kilfinane - Damaged decorative fencing replaced.
5. Cappamore Estates Committee - Assistance provided for committee's 2015 work programme.
6. Scanlon Park Residents Committee Castleconnell - 160 metres of timber picket fencing installed with the help of staff from the Ballyhoura Rural Social Scheme and enthusiastic local volunteers. Workshop held with committee members on the 7th May in preparation for judging of Pride of Place entry scheduled for the 9th July.
7. Bi-annual meeting of Estate Residents Representative Forum held on the 28th May in Council Chamber, Dooradoyle. Addresses and presentations by Milford Hospice, representative of Irish Men's Shed Association, and co-ordinator of Limerick Sports Partnership.
8. Pre-tenancy training meetings: 41.
9. Intensive support provided to tenants who may have been identified as being vulnerable or in need of such support for any other reason. In addition, there is

monitoring of individual tenancies that may require particular attention to prevent problems occurring.

9. Tenancy Enforcement

1. Number of complaints received: 80
2. Number of cases opened: 36
3. Number of interviews conducted: 78
4. Number of verbal/written warnings: 8
5. Other actions: 4 properties taken back into stock following service of Abandonment Notices. One property voluntarily surrendered following serious incident.

A very notable development in the area of tenancy enforcement occurred with the enactment of new provisions contained in the Housing (Miscellaneous Provisions) Act 2014 dealing with anti-social behaviour and tenancy breaches generally, including improvements in existing powers in relation to seeking Excluding Orders against individuals. In relation to the latter, two applications were scheduled for hearing in mid-June.

10. Libraries Update

An Art Exhibition by Adult Learners from Shanagolden Vocational Training Opportunities Scheme (VTOS) group was launched at Newcastle West library on Thurs 28th May. The event drew a large attendance of over 60 people. The exhibition which continues until 16th June contains some beautiful works.

The Granary Library, in association with the Hunt Museum hosted an evening of stories & dress-up with 800 years of fashion to celebrate **Bealtaine Festival**. Children & their Grandparents were shown clothes/costumes from the past & learned about the societies that wore them. They were given the opportunity to dress up as Elizabethan nobility or medieval serfs.

The wonderful **RTE Contempo Quartet** continued with its **"Father & Sons"** lunchtime concert series. Among the musical pieces performed was a composition by **Bill Whelan – Quintet for voice & string quartet** and the guest artist on this occasion was the soprano **Deirdre Moynihan**. Over 110 people attended the event.

The Granary Library hosted a lunchtime performance by the great **Freddie White**. With well over 80 people in attendance, the gig proved to be a great success. Watch house Cross Library participated in the City and County wide celebrations for Africa Week. On Thursday 28th May, two African drumming workshops were

attended by pupils from St. Munchin's NS, Hassett's Cross. In addition, 20 pupils from 6th Class took part in an art workshop facilitated by Jean Ryan Hakizimana.

Watch House Cross Library marked its 8th anniversary of the opening of the library with a party for the Mother and Toddlers Group and refreshments for their customers. In the 8 years since its opening, Watch House Cross has established itself as an integral part of the community. In 2014, Watch House Cross Library issued over 86,000 books to over 3,300 members with over 82,500 visits to the Library.

11. Ireland 2016 Centenary Programme

As part of the **Community Participation Strand** of the **National Programme – Ireland 1916**, four Public Consultation Meetings were held to facilitate individuals and community groups throughout Limerick City and County to put forward and share ideas, pool resources and be part of the creation of a unique and distinctive local programme to mark **Ireland 2016**. The venues for these meetings were (Metropolitan Area) the Granary Library, Newcastle West Library, Kilmallock Library and the Rathkeale Arts Centre. There was a good turnout and there were several interesting and innovative proposals. In addition, a media publicity campaign was held which included radio and newspaper interviews, press releases, public calls for submission and website and social media campaigns.

12. Limerick Archives & Arts Update

Archives

Limerick Museum and Archives launched 'Stand Up and Fight' a major exhibition marking Limerick's role in the First World War and exploring Limerick's military history from 1691 and the departure of the Wild Geese. The exhibition showcases key objects from the Museum's collection including an oar from one of the Lusitania's lifeboats. 80 per cent of the objects have been loaned by collectors and families reflecting that over 4,000 men from Limerick fought in the war and of these 1,057 died. Their names are

on display in the exhibition which is supported by local stakeholders including the Royal Munster Fusiliers Association and the Naval Association.

Arts

- Funding to the Arts Office awarded for Culture Night 2015 from the Department of Arts, Heritage and Gaeltacht Affairs.
- Open call advertised for Artists' Studio, James Street and Cappamore Arts Studio and call out for bursaries for Tyrone Guthrie Bursary, Irish Youth Choir Summer Course Bursary and Drama League of Ireland Summer School.
- Youth Arts Programme (Integrated Dance, County Limerick Youth Choir, County Limerick Youth Theatre and Artists in Schools) and Music Programme (Contempo Quartet, Father and Sons, in partnership with the Library at The Granary) in progress.

13. Emergency Services

Fire and Emergency Operations Plan

Each fire authority which maintains a fire brigade is required to prepare what is termed in the legislation as a 'Fire and Emergency Operations Plan', which sets out how it meets its statutory duties. Adoption of the Section 26 Plan is a reserved function.

Limerick City and County Council fire service will undertake a review of its current services in light of the approaches and the targets of national policy and prepare an updated / revised statutory Section 26 Plan in 2015. The new Section 26 Plan will set out the individual service's overall approach to delivering the targets set out in national policy. It will be complemented by Annual Service Development Plans which will set priorities and targets for change on a year-by-year basis.

Transition Year Courses

Limerick Fire & Rescue Service recently ran two Transition Year Courses in Rathkeale & Kilmallock where 25 students undertook a one week training course. Students received basic training in fire service drills, combustion science, fire prevention and emergency first aid.

Economic Development and Planning

1. Economic Development & Property:

- The Council purchased Limerick's Cleeves site. This 8 acre city centre brownfield site has been purchased from the Kerry Group. The Council will now commence the preparation of a masterplan/urban design for the site.
- The Council has published a request for tenders on eTenders/European Union Official Journal (EUOJ) for a Design Team for the Hanging Gardens office development. Once planning permission issues the Council will tender for a Contractor.
- Following publication of expressions of interest for the Opera site redevelopment significant interest has been received from the market. An assessment of the submitted expressions of interest is due to take place.
- Work is on-going on pilot Urban Garden at O'Connell St. /Cruises St.
- The Living Cities Initiative (tax incentive) for designated Georgian areas was officially launched in Limerick, Dublin, Cork, Galway, Waterford and Kilkenny during May 2015.

2. Forward Planning

- The variations to the Limerick County Development Plan and the Limerick City Development Plan to incorporate the Shannon Integrated Framework Plan for the Shannon Estuary were adopted at the May Council Meeting.
- The public display of the issues document for Mungret, in advance of the amendment to the Southern Environs Local Area Plan took place.
- The statutory public display period for the amendment to the Croom Local Area Plan to incorporate additional zoned land for educational use commenced.
- The Golden Mile Competition was launched.

3. Local Enterprise Office

The Local Enterprise Office (LEO) is delivering the Spring/Summer Training and Development Programme for enterprises in Limerick. Activity during May included the following:

- Mentoring –
 - 2 mentor clinics for 8 clients
 - 10 additional mentor assignments
- Training programmes for business including Time Management, Assertiveness, Pricing for Craft Business -

15 clients

- 6 week start your own business programme - 9 attendees
- Business skills for Childcare providers – 18 businesses
- Retail Development Programme for Newcastle West – 13 participants
- Go to Tender programme with Intertrade Ireland – 15 clients
- Food Academy Start Programme with Bord Bia and Super Valu – 10 food businesses
- Business Advice clinics held during May for 20 clients.

Regional Women in Business Network Event for Clare, Kerry, Limerick, North Cork and Tipperary was held in the Woodlands Hotel, Adare and 72 business women attended. The Limerick Women in Business Network meets 5/6 times per annum.

Financial assistance approved in the month:

- Priming Grants - €29,935
- Business Expansion Grants - €35,000
- 4 applications submitted to Microfinance Ireland – average loan €19,000
- 4 applications for Trading on line Vouchers approved.

To date in 2015 LEO Limerick has approved a total of €660,496 for 32 eligible businesses as follows:

- 20 priming grants for new start up businesses
- 10 Business expansion grants for existing businesses
- 2 Feasibility Studies.

3. Innovate Limerick

Innovate Limerick has agreed the purchase of former Dell/Culture Factory building in Castletroy on behalf of the Council. This 350,000 sq ft building on 25 acres will be used to house the Mid West's first film studio hub in association with Ardmore Studios which could result in the creation of 750 new jobs in Limerick and a commercial spin off of €70 million for the local economy.

4. Travel and Transport

The following appointments were made during May.

National Road Overlays

- Kilgallen & Partners, Engineering Consultants, have been appointed to progress the design of junction improvements on the N20 at O'Rourke's Cross and on the N24 at Beary's Cross.
- MHL, Consulting Engineers have been appointed to progress the design, and prepare contract documents

for two pavement overlay projects on the N21 at Ballinlyny and Ballymurragh.

- Roadplan Consulting Engineers have been appointed to progress the design of the N21 Adare western approach pavement overlay scheme.

Bridges

- Bridge Rehabilitation Programme – Non-National Roads 2015 - Malachy Walsh & Partners have been appointed for Design and Tender of these works.
- R515 Garrienderk Bridge, Killmallock – Michael Keating Plant Hire have been appointed for the construction of embankment stabilisation and Safety Barrier installation.

Limerick Smarter Travel

National Bike Week 2015 takes place from the 13th - 21st June. A full programme of events has been agreed. The highlights of this event will be the Family Bike parade on Sunday 21st and the Bespoke Festival Expo on Saturday 13th June.

A full programme of all events held in the City and County is available on the website www.smartertravel.limerick.ie and brochures will be circulated.

Route 2 Phase 2, Park Bridge Canal Walkway/Cycleway, City to University of Limerick.

The Council granted a Part 8 Planning application at the May Metropolitan Council Meeting, for work to upgrade Park Bridge and a section of Park Canal which forms part of Route 2 City to University of Limerick walkway/cycleway. Construction is due to commence this summer.

The aim of the design for Park Bridge and Park Road is to create an area that controls vehicle speeds and provides continuous and safe access for pedestrians and cyclists which would ultimately connect Corbally, UL, Castletroy and the City Centre.

Limerick Smarter Travel (LST) Route 4 Castletroy and Newtown Junction Improvements

Tenders have been received for this scheme and assessed and a contractor will be appointed.

30KPH Speed Limit

Following on from the recent publication by the Department of Transport of The Guidelines for Setting and Managing Speed Limits in Ireland, the Council will commence a programme in 2015 of introducing 30kph

speed limits to Housing Estates. In this regard 30kph speed limits will be introduced in 30 Housing Estates throughout the City and County in locations to be agreed with the Members, 5 per each Municipal District and 15 in the Metropolitan District. The roll out of 30kph speed limits in housing estates will be continued in 2016.

Organisational Development

1. Change Liaison Network

To improve two way communication between staff, a new network has been set up and had its first monthly meeting in May. Following expressions of interest sought from all staff via Directors, 25 staff members came forward representing the full range of the Council's services. All information, including a list of the people on the network, is available on the Change Liaison Network folder on the intranet.

2. Staff Briefing Sessions

Change Management supported Human Resources in the roll-out of 10 sessions in Council venues. A presentation was given covering an update on the Change Management Programme and, in particular, the Organisational Development Programme including the development of a Staff Training Programme, a first for the organisation. One of the information displays was Project Management - an approach being adopted on a cross-organisational basis.

3. New Property Unit

This new unit as part of Asset Management has completed process mapping of the current services with all staff involved in this area of work.

4. Customer Relationship Management (CRM)

Sugar CRM system continues to be rolled out across the organisation with Finance and Emergency Services, Planning, Economic Development, Home and Social Development and Roads underway.

5. Civic Receptions

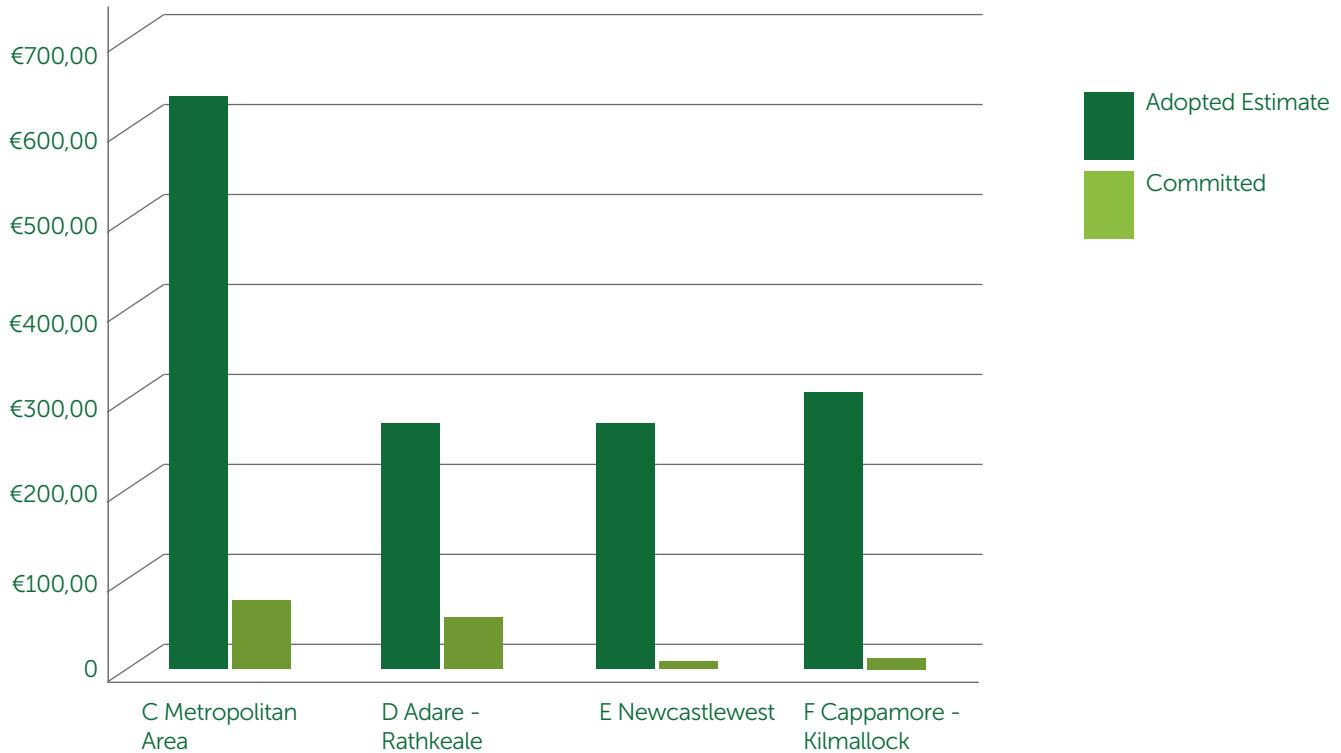
