Limerick City and County Council

Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2016

Limerick City and County Council in exercise of the powers conferred on it by section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), hereby makes the following bye-laws in respect of certain regional and local roads within the administrative area of the County of Limerick City and County.

1. These Bye-Laws may be cited as the Limerick City and County Council Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2016.

2. These Bye-Laws shall come into operation on the 28th day of December, 2016.

3. In these Bye-Laws:

“The Act of 2004” means the Road Traffic Act, 2004 (No. 44 of 2004);

“local road” has the meaning assigned to it by the Roads Act, 1993 (No. 14 of 1993);

“regional road” has the meaning assigned to it by the Roads Act, 1993 (No. 14 of 1993);

“road” means a public road.

4. The provisions of the Limerick City Council Special Speed Limit Bye-Laws 2014, Limerick County Council Road Traffic (Speed Limits) County Limerick Bye-Laws 2013, Limerick County Council Road Traffic (Speed Limits) County Limerick Bye-Laws 2011, and Limerick County Road Traffic (Speed Limits) County Limerick (No.2) Bye-Laws 2011 insofar as they apply to any of the roads or part thereof referred to in the sections A to F of these Bye-Laws are hereby amended insofar as they relate to the said roads or part thereof with effect from the date on which these bye-laws come into effect.

Section A

Metropolitan District of Limerick

Electoral Area of Limerick City East

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All roads within the housing estate of Elm Park, Limerick from its junctions with the L-1118 Plassey Road and its junction with L-5157 Kilmurry.
2. All roads within the housing estate of Glenside, Limerick from its junction with the L-1165 Castletroy College Road.
3. All roads within the housing estates of River Glen, Georgian Village, Meadowlands, Willowgrove , Butterfield Crescent and Derrynane in Limerick, from their junctions with the R512 Kilmallock Road.
4. All roads within the housing estate of Milford Grange from its junction with the L-1117 road linking the R445 Dublin Road with L-1118 Plassey Road.
5. All roads within the housing estate of Riverbank from its junction with the L-1113 Newtown Road, Rivers, Annacotty.

Section B

Metropolitan District of Limerick

Electoral Area of Limerick City West

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All roads within the housing estates of Ballinacurra Gardens/Oakview Drive, Limerick from their junction with the R526 Ballinacurra Road by Baggots Boreen, their junction with the R509 Childers Road and their junction with L-10469 Greenfields Road.
2. All roads within the housing estates of Glencairn/Ballycummin Village, Limerick from their junction with the L-1443 Church Hill Meadows, and their junctions with the L-1405 Upper Church Road.
3. All roads within the housing estate of Kilteragh, Limerick from its junction with the R926 Dooradoyle Road.
4. All roads within the housing estates of Lisheen Park and Marian Park, Patrickswell from their junction with the R526 Main Street, Patrickswell.
5. All roads within the housing estates of Log na gCapall and Greenpark Close, Limerick from their junction with the L10441 South Circular Road.

Section C

Metropolitan District of Limerick

Electoral Area of Limerick City North

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All roads within the housing estate of Caherdavin Lawns, Limerick from its junction with the R445 Ennis Road.
2. All roads within the housing estate of Irish Estates, Limerick from its junction with the R463-3 Corbally Road at Lanahrone Avenue and its junction with the R463-2 Corbally Road at Shannon Drive.
3. All roads within the housing estate of Woodview Park, Limerick from its junction with the L-8078 Old Cratloe Road.
4. All roads within the housing estate of Moyross, Limerick from its junctions with the L-10001 at Castlepark, Hartigan Villas and the Moyross Road, and all roads within the housing estate of Ballynanty from its junction with the R464-5 Kilkeely Road at the Ballynanty Road, and the junction of the Knockalisheen Road with the R445-29 Cratloe Road.
5. All roads within the housing estates of Saint Marys Park, Assumpta Park, Verdant Place, Island Road and Island View Terrace from the junctions of the L-10090-2 Verdant Place, L10105-0, L-10123-2, and the L-10099-0 with the R445, and all roads within the housing estates of Lee Estate and Abbey View from their junctions with the R445 Island Road.

Section D

Municipal District of Adare-Rathkeale

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All roads within the housing estate of St Mary's Park, Rathkeale from its junction with the R518 New Road and from the entry point to the estate from the L-6164 which is 165m from the junction of the L-6164 with the R523 Regional Road.
2. All roads within the housing estate of Plunkett Road Estate, Askeaton from its junction with the R518 Regional Road and its junction with the L-1221.
3. All roads within the housing estate of Parkview Estate, Shanagolden from its junction with the L-6118.
4. All roads within the housing estate of Deerpark Estate, Adare from its junction with the L-1422 Blackabbey Road.
5. All Roads within the housing estate of Kylefea Estate, Croom from its junction with Regional Road R516.

Section E

Municipal District of Cappamore-Kilmallock

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All Roads within the housing estates of Glenfield Estate and Radharc na Cille Estate, Kilmallock from their junction with the R512 Regional Road.
2. All Roads within the housing estate of Sycamore Drive, Bruff from its junction with the R512 Regional Road.
3. All Roads within the housing estates of Galtee View and Glenview Drive , Hospital from a point 165 metres north-west of the junction with R516 Regional Road.
4. All Roads within the housing estates of Ceol na hAbhann, Caherconlish from its junction with the R513 Regional Road at Caherconlish Village.
5. All roads within the housing estates of Ros Fearna and The Meadows, Murroe from their junctions with the L1161 road linking Murroe Village to the 5-cross roads.

Section F

Municipal District of Newcastle-West

Roads in respect of which a special speed limit of 30 kilometres per hour is prescribed:

1. All roads within the housing estate of Collins Park, Abbeyfeale from its junction with the L7112.
2. All roads within the housing estate of Ferndale Estate, Newcastle West from its junction with the R522 Dromcollogher to Newcastle West road.
3. All roads within the housing estate of Winfield Orchard Estate, Newcastle West and its junction with the R522 Regional Road.
4. All roads within the housing estate of Hillside Drive, Athea from its junction with the R524.
5. All roads within the housing estate of Marian Place, Glin from its junction with the R524 Regional Road.

The Limerick City and County Council Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2016 are made and adopted under the Common Seal of Limerick City and County Council this, the 28th Day of November, 2016.
