The applicant must also contact the Council to arrange a site visit pre construction/refurbishment so as to obtain photographic evidence. Limerick City and County Council will review the application and will issue an interim acknowledgement once satisfied that the information provided is accurate and reasonable. The acknowledgement will contain a unique reference number (URN) which the applicant must quote when requesting a Letter of Certification. In order for Limerick City and County Council to consider issuing the letter of certification pursuant to the Living City Initiative Scheme, on completion of the works the applicant must provide to the Economic Development Directorate of the Council a letter of opinion from a suitably qualified professional such as an Architect or Engineer regarding the following information:

- In cases where planning permission is not required, please provide an opinion of compliance outlining why the works are considered exempt from requirement to obtain planning permission. The opinion must also confirm compliance with the Building Control (Amendment) Regulations 2015;
- In cases where planning permission is required a certificate of compliance on completion signed by the assigned certifier and the

competent builder as outlined by the Building Control (Amendment) Regulations 2015 must be provided;

Limerick City and County Council will not issue a Letter of Certification pursuant to the Living Cities Initiative Scheme until the above certificate/opinion has been received and a post completion inspection has been undertaken.
