Dear Mr O'Callaghan,

Thank you for your email on behalf of the members of the municipal district of Adare - Rathkeale.

Properties in the Knockroe area closest to the reservoir experience low pressure if the reservoir levels drop. Irish Water are currently upgrading the monitoring and alarm system to allow reservoir levels to be monitored.

Network controls are also being installed enabling improved leakage management which will assist in maintaining reservoir levels.

There were disruptions in the area in early March when new watermains in the Kildimo area were being commissioned but these works are now complete.
