Lease of Lands at Ballinacarriga, Kildimo

A Chomhairleoir, a chara,

Limerick City and County Council is owner of lands comprising 2.272 hectares at Ballinacarriga Kildimo on the shore of Bleach Lough. The Council leased these lands to Bleach Lough Anglers Ltd. in 2009 for a nominal fee of €5 per annum for six years in order that Bleach Lough Anglers Ltd. could provide mooring and changing facilities with grant aid provided by West Limerick Resources Ltd.

The Bleach Lough Anglers applied for a renewal of the lease early this year. The Company has published Annual Certified Accounts, kept the property insured and held AGMs. The renewal of the lease has been discussed at a number of meetings of the Municipal District of Adare/Rathkeale.

The elected Members of the Adare/Rathkeale Municipal District agreed by a majority decision at their meeting on 8<sup>th</sup> September 2015 to recommend granting of the lease at the next available meeting of the full Council.
