Thank you for your letter of 24 April 2017 requesting that Transport Infrastructure Ireland (TII) make direct arrangements for the collection of litter on national roads in County Limerick. The position in relation to your enquiry is as follows.

I can confirm that the roles required by TII and local authorities in this matter are set out in Section 19(2) of the Roads Act (as amended) which states that:

"The Authority shall, as far as possible, arrange for the functions shall be performed on its behalf by the relevant road authority, but in any case where the Authority considers that it would be more convenient, more expeditious, more effective or more economical that the function concerned should be performed by it, it may decide accordingly."

On the basis of the above, TII implemented three regional motorway maintenance and renewals contracts (MMaRC) to undertake road maintenance activities on the motorways. In the case of Limerick City and County Council's administrative area, the M7 and short sections of the M20 and M21 are covered by the MMaRC contracts. Thus litter collection and other maintenance activities are undertaken by TII's contractor for the aforementioned sections of national roads.

It is intended to investigate the feasibility of extending the operation of the contracts and the Council's resolution with regard to litter collection will be considered in this context.

I refer to your recent correspondence to the Taoiseach regarding the Post Office Network in rural Ireland which was forwarded to me for direct reply.

It is Government policy that An Post remains a strong, viable company and in a position to provide a high quality, nationwide postal service and that it maintains a nationwide customer-focused network of post offices in the community. However, the postal sector as a whole is undergoing systemic change as a result of the growth of the digital economy. The continuing decline in mail volumes, combined with the ongoing impact of e-substitution on retail businesses transacted through the post office network, is a significant challenge for the company and has an impact on its financial well-being.

A fundamental review of An Post, including the post office network, which will identify the strategic changes and restructuring necessary to maintain the company on a sound financial footing is ongoing.

The Government is acutely aware of the value placed on post offices by communities in both rural and urban areas. Managing the scale of the challenge facing An Post will require a focus on innovation and new business models by the company as well as the development of new commercial strategies. In so far as the commercial and operational activities of the company are

concerned, the board and management of the company are constantly working to ensure that the services the company provides are developed and delivered to meet the needs of its customers. As a shareholder, however, I have a strong interest in the commercial and financial position of the company and regularly liaise with the company in this regard. The future sustainability of An Post and its relevance to consumers is recognised as an important priority for all involved.

On foot of a reconfiguration of Government Departments in July last year, responsibility for the post office network transferred to the Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs. That Department published the Final Report of the Post Office Hub Working Group in March in which it was outlined that they are pursing the possible opportunities for services such as community banking and motor tax renewal for the network. Arrangements are in hand to reassign responsibility for the post office network to my Department given my overall responsibility for An Post and the recommendations of the Post Office Hub Working Group will continue to be finalised.


Decisions in relation to the operation of the post office network are operational matters for the Board and management of An Post and not ones in which I, as Minister, have a statutory function. Nonetheless, I will continue to monitor the position closely.

I refer to your correspondence, received by this office on 19 May 2017, in relation to a resolution adopted by the members of Limerick City & County Council.

If I might outline how NAMA operates, it might be of assistance to the members. The first relates to NAMA's role in relation to properties. NAMA does not directly own or manage properties. NAMA's role is that of a secured lender, like a bank. Properties securing the loans we have acquired remain under the control of either the original owner or, in the case of enforcement, the appointed receiver and it is these parties that remain responsible for the efficient management of the properties. This includes the management of the selling process, where a property is being sold.

NAMA's established policy is that the sale of loans and properties by debtors and receivers should be openly marketed to ensure that the best price available in the market is achieved at the time of the sale. This allows all interested parties to bid for assets and loans in an open and transparent manner, while also ensuring that NAMA achieves maximum return to the taxpayer. To exclude a certain sector of potential purchasers would prevent NAMA from maximising the return to the taxpayer, as is set out in the NAMA legislation.

I would also point the members towards NAMA's commercial objective of funding the construction, on a commercial basis, of 20,000 residential properties in Ireland by end-2020. This represents a significant contribution by NAMA to the supply of residential properties in Ireland, and will also be subject to the standard Part V obligations. Between 2014 and the end of March 2017, NAMA had funded the construction of over 4,840 residential properties, while a further 2,064 homes are under construction, and funding has been approved for an additional 1,114 properties which have received planning permission but are not yet under construction.

I hope the above explains NAMA's role and is helpful to the members.

I refer to your representations on behalf of Limerick City and County Council in relation to My Open Library.

The 'My Open Library' service is an initiative under Opportunities for All, the national public library strategy 2013-2017. It forms part of an overall strategy to address customer demand and grants members the freedom and flexibility to use the library during the hours that suit them best.

Open Library pilots were introduced in Tullamore, Banagher and Tubbercurry libraries from November 2014 and feedback from users has been very positive to date. The service has made community spaces and collections available to library members and communities who would otherwise be unable to access them, with each library operating the service now open to the community for 98 hours per week.

The Department is satisfied that the learning from the pilots, and the positive feedback from library users, justifies extending the pilot phase to a further 20 library branches. The learning gathered from this phase will inform and shape the future development and implementation of the service across the broader library network.

It is unfortunate that the nature and purpose of the 'My Open Library' service has been misrepresented and misunderstood. 'My Open Library' seeks only to extend availability of an essential community service. Staffed opening hours will not be reduced. Similarly, staff <u>levels will not be reduced</u>; rather the Department is working with local authorities though the workforce planning process to increase staff levels across the library service.

The Department intends to continue with the roll out of the extended pilot. It is expected that the service will add significant value to the library services operated by the participating authorities. A full review of the pilots will be conducted before any decision is taken to roll out the service more broadly across the library service.

I acknowledge receipt of your letter of the 16th May 2017 and my apologies for the delay in responding to same due to my absence on leave. I note the details of the resolution adopted by Limerick City and County Council.

Gas Networks Ireland develops, owns and operates the natural gas Transmission and Distribution networks, under license from the Commission for Energy Regulation (CER), on behalf of the Irish state. Extensions of the network and connections to it are considered in accordance with the Connections Policy approved by the CER. The Connections Policy sets out the process and requirements, both technical and economic, applicable to new connections to the Gas network. The Gas demand associated with the Kerry Food Ingredients plant and the Listowel town load together, justify the laying of a Distribution connection only. The project has been approved by the Commission for Energy Regulation and is already at an advanced stage

This pipeline when constructed, will have the capacity to cater for some additional distribution level demand along the route. However, the scale of demand associated with a Power station, would require a high pressure Transmission connection and could not be accommodated on a distribution level connection. In the context of potential additional loads at the Industrial land banks in Tarbert/Ballylongford or a new gas fired Power Station at Tarbert, Gas Networks Ireland would welcome all enquiries where there are sufficient load details currently available and we would be happy to engage with any such businesses and carry out a detailed assessment with a view to proposing a suitable connection solution.

I trust the above clarifies the position but if I can be of any assistance in the future please do not hesitate to contact me.
