Re: Section 183 Disposal Notice – Limerick City & County Council (Innovate Limerick Ltd.) to Mr Paul Collins, Design Pro Ltd.

Innovate Limerick Ltd., a wholly owned subsidiary of Limerick City & County Council was established in 2014 to help drive innovation in Limerick and act as the delivery vehicle for economic projects outlined in the Limerick 2030 – An Economic and Spatial Plan for Limerick.

Innovate Limerick Ltd purchased the former Anderson Building in Rathkeale in 2014 after its closure earlier that year. It was purchased from the Receivers PWC with the view to attracting businesses into smaller units within the 125,000 sq. ft building.

Innovate Limerick Ltd. has negotiated, subject to Council approval, to dispose by way of 999 year lease 25,000 sq. ft. of the former Anderson building to Mr Paul Collins, Design Pro Ltd. Consideration for the purchase is €250,000 and an annual rent of €1 (if demanded) which is in accordance with the independent valuation obtained by Innovate Limerick.

The location of Design Pro Ltd. in the former Anderson building will create forty jobs with a further thirty within two years.

In order to complete the purchase of the building to Mr Paul Collins, Design Pro Ltd., a Section 183 Disposal Notice must be approved by the members of Limerick City & County Council.

I therefore seek a resolution from the Council under Section 183 of the Local Government Acts 2000 to 2014 to approve the disposal of the property as set out on the statutory notice previously circulated.

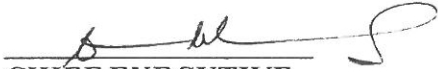
- (a) Lease agreement for 999 years at an annual rent of €1 (if demanded) and subject to the conditions and covenants contained within the Lease agreement.
