| Increase of fee For Parking discs. | 3. | Bye-Law 12 of the Limerick City Council (Parking Places) Bye-Laws, 2006 is hereby amended by the substitution of €1.50 for €2.00 and the said Bye-Law as so amended is set out in the Table to this bye-law. |
