Circular Letter F 11/18

A Chara

I attach for your attention a copy of the Presidential Election Order made by the Minister today in relation to the forthcoming Presidential Election. The Order sets out the last day on which the Presidential Returning Officer may receive nominations, the date and time of the poll at the election and other details.

Article 12.4.2 of the Constitution provides that every candidate, who is not a former or retiring President, must be nominated either by:

- (i) not less than twenty persons, each of whom is at the time a member of one of the Houses of the Oireachtas, or
- (ii) by the Councils of not less than four administrative counties (including County Boroughs) as defined by law.


The nomination of candidates for a presidential election by county, city, and city and county councils is a reserved function, regulated by law under section 16 of the Presidential Elections Act 1993. With the Presidential Election Order now signed, the main points of note are as follows:

- councils may, by resolution, resolve to nominate one candidate,
- not less than 3 clear days notice of the intention to propose the resolution must be given in writing to every person, who, at the time when the notice is given, is a member of the council, and
- the resolution of the council must be given effect by means of a nomination paper as prescribed in the Presidential Election (Forms) Regulations 2011 – S.I. 258/2011 amended by S.I. 329 of 2018 - sealed with the seal of the council and delivered in person to the Presidential Returning Officer. Copies of the Regulations and a nomination paper are enclosed.

Mr. Barry Ryan of this Department has been appointed as the Presidential Returning Officer and the address at which nomination papers may be delivered and to which other communications may be addressed is – Presidential Returning Officer, Custom House, Dublin 1.

The period for the receipt of nominations commences at 10am on 30 August, 2018 and ends at 12 noon on 26 September 2018. As indicated in Circular Letter F10/18 of 18 July 2018, councils intending to get involved in the nomination process should liaise with any other councils who are proposing to nominate the same candidate to ensure that the details (names, address and occupation) in relation to the candidate on the nomination papers are identical.

I bhfeidhmiú na gcumhachtaí a thugtar dó le hait 6 d'Acht Toghchán an Uachtaráin, 1993 (Uimh. 28 de 1993), déanann Eoghan Ó Murchú, an tAire Tithíochta, Pleanála agus Rialtais Áitiúil na nithe seo a leanas a cheapadh leis an Ordú seo uaidh chun críocha an ghnáth-thoghcháin uachtaráin a dhéanfar sa bhliain 2018:

1. Is é an 26<sup>ú</sup> lá de Meán Fomhair 2018 an lá deireanach ar a bhféadfaidh ceann comhairimh toghcháin an uachtaráin ainmniúcháin a ghlacadh le haghaidh an toghcháin.
2. Is é seo a leanas an seoladh a bhféadfar páipéir ainmniúcháin a sheachadadh air agus a bhféadfar cumarsáidí eile a chur chuige: Ceann Comhairimh Toghcháin an Uachtaráin, Teach an Chustaim, Baile Átha Cliath 1.
3. Is é Teach an Chustaim, Baile Átha Cliath 1 an áit ina suífidh ceann comhairimh toghcháin an uachtaráin chun rialú a thabhairt ar ainmniúcháin ar an lá deireanach chun ainmniúcháin a ghlacadh.
4. Is é an 26<sup>ú</sup> lá de Deireadh Fomhair 2018 an lá ar a dtógtar, agus is í an tréimhse idir na huaireanta 7.00 a.m. agus 10.00 p.m an tréimhse ar lena linn a thógtar, an vótaíocht (más ann) sa toghchán.

I, Eoghan Murphy, Minister for Housing, Planning and Local Government, in exercise of the powers conferred on me by section 6 of the Presidential Elections Act 1993 (No. 28 of 1993), by this Order appoint for the purposes of the ordinary presidential election to be held in the year 2018 as follows:

1. The 26<sup>th</sup> day of September 2018 shall be the last day on which the presidential returning officer may receive nominations for the election.
2. The address at which nomination papers may be delivered and to which other communications may be sent is The Presidential Returning Officer, Custom House, Dublin 1.
3. The Custom House, Dublin 1 shall be the place at which the presidential returning officer will sit to rule upon nominations on the last day for receiving nominations.
4. The 26<sup>th</sup> day of October 2018 shall be the day on which, and the period between the hours of 7.00 a.m. and 10.00 p.m shall be the period during which, the poll (if any) at the election shall be taken.

I, JOHN PAUL PHELAN, Minister of State at the Department of Housing, Planning and Local Government, in exercise of the powers conferred on me by section 4 of the Presidential Elections Act 1993 (No. 28 of 1993) (as adapted by the Housing, Planning, Community and Local Government (Alteration of Name of Department and Title of Minister) Order (S.I. No. 358 of 2017)) and the Housing, Planning and Local Government (Delegation of Ministerial Functions) Order 2017 (S.I. No. 473 of 2017) hereby order as follows:

1. These regulations may be cited as the Presidential Elections (Forms) (Amendment) Regulations 2018.

2. The Presidential Elections (Forms) Regulations 2011 (S.I. No. 258 of 2011) are hereby amended by the substitution of

- (a) Part 1 of the Schedule hereto for Part 1 of the Schedule to the Presidential Elections (Forms) Regulations 2011 (S.I. No. 258 of 2011);
- (b) Form No. 1 in Part 2 of the Schedule hereto for the Form of Nomination Paper for Nominations by County Councils and City Councils in Part 2 of the Schedule to the Presidential Elections (Forms) Regulations 2011 (S.I. No. 258 of 2011), and
- (c) Form No. 2 in Part 2 of the Schedule hereto for the Form of the Ballot Paper in Part 2 of the Schedule to the Presidential Elections (Forms) Regulations 2011 (S.I. No. 258 of 2011).

1. A photograph in digitised format and 2 identical printed copies of the photograph (passport size — 35mm x 45mm) shall be delivered with the candidate's nomination paper.
2. The photograph shall be of good quality and in colour showing the candidate's full face, head and shoulders only, on a light background (any colour) and taken to a professional standard.
3. The photograph shall have been taken not more than 12 months prior to the date appointed by the Minister for Housing, Planning and Local Government by order under section 6 of the Presidential Elections Act 1993 for the taking of the poll at the election.
4. Each copy of the printed photograph shall have the candidate's name clearly shown on the back.
