1. Draft Budgetary Plan 2019

Circulated, Report of the Director of Support Services dated 4th October, 2018, setting out the background to the General Municipal Allocation (GMA) and noting that the total provisional allocation for the GMA for 2019 was €1,203,000 of which €503,000 had been allocated to the Metropolitan District in the Draft Budgetary Plan 2019 as follows:
