2. HAP Shared Services

The Housing Assistance Payment (HAP) Scheme is a form of social housing support provided by all local authorities. Located in the Granary the HAP Shared Services Centre occupies two floors and specialises in a number of functions on behalf of the 31 Local Authorities including the Dublin Regional Homeless Executive in the delivery of the HAP Scheme nationally.

There were 40,837 active HAP tenancies at the end of September 2018. A weekly average of 352 HAP tenancies have been set-up during 2018.

The weekly tenant debit is just under €1.9 million. The September landlord payment run was just over €30 million.

3. Social Development

Environment Awareness

The King's Island Conscious Cup Campaign launched by the Mayor of the City and County of Limerick, Councillor James Collins on 4 September.

Preventing waste and litter is a key part of managing the impact of litter and waste in our environment. The King's Island Conscious Cup Campaign saw businesses on King's Island coming together to support the National Conscious Cup Campaign. National Tidy Towns Results 2018

- 55 communities across Limerick took part in the National Tidy Towns competition 2018.
- Adare is Limerick's Tidiest Town and received a silver medal with an increase of an excellent seven marks on last year with 328 marks (Listowel, the overall national winner, received 339 marks).
- Ardpatrick, Castleconnell, Galbally, Newcastle West and Limerick City Centre were awarded Bronze medals. This included a first time Bronze for Castleconnell and a 12-point increase for Limerick City to maintain a second Bronze.
- Garrienderk won an Endeavour Award for the area with the biggest percentage improvement over the previous year.

Healthy Limerick

We're Breastfeeding Friendly Limerick was launched on 26 September 2018.

Limerick City and County Council is leading this Healthy Ireland funded initiative - in partnership with Limerick Local Community Development Committee, (LCDC), Health Service Executive, Limerick Children and Young People's Services Committee (CYPSC), PAUL Partnership and West Limerick Resources - and is the first local authority in Ireland to do so.

Platforms for Ageing Community Engagement – Exchange and Enterprise (PLACE-EE)

Four north Atlantic countries (Iceland, Ireland, Sweden and U.K.) are involved in a European research project titled PLACE-EE. Limerick hosted representatives from the other partner countries on 12 and 13 September. The partners viewed presentations regarding projects currently being undertaken in the City and County, including the Acorn Tablet for older people, Move4Life, "Shortening the Winter" campaign and Limerick Age Friendly Programme.

Older People's Council

Mary Cronin, Chairperson of Limerick Older People's Council was elected National Chair of Older People's Councils of Ireland at a meeting in Dublin on 25 September. Mary will be Chair for a period of two years and will officially take office at the National Convention of Older People's Councils of Ireland in Wicklow in November.

Launch of "Belonging to Limerick"

Friday 28 September saw the official launch of "Belonging to Limerick," the third integration strategy for Limerick and the first to be formally adopted by Council. Guest of honour was President of Ireland, Michael D. Higgins, who gave a keynote speech. Ms. Donnah Vuma addressed the attendees and spoke about her experience of "Belonging". The strategy was then launched by the Mayor of the City and County of Limerick, Councillor James Collins.



4. Customer Services

Housing maintenance requests, in particular for the Metropolitan area were formally integrated to Customer Services in June. A total of 1,415 cases were logged by our Customer Services teams in both Merchant's Quay and Dooradoyle supporting this front line service of the Council.

Customer Services handled and processed 82 Residential Parking Permits.

The call centre managed by the Customer Services Department received a total of 12,249 calls.

This works out at approximately 613 calls per day, with the average response time being 23 seconds for calls to be answered.

A total of 2,986 cases were logged, with the majority broken down as follows;

• Operations and Maintenance: 2,040

· Housing Support Services: 304

Planning and Environmental Services: 212

Customer Services: 119

• Veterinary: 68

• Design & Delivery: 86

Urban & Village Renewal: 54

The total number of callers to our counters at Merchant's Quay and Dooradoyle was 2,250.

Customer Services managed the centralisation of incoming post for the organisation. Post addressed to Merchant's Quay, Lissanalta House and Dooradoyle is now received in Dooradoyle and opened and sorted by Customer Services staff.

All monies received are recorded and receipted daily. Facilities staff continue to work closely with Customer Services to ensure prompt and secure internal delivery of opened post.

Staff in Customer Services attended Service Design training. This training aims to take a service and through detailed analysis and consultation with all relevant parties including the customer, come up with a more efficient way of delivering that service.

5. Library Services

- In the Granary Library a workshop titled "Dogs Trust: Be Dog Smart" was held for new and expectant parents on 6 September as part of their Be Dog Smart nationwide programme giving new parents tips on how to help your dog and baby cohabit safely and harmoniously.
- The Granary Library facilitated a pain management workshop organised by "Chronic Pain Ireland" on 10 September.
- On 11 September the Granary Library hosted a café style conversation workshop for Palliative Care Week called "Palliative Care - Because every moment matters". This was organised by the Milford Care Centre for members of the public to learn about the services available to those with limiting conditions and the benefits gained by patients and their families. Healthcare Professionals attended to answer any queries.
- The Granary Library facilitated the "Breadwinner Storyboard Workshop" as part of the Limerick Elemental Festival on 15 September. This children's event was for those with an interest in movie making and animation. Storyboard artist Giovanna Ferrari, of Cartoon Saloon, delivered this hands-on, informative workshop.
- "The Breaking Rapids" by Joe Coleman was launched in the Granary Branch on 21 September, Culture Night. Limerick author Joe Coleman follows his bestselling "House Full" (History of Cinemas), "Falling Gradient" (A history of Limerick railways) with "The Breaking Rapids". This is an illustrated collection, full of local legends and heroes, saints and scholars, trials and tribulations, and tales of the normal and paranormal.
- The branch facilitated an information meeting on Fostering organised by FFI (Fostering First Ireland) on 26 September. A representative was available to answer any questions on the fostering process, the support available from FFI foster carers and a local fostering advisor. The meeting generated a lot of interest with the organisers delighted with the attendance on the day.
- Alliance Française de Limerick launched its first book, "Recueil de Nouvelles" a collection of short stories in the Granary on 28 September. The book is a compilation of original texts in French and in English written by Alliance students.



- Friends of the Hunt Museum held an illustrated lunchtime lecture in the Granary entitled "Richard Thomas Moynan RHA, 1856 1906" on 25 September. Dr. Maebh O'Regan spoke of how Moynan, though known, primarily as one of the Irish Impressionist painters, was also influenced by education, family concerns, Freemasonry, unionism, and political issues.
- Kilmallock Library hosted Cruinniú 2018, the annual group exhibition during the months of July, August and September. This exhibition included paintings, sculpture, craft and fabric work, and ceramics.
- The monthly meeting of Little Readers workshop took place on 19 September in Kilmallock Library.
- Digital Skills classes in the Library continued in Kilmallock branch in partnership with Ballyhoura Development CLG. This month a further seven people took the initiative to delve into the digital world and learn how to navigate and operate in an online world using their own device.
- The Summer Stars Awards celebrations took place on 29 September in both Kilmallock and the Granary Libraries. Tommy the magician read from the hugely popular "The President's Glasses" in Kilmallock and Roisin Meaney presented the certificates and medals and entertained the children with wonderful story telling, rhymes and songs. Watch House Cross Library also rewarded their star readers with an award ceremony for 150 children on 22 September.
- Newcastle West Library hosted an exhibition titled "The Cool Vernacular" by Jim Furlong for the month of September. Jim is a Limerick based artist, who graduated from Limerick School of Art and Design in 2016 with a BA in Fine Art. He has held several solo exhibitions, in Clare, Kerry, Dublin and throughout Limerick.
- 'SMILE' (St Munchin's and Moyross Initiative for Learning and Education) held a training day for staff on 8 September at Watch House Cross Library. This project works with the DEIS schools in the north side of Limerick City and focuses primarily on encouraging those at risk of early school leaving to engage positively in education.
- "The Incredible Years" parent training intervention is a series of programmes focused on strengthening parenting competencies (monitoring, positive discipline, confidence) and fostering parents' involvement in children's school experiences in order to promote children's academic, social and

- emotional competencies and reduce conduct problems. A two day training programme for their staff was held in the Watch House Cross Library on 11 and 12 September.
- Watch House Cross Library Adult Book Clubs have commenced for the new season while the children's book club, which is aimed at nine to twelve year olds, has four newcomers.
- The parent and toddler group meets in the Watch House Cross Library every Friday from 10.30am to 12pm, tea and coffee is served and the parents, grandparents and carers enjoy singing nursery rhymes, and listening to stories.

6. Limerick Culture and Arts Office

Strategic Developments and Supports

Cultural Strategic Policy Committee

The Cultural Strategic Policy Committee met on 3 September. The committee considered the new open call for Individual Arts Bursaries, the draft Framework Agreement between the Arts Council and Limerick City and County Council, considered the report on the evaluation of the recent Artists in Schools Programme, considered preparing a draft strategy on Festivals and Events for Limerick City and County Council.

Following the meeting, the following reports will be published:

- The Evaluation of Artist in Schools Programme 2017/2018.
- The Evaluation of Festival and Events Professional Development Training Scheme 2018.

Letters of support from Limerick City and County Council Strategic Fund

The Limerick City and County Council Strategic Fund for Arts and Culture was developed by Limerick City and County Council to allow cultural, arts organisations and practitioners to bid for funding for ambitious, high potential projects with an aim to leverage funding from other sources. In September, Limerick Culture and Arts Department provided 12 letters of support to the recent open call for Strategic Funding from The Arts Council of Ireland.



Social Impact Assessment – Pilot Project

The Arts Council have initiated a pilot study to deliver a social impact assessment model to build a new framework for assessing the social impact of investment of the arts at local level, as a priority of the Arts Council's strategy, Making Great Art Work: Three Year Plan. Three local authority arts offices will be part of the pilot, Limerick, Carlow and Leitrim. The first meeting to set the terms of reference around the pilot project took place in September.

The Arts Council Strategic Actions Update Form

A Strategic Actions Update Form was submitted to the Arts Council in September. This form outlines the potential four shared strategic actions Limerick City and County Council and the Arts Council are working to deliver:

- Strategic Action 1 : Supporting Artists and Key Strategic Organisations.
- Strategic Action 2: Rural Arts and Excellence.
- Strategic Action 3: Young People, Children and Education.
- Strategic Action: 4 Festivals and Events.

UL Hospitals Group Arts Committee

Limerick Culture and Arts Department are working with UL Hospitals Group Arts Committee, to establish common areas of interest and possible collaborations.

Open Calls to support artists and creatives in Limerick

The Individual Arts Bursaries Awards Scheme

This new Scheme was approved by the Cultural Strategic Policy Committee on 3 September on the basis that the individual Bursaries be open across all discipline. Bursaries Information Clinics took place at Culture House, 2 Pery Square on 27 and 28 September.

International Mobility Award

This was the second round of the Awards, with continued support for creatives in Limerick to encourage international mobility and opportunities for Limerick artists. Following the deadline on 28 August these awards are being processed.

Emerging Writer Mentoring Opportunity

In partnership with Words Ireland, a Mentoring Opportunity for an emerging writer living in Limerick was offered. This mentoring opportunity will allow a writer to receive mentoring from a professional writer. Words Ireland administer and assess the open call. We are delighted to announce that the Poet Breda Spaight is the successful recipient of the Award for 2018-2019.

Creative Ireland

On 12 September, An Taoiseach Leo Varadkar launched the Culture and Creative Strategies 2018-2022 for each local authority in Ireland, including Limerick. This ambitious and innovative five year strategy has been developed by the Limerick Culture Team, aligning culture-related strategic priorities of the Limerick City and County Council Departments that are currently involved in the provision of creative services or use creative tools as means of engaging and activating citizens. The Strategy aims to provide meaningful opportunities for citizens and local communities, together with our Local Authority, to nurture, sustain and facilitate participation in cultural and creative activities, and it has six strategic priorities:

- 1. Future Creator: Children and young people;
- 2. Creative Minds: Nurturing and supporting artists and other creators;
- 3. Creative Springboard: Fostering creative and cultural innovation;
- 4. People, Places, Networks: Enhancing our local cultural and creative infrastructure;
- 5. Creative Screens: Focus on film and coding;
- 6. Creative Citizens: People creating and accessing culture on their doorstep.

Partnership with Limerick and Clare Educational and Training Board (LCETB) on Local Creative Youth Partnership (LCYP) Application

Limerick and Clare Educational and Training Board (LCETB) convened a workshop on 14 September, with relevant stakeholders and partners in the region, to discuss initiatives and share ideas for collaboration going forward. Based on the findings at the workshop and subsequent meetings, an application for funding to Creative Ireland for a LCYP was made for the deadline of 21 September 2018. Three ETB's will be selected nationally to deliver the pilot of Local Creative Youth Partnerships in 2019.

Kilfinane Arts: Our Traditions, Our Links with Nature

Commencing in September 2018, Our traditions, Our Links with Nature is a community sculpture project run by Kilfinane Arts under the guidance of basketry artist Hanna van Aelst. This project includes a series of workshops over two months, culminating in a local three-day pop-up exhibition. The workshops are open to all and aim to strengthen community interactions by bringing people together in new ways and stimulating new conversations. It is capacity building, helping individuals develop as artists and makers and helping to group to collaborate on creative projects. It aims to renew and invigorate the local sense of cultural identity.

Limerick Printmakers: Print-spiration

Commencing in September 2018, Print-spiration project focuses on imparting printmaking skills to young adults aged 13 – 17 years and will culminate in each participant completing print artworks that will be exhibited both in their own locality and as part of group exhibition in Limerick City, as well as with a partner organisation in Georgia, USA. Limerick Printmakers will collaborate with two organisations on this project: Limerick Youth Service and Moyross Youth Academy.

Narrative 4: Creative Pool

Commencing in September 2018, Creative Pool is working to create, train and support a pool of ten Limerick based creative producers in the Narrative 4 methodology of story exchanges. Narrative 4 Limerick works to equip young people to use their stories to build empathy, shatter stereotypes, break down barriers and ultimately make the world a better place.

Limerick Culture and Arts Office Programme Delivery

Castleconnell Autumn Concerts Series

Presented by RTE Lyric FM's Liz Nolan, the second of this year's programme took place on 25 September. Victoria Massey, one of Ireland's leading mezzo soprano voices, sang a programme of operatic arias. She was accompanied by Padhraic O'Cuinneagáin on Piano at All Saint's Church in Castleconnell. This programme brings national and international performers to Castleconnell, providing a high quality music programme to audiences in the region.

Culture Night/Oíche Chultúir

Culture Night Limerick happens because many people share a vision and enthusiasm for enjoying, celebrating and promoting creativity and culture. This year on 21 September, a wide range of artists, cultural organisations, institutions and community groups were involved in delivering an exceptional programme of events. This year we also had a record number of volunteers recruited under the Cultural Civic Engagement Programme. This programme seeks to actively target at risk groups, new Irish and those living in regeneration areas as part of a programme of inclusion encouraging citizens to actively participate in the cultural life of Limerick through the Culture and Arts Department annual festivals programme. Limerick embraced this year's programme of activity with great enthusiasm. The following numbers illustrate that enthusiasm in terms of audience, locations and events:

- Total Audience: 21,600.
- Total Number of locations: 84 (City 67 locations: County 17 locations).
- Total no. of events: 99.

We had a very successful Twitter campaign and our Tweets for September 2018 earned 71.7K impressions.

- 21 September 13,770 organic impressions.
- 22 September 6,805 organic impressions.

The days following Culture Night saw a spike in Twitter impressions 3,000 – 4,000 impressions for some post-event Culture Night tweets.

Sliabh Luchra Musician in Residence appointed

Eoin O'Sullivan has been appointed as Musician in residence and is just beginning work on this residency programme for the Sliabh Luachra area. Over the next 12 months Eoin will be working with children in schools in Sliabh Luachra promoting awareness of the region's vast musical heritage. Eoin will also engage with music festivals, music, singing and set dance groups, local musicians and music teachers to help promote the excellent work that is being done by these groups. The Sliabh Luachra Traditional Musician in Residence is a partnership between Limerick City and County Council and Cork and Kerry County Council's, the Irish traditional Music Archive and is supported by the Arts Council.

County Limerick Youth Theatre

The County Limerick Youth Theatre have a new home for the year ahead in The Honey Fitz Theatre, Lough Gur. Taster workshops with pupils in schools, Theatre in Education workshops, Irish Wheelchair Association participants and Youth Members have all taken place. Two youth theatre participants attended Dublin for National Youth Theatre audition call backs. The County Limerick Youth Theatre was selected for participation in the BNest Social Entrepreneur programme, Nexus Innovation Centre, University of Limerick.

The Limerick Youth Choir

Auditions took place for members for the 2018-2019 season. This choir comprises young people between the ages 17 and 28 and is a mixed voice choir of Soprano, Alto, Tenor and Bass. The repertoire studied covers many different genres and eras, from Renaissance and classical to pop and contemporary. The goal of this choir is to perform good choral music to a high standard. Rehearsals take place weekly from September to May.

Capital Developments

Capital Works Programme - Dance Limerick Refurbishment

A site visit to inspect the refurbishment work carried out at Dance Limerick in John's Square, (which is in the long-term custodianship of Limerick City and County Council) took place. These works focus on the thermal performance of the building fabric allowing audiences and artists to enjoy seeing work in a warm venue. This work was joint funded by Limerick City and County Council and The Department of Culture Heritage and the Gaeltacht, Arts and Culture Capital Scheme 2016, Stream 1.



7. Limerick Museum

- Limerick Museum received 2,123 visitors in September 2018.
- Dimensions, a contemporary art exhibition by Limerick artist Cindy Fogarty opened in the Museum on 20 September. Cindy Fogarty is a BA Honours Fine Art Painting graduate of Limerick School of Art and Design who currently lives and works in her native Limerick city. Working predominately through the medium of paint, her practice examines our neurological digestion of information in our quickly evolving society, how we respond to it, and how it can mould our ways of thinking. The exhibition continues until 15 October.
- Limerick Museum has lent some objects to Ormston House for an exhibition entitled Museum of Mythological Water Beasts.
- Limerick Museum opened an extra three hours on Culture Night 21 September from 5pm to 8pm during which 350 visitors were received. John Elliott gave a guided tour of the Museum, attended by over 100 visitors.
- Friends of Limerick Lace Group held a meeting in the Museum on 13 September.

8. Limerick City Gallery of Art (LCGA)

- Crossing the Salt by Gabhann Dunne, Art Forms in Nature by Karl Blossfeldt, a Hayward Gallery Touring Exhibition from Southbank Centre, London, Florilegium A Gathering of Flowers by Naomin Draper and Rachel Myles, Imni which received the LCGA/LSAD Graduate Prize award for 2017 and a selections of works from the Permanent Collection finished on 3 September. Total number of visitors for duration of the four exhibitions was 8,133.
- Launch of the Exhibitions, Maud Cotter, a consequence of without stilling and Anita Groener, The Past is a Foreign Country, and selected works from the Permanent Collection. The official opening on 29 September by Mary McCarthy, Director of the Crawford Art Gallery, with an Artist's Talk prior to the launch with an attendance of around 350 people.
- Works from The Permanent Collection including works by local artists, Tom Fitzgerald, Don MacGabhann and recent donations from the Rodgers family in memory of their parents hang alongside The Mushroom Book.



- The exhibition, HEADLAND, by Elizabeth Magill concluded its run in the Ulster Museum, Belfast in September.
- LCGA's visitor attendance was 5,814. Visitor numbers reflect that we were changing over exhibitions and some initial building works commenced.
- Application and submission of LCGA's application to the Arts Council for Strategic Funding Grant, 2019 was submitted on 6 September.
- LCGA will store the ceramics collection owned by The Hunt Museum while they undergo building works. It is planned to exhibit these works alongside ceramics from the Permanent Collection in early 2019.
- Ongoing loan to the Crawford Art Gallery, Cork of the painting by Maurice MacGonigal, A Dublin Studio, from the Permanent Collection featured in the exhibition Naked Truth: The Nude by Irish Artists.
- Loan of two Mary Swanzy artworks to the Irish Museum of Modern Art, IMMA for a forthcoming retrospective exhibition by Mary Swanzy, exhibition touring in 2019 and will be exhibited at LCGA in the Summer of 2019.
- LCGA's continue its support for workshops by Limerick Art Society held in HUB space.
- Ongoing plans for exhibition in 2019, discussion with artists and galleries.
- Continued meetings and plans for essential Fire and Safety upgrade work to LCGA with the new boiler upgrade works started and continued plans for the scheduled works being carried out over the coming months. Funding provided by Department of Arts grant that has been matched by Limerick City and County Council. It will be necessary to raise further monies to complete the other works that have been identified as necessary to bring the building up to acceptable international standards.

9. Planning and Environment

Litter/Waste Enforcement

- 150 complaints were received.
- 188 inspections were undertaken.
- 25 on the spot litter fines were issued.

The theme of this year's Mobility Week was multi-modality and people were encouraged to come to town using sustainable modes.

Joining LST in tents set up along the street were; the Maigue River Trust providing awareness and information on the river and biodiversity; Limerick Environment awareness with information on recycling and composting; An Taisce Green Schools and Limerick Sports Partnership advocating the benefits of physical activity through games; Spin South West broadcasting from the street; Design and Delivery were on hand with drawings for the proposed O'Connell Street revitalisation and engaged with the public on their plans; the Hub were there with a selection of bikes and information on the Bike to Work Scheme; An Garda Síochána were providing cycle safety tips, bike registration information and details on locking bikes; and the RSA brought their Roll Over Car to simulate what it would feel like in the event of a crash.

Bus Éireann partnered with LST for the day showcasing their new double decker bus and provided free Leap Cards to those on the street. In addition to this they ran free half hourly guided tours along the banks of the river where people got an opportunity to hear about the benefits of public transport as well as learning some local facts.

 Extension comprising the construction of an extended production hall with mezzanine plant space overhead at Johnson & Johnson Vision Care, National Technology Park, Plassey.

2. Investment

- Investment group ICAV announced a potential €90 million development on the Horizon Mall Site on the Dublin Road, which will include a 300 bedroom hotel, a budget hotel, apartment housing 190 residents, offices and a filling station. 150 permanent jobs will be created between the two hotels, the offices and the proposed filling station. A start date of early 2020 is proposed for the project, with hundreds of jobs to be created during construction.
- Eurocar and GoCar, which provide a high quality car and van rental service, opened a new corporate office on the Dock Road, Limerick with the creation of 15 jobs.
- DesignPro Robotics, a provider of precision automation and machine-build services, has announced that it will create 30 new jobs at its hub in Rathkeale, Co Limerick.
- Matilda's Planet, a social enterprise which provides internal insulation has opened its first Irish outlet in Limerick. When fully operational, the factory will employ 30 staff directly and indirectly.
- A total of 38 jobs were announced by LEO supported companies Celignis Ltd, Black Bear Software and ABS Engineering Control Systems.

• Troy Studios announced plans to increase its sound stage space to 100,000 square feet with the addition of a fourth sound stage (33,000 sq. ft) within its existing site. Up to 150 jobs will be created during the construction phase alone. It will position Troy as the largest international standard film and TV studio in Ireland with the potential to double the level of inward production and jobs. It was also announced that Troy Studios, in collaboration with the University of Limerick, is in the process of extending the current Executive MBA offering to include a special focus on the business of content production, which will be the first MBA of its kind in Europe.


Recourse to Overdraft Facility No of days in overdraft
