1. Trade & Investment

- A multi-million investment in an advanced manufacturing facility at Plassey has been announced by IDA Ireland. 100 tech jobs are to be created over the next five years with 60 construction jobs to be created during the building phase. The two-storey facility will also feature research and development in the 3,000 square foot complex.
- Mobile Phone Company, Three, has announced 30 new jobs for its customer service centre in the National Technology Park. The new roles will bring the total headcount at its Limerick operation to 500.
- 14 new jobs are to be created in Limerick as part of the 500 jobs announced by German discount retailer Aldi.

2. Limerick Local Enterprise Office (LEO)

- Local Enterprise Office Training and Development Programme for 2019 was launched by the Mayor of the City and County of Limerick, Councillor James Collins
- Online applications for Ireland's Best Young Entrepreneur competition now open, we have begun the search to find Limerick's Best Young Entrepreneur 2019.
- The Student Enterprise Programme for academic year 2018-2019 launched nationally in Dublin with Josh Van der Flier as Ambassador. 22 secondary schools and 1,100 students taking part in Limerick.
- The Business and Retail Incentive Scheme for 2019 launched - this Scheme provides financial incentives to encourage new businesses to open in vacant units in Limerick City, and in towns around the county. The scheme is intended to address property vacancy rates, improve streetscapes and to support the business community.
- Three Limerick Craft Companies exhibited at Showcase Ireland 2019 in the RDS, Dublin.

- January Women in Business event with LEO's partner Network Ireland Limerick held in January with the theme 'Achieving Success through Wellness.'
- Six week start your own business course commenced in Kilmallock.

3. Innovate Limerick

On 24 January Innovate Limerick partnered with the Guinness Enterprise Centre for the launch of Prosper Limerick. The aim of this series of events is to develop a network of support among Limerick's business diaspora to enhance prosperity in the city and county. Guests at the event heard from early stage Limerick start-ups who are creating jobs in the city and county. Dr. Pat Daly, Deputy Chief Executive and Director of Economic Development also addressed the meeting.

4. Digital Strategy

- Digital Strategy has successfully completed the procurement process for a new online public consultation platform. This new online engagement channel will be called My Point, and will be integrated with Limerick.ie to provide citizens with a mechanism to engage with the council 24/7 by creating submissions against consultations and surveys that the Council publishes online. The tender has been awarded and a contract will be signed in early February, with a pilot version of the platform to be deployed before the end of Q1 2019.
- Rollout of the Council's new EDRMS (Electronic Document Records Management System) has commenced with Digital Strategy and Archives now actively using the new system. Part of the LITE (Limerick Information Transformation eProgramme) programme, rollout will continue to other departments in a phased approach in the coming months.

1. Travel & Transportation Strategy

National Road Grant Allocations 2019

- Transport Infrastructure Ireland (TII) has recently advised the national road allocation for Limerick for 2019. These grants are for the improvement and maintenance of national roads. The total allocation is €10,284,374, an increase of 12% from 2018.
- The major road schemes include *inter alia* the schemes in the following table:

Regional and Local Road Grants Allocations 2019

- The Council has been advised by the Department of Transport, Tourism and Sport that there will be €483,400,000 in funding available under the 2019 Regional and Local Road Grant Allocations of which €26,199,251 will be allocated to Limerick. This represents an increase of about 38% on the 2018 grant allocation.
- This allocation will enable the Council to undertake road maintenance and improvement works across the City and County under the following expenditure headings:

2. Environment Strategy

City and County of Limerick (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-Laws, 2019

- Limerick City and County Council has adopted and made the City and County of Limerick (Segregation, Storage and Presentation of Household and Commercial Waste) Bye-Laws, 2019 in relation to the segregation, storage and presentation of waste throughout Limerick city and county. These Bye-Laws will come into force on 1 March 2019, and a person found guilty of a contravention of the Bye-Laws shall be liable on conviction to a financial penalty of up to €2,500.

3. Water Services

Capital Works

- Watermain rehabilitation works complete in Ballingaddy.
- Watermain rehabilitation works progressing in Islanduane and Ennis Road.
- Works progressing on upgrade to Athea Wastewater Treatment Plant.
- Works progressing on upgrade to electrical panels in Castletroy Wastewater Treatment Plant.
- Limerick City Sewer Rehabilitation works progressing on Catherine Street and O'Connell Street as per programme.

4. Mid West Road Design Office

N20 Ballyphillip to Howardstown Pavement Scheme

- The N20 Ballyphillip to Howardstown North and N20 Ballymacrory pavement improvement scheme extends from 1km south of Anhid Cross on the N20 to 6kms south of Hynes's Cross.
- The contract for these works was awarded to Clare Civil Engineering Ltd. Works commenced in early January with an expected duration of 8 – 10 weeks.

N21 Templeglantine Pavement Scheme

- The N21 Templeglantine Pavement Scheme is located on the N21 national primary road at Templeglantine village. The scheme commences at the traffic island east of the junction of the N21 and extends approximately 1km to the west through Templeglantine village to the 100km speed limit sign.
- The contract was awarded to Roadstone Ltd. Works commenced in early January with an expected duration of 6 - 8 weeks.

1. Tourism Development

- Limerick City and County Council held an inception meeting with a number of stakeholders in January 2019 to discuss tourism in West Limerick. It is intended that the group will meet quarterly, and support a number of tourism projects progressing in the area, including the Great Southern Greenway, Shannon Estuary Way and an interpretative space in Glin Library.
- The Contractor is on site and work has commenced on the installation of an underpass under the existing N21 carriageway linking the Great Southern Greenway via the Barnagh Tunnel, work is expected to be completed Summer 2019.

Adoption of the Tourism Strategy

- The Limerick Tourism Development Strategy – Action Plan 2019 - 2023 was adopted by Full Council at the January meeting. Members welcomed the plan which will focus on four thematic areas – Into the Blue (Waterways); Alive and Kicking (Arts and Culture and Events); Energy Unleashed (Activities) and Vibrant History (Heritage and History). Staff from the Tourism Development Department will update the Councillors on an annual basis on progress on the Action plan deliverables.

Walking videos

- A series of six walking videos were launched, which were funded under the Outdoor Recreation Fund. The Tourism Department in partnership with the Local Development Companies identified relevant Country walks which resulted in promotional videos being produced for the following locations: Broadford/Ashford Walking Trails; Clare Glens; Knockfierna; Knights Walk, Glin; Keale River Walk, Ballyorgan and Castleconnell.

2. Urban & Rural Community Development

- The Community Development Department and Urban and Village Renewal Department merged on 2 January to create the new Urban and Rural Community Development Department.

Acorn Tablet Project

Following the provision of funding by Minister Michael Ring T.D., the Acorn pilot project was launched in Limerick on 14 January, the Mayor of the city and county of Limerick, Councillor James Collins. 31 older residents from across the county, will benefit from a 12 week programme of intensive training, aimed at giving older people an opportunity to become familiar with the use of a tablet, and to learn how to navigate the internet, manage a calendar and other skills required to effectively use IT.

Housing and Public Realm Training

On 30 January, a training session was hosted by Age Friendly Limerick and delivered by Jack Keyes, Senior Housing Advisor to Age Friendly Ireland. The session provided participants with an opportunity to discuss new and existing material relating to the area of housing, drawing on universal design principles and referring to Part M requirements. It set out the common principles between housing provision for older people and people with disabilities. It also covered the public realm, specifically Age friendly practices around public seating, toilets, parking, pedestrian crossings, parks and green areas.

PLACE – EE (Platforms for Ageing Community Engagement-Exchange and Enterprise)

Three Place EE workshops took place during January in Newcastle West with a wonderful group of 106 older participants in attendance. Workshops covered the following topics: gaining an understanding of perceptions on barriers to services, loneliness and social exclusion; an older people's attitudes towards younger people and local knowledge; crafts and skills that are 'threatened' or in danger of being lost.

Healthy Limerick

Two of the nine community projects funded by a small grant (with Healthy Ireland funding) that are led by students from Gaelcholáiste Luimnigh (community enhancement work around Nicholas Street) and Laurel Hill Coláiste (intergenerational project with residents of St Paul's Nursing Home) progressed significantly this month.

The number of private, public and community premises signed up to We're Breastfeeding Friendly Limerick reached 90. Preparations continued for the formal handover of the We're Breastfeeding Friendly concept to Healthy Ireland.

Work continued on the local action plan aligned to international best practice to support *Tobacco Free Ireland* with a wide range of partners with a stake in the next generation being tobacco free.

An interagency/inter-county meeting was hosted by Healthy Limerick to explore building on the current success of the expansion of the Social and Health Education Project (SHEP) to the county - with four

more short courses starting this month in Newcastle West, Abbeyfeale, Kilmallock and Hospital - by expanding the initiative within the region.

A "Pilot" Vacant Homes Survey was carried out in January 2019 by the inspectors of the Urban and Rural Community Development Department. Approximately, 1,200 properties were surveyed to determine the level of vacancy in Limerick city and county.

The survey will give an accurate level of vacancy in targeted small areas of population and identify homes that can be reactivated for social housing utilising the Buy and Renew and Repair and Lease Schemes.

Environment Awareness

Limerick City and County Council in conjunction with Security in Shredding facilitated a 'Free Shred Event' to celebrate European Data Protection Day 2018, promoting awareness of the incoming General Data Protection Regulations (GDPR) and promoting good waste management practices.

Limerick Senior Hurling Stars Launched Milestone TLC5 in Castleconnell.

Registration is now open for the fifth edition of Team Limerick Clean-Up (TLC), set to take place this Good Friday, 19 April, across Limerick city and county.

Ongoing assessments of Green Schools' Programmes across Limerick City and County progressed during January.

Two Leader projects were approved by the Local Action Group to the sum of €40,882.27 at the January Local Community Development Committee meeting.

3. Culture & Arts

Cultural Strategic Policy Committee

A workshop was held on 29 January for the elected members and sectoral interests to review investment and discuss and recommend the strategic priorities for the delivery of the cultural strategy for 2019.

Strategic Developments

National Volunteer Strategy Workshop Newcastle West 24 January

The Department of Rural and Community Development has called for input on key aspects to be included in a National Volunteering Strategy. Representation on behalf of the Limerick City and County Council through the council's Cultural Civic Engagement Programme were made at a workshop hosted by the Limerick Volunteer Centre in Newcastle West on 24 January. The Limerick Volunteer Centre along with all other centres in Munster have partnered to make a joint submission representing the interests of volunteer programmes in Munster.

Integrated Dance

Limerick Culture and Arts Department are working in partnership with West Limerick Children's Services and dance artist Mary Hartney on a new pilot initiative for Integrated Dance. Participants with their parents/guardians met for an information evening on Monday 21 January in West Limerick Children's Services, Gortboy, Newcastle West.

Helium Arts

Helium Arts Children's Creative Health Programme, Creative Health Hub Associate Artist Paul Bokslag has begun the new programme in the Paediatric Outpatients in University Hospital Limerick. Limerick Culture and Arts Department is working in partnership with Helium Arts, brokering partnerships for the Steering Committee for the programme.

The County Limerick Youth Theatre

Following the success of the pantomime, which had 94% capacity, a call for applicants was made for new members. Weekly workshops on a Tuesday commenced for the new term on 15 January and welcomed new members. The County Limerick Youth Theatre has an open recruitment policy and welcomes young people from all backgrounds and abilities.

A Piano for Dolores

The *Piano for Dolores* took place in Ormston House, 9-10 Patrick Street, Limerick from 12 noon until 9pm, allowing music lovers to come and remember the rock superstar on 14 January. The focal point was a piano. *Piano for Dolores* was brought to the public by *Dolce Vita* in association with the Culture and Arts Department.

Operational

Licensing meeting for St. Patrick's Day Festival

A statutory event licencing meeting for the 2019 St. Patrick's Day Festival took place on Monday 28 January with attendees present representing Limerick City and County Council (Planning and Environmental Services, Operations and Maintenance, Fire and Emergency Service and Limerick Culture and Arts Department) An Garda Síochána, HSE and Grooveyard Event Management, the company who won the tender for the delivery of Civic Festivals. The first draft of the Event Management Plan was reviewed and comments/amendments noted.

Open Calls

The International Mobility Award 2019 Round 1 closing date for applications was Monday 7 January 2019. 12 applications were received with a total ask of €13,330. The Assessment Panel met on Wednesday 16 January.

The 2019 Grants under the Arts Act were advertised on Tuesday 29 January. The total fund for 2019 is €20,000. The annual scheme offers grant funding to amateur, community or voluntary groups, or organisations, and individual arts practitioners, to stimulate public interest in the arts, promote the knowledge, appreciation and practice of the arts or assist in improving the standards of the arts. The closing date for applications is 5.00pm Thursday 28 February 2019.

Four letters of support were issued in line with the Limerick City and County Council Strategic Fund for Culture and Arts for applications to the Arts Council's Bursary Awards.

Creative Ireland

Limerick Culture and Arts Department and Local Enterprise Office delivered a joint presentation on Limerick Festival and Events Professional Development Training at the recent Creative Ireland Coordinators meeting in Dublin on 30 January 2019. The training programme was developed and delivered in 2018 through a collaboration between Culture and Arts Department and Local Enterprise Office as a response to recommendation from assessment panel of the Limerick City and County Council Festivals and Events Grant Scheme 2017 Strand 3.

The Creative Ireland Programme encourages cross-departmental collaboration and Limerick's case served as an example of such successful joint effort to improve service delivery in the area of culture and creativity.

4. Libraries, Gallery & Museum

Library Services

- An exhibition to mark the centenary of the First Dáil, was launched by the Mayor of the City and County of Limerick, Councillor James Collins, at Dooradoyle Library on Monday 28 January, 2019. At the First Dáil assembly at the Mansion House, Dublin in January 1919, Michael Colivet (Limerick City), Dr. Richard Hayes (Limerick East) and Con Collins (Limerick West) represented Limerick. Descendants of all three Limerick TDs from 1919 appeared as guests and were presented with a copy of the book *"Revolutionary Limerick: The Republican Campaign for Independence in Limerick, 1913-1921"* by John O'Callaghan. The elected members of Limerick City and County Council attended the ceremony. This was part of the National Commemorations Programme: Decade of Centenaries, 2012-2022.
- Dooradoyle Library also hosted two art exhibitions this month starting with Caoimhe O'Flanagan and followed by St. Saviours Community Art Group. Age Action continued computer classes every Tuesday morning with one to one tuition, while the Digital Skills classes held in conjunction with Ballyhoura
- Development CLG continued on Tuesday afternoons. A group of pupils from Catherine McAuley School visited the branch on Tuesday 29 January for quizzes and games. The Adult Book Clubs resumed for 2019 with the morning group reading *"Beatlebone"* by Kevin Barry and the evening group choosing *"Staring at Lakes"* by Michael Harding. The Children's Book Club also met on 31 January. Meditation classes and pre-school story-time sessions also continued.
- Newcastle West Library exhibited paintings by Jean Ryan Hakizimana for the month of January. Born in Rwanda, of Burundian parents, Jean has made Limerick his home and is well known for his art classes and exhibitions. Sheila O'Regan from West Limerick 102fm was present for afternoon tea on 17th to celebrate the vibrancy and colour of the work with an audience of local art enthusiasts.
- The Granary Library officially opened the exhibition, *"World War 1: Ireland's Humanitarian Effort"* by St. John Ambulance on 11 January. The tragedy of the First World War brought out the best in many Irish people. Thousands gave freely of their time. The number of volunteers, the range of activities, the funds raised, the sacrifice made, including the ultimate sacrifice, is largely unrecognised, unmentioned, and unremembered. This exhibition, curated by Pádraig Allen, sets out to recall some of those stories, recognising and remembering personal stories and the citizen's overall contribution. The Mayor of the City and County of Limerick, Councillor James Collins officiated; in attendance were local St. John Ambulance Officers and Officers from the Order of Malta.
- A Limerick Lace workshop with Toni O'Malley was held on 24 January. Weekly meditation classes, weekly meeting of this *"Nitter Natter"* group, who knit for charity on Fridays at the Granary, and, of course, a variety of book club gatherings continued throughout the month.
- Engaging children in the world of books and reading is of course, a strong focus of library activities and The Granary Library filled the month with targeted activities. These included: Storytime for children with Róisín Meaney on Saturday 5th, Storytime with staff member, Caroline, on Wednesdays 9th, 23rd and 30th, Junior Book Club with Julie on Friday 11 January and a visit of St. Mary's Preschool on 17 January, with staff member, Gráinne, running a Storytime and colouring session for 19 children aged 3-4.

- Adare Library's weekly Parent and Toddler Group recommenced with regular Friday morning sessions.
- First Year students from Scoil Pól, Kilfinane visited Kilmallock Library on Thursday 17 and 31 January as part of that "Well Read" Programme in operation at Scoil Pól. This programme is an initiative in secondary schools that seeks to grow a reading culture throughout the whole school environment. Recent research into the impact of digitisation on reading practices across the EU has found that young "digital natives" are much more likely to absorb information from the printed book rather than digital devices or screens. This research supports the value of proactively supporting a reading culture in all schools.
- The result of a collaboration between Kilmallock Traveller Group and Kilmallock Women's Group was exhibited in the library in January. The idea behind this project, under the guidance of Marion Clarke, Community and Family Support Worker with Ballyhoura Development CLG was to build bridges between two communities through what they have in common as women living their daily lives in the same town. The resulting fabric piece is a wonderful depiction of the town but perhaps a more lasting result is encapsulated in this quote from a participant "It wasn't easy to get started, but we just decided we would start. So we all turned up one night and there was no looking back". From planning to completion, the group talked, laughed and discovered things they did not know about each other. This project was funded and supported by Healthy Ireland, Ballyhoura Development CLG and the Limerick and Clare Education and Training Board.
- At Watch House Cross Library, a ten-week course began on 18 January for "Silver Learners", introducing the use of internet and email. Topics covered during the classes include online banking, booking holidays and using applications such as Skype. Fetac accredited courses on a wide range of subjects such as Excel, Graphic Design, Driver Theory SPSV, Maths and Driver Theory training continue to run weekly in the library's dedicated training rooms. The International Women's Organisation held their January meeting at Watch House Cross on Tuesday 22 January. Also in WHC Library *Les Enfants Francophones de Limerick* (EFL), facilitate French language classes for teenagers on Tuesdays. Story sessions for children and book clubs for all ages were held throughout the month.

Limerick Museum

- Limerick Museum received 1,653 visitors.
- Limerick Museum held a very successful Pop-Up Museum in St Paul's Community Centre, Mungret on 20 January.
- Limerick Museum has collaborated with the Hunt Museum and the Diocese of Limerick to hold an exhibition, *Visible Reminders of Invisible Light*, which opened on 24 January and will continue until 24 March. The exhibition, curated by local artist Maurice Quillinan weaves together many strands around the theme of family and celebrates Limerick's long tradition in visual culture. Artists across Limerick have given their individual interpretation of 'family' in the new exhibition, and the project saw 17 contemporary artists create new works based on the historic collections held in both museums.
- An exhibition on Limerick's role in the First Dáil that was curated by Limerick Library Service and Limerick Museum opened in Dooradoyle Library on 28 January.
- The exhibition Limerick's 130 Years of All-Ireland Success continued throughout the whole of January.
- Friends of Limerick Lace Group held a meeting in the Museum on 17 and 31 January.

Limerick City Gallery of Art (LCGA)

- Exhibition of LOUISE BOURGEOIS PRINTS: Autobiographical Series and 11 Drypoints, A Hayward.
- Touring exhibition from Southbank Centre, London exhibited from 17 January to 17 February. The first exhibition in Limerick of works by the internationally acclaimed artist of the 20th century.
- Recently donated artworks by Janet Mullarney and Maggie Madden temporarily exhibited for two weeks, along with other works from the Permanent Collection including works by Mike Fitzpatrick, Alice Maher, Breon O'Casey, Jack Donovan and Suzannah O'Reilly.
- Preparation and installation of Siobhan McDonald's *Crystalline: Hidden Monuments*, which officially opened on 31 January. The exhibition in LCGA is a Creative Ireland commission to address the late

prehistory (Bronze Age) linear earthworks in Ireland called the Black Pig's Dyke. In this new project, titled Hidden Monuments, McDonald presents a series of artistic enquiries to remind us of the Cairns, standing stones and Megalithic structures that foreshadow our architectural histories.

- Anita Groener's, The Past is a Foreign Country, exhibition received an Arts Council Touring and Dissemination Award managed by LCGA and opened at The Dock, Carrick-on- Shannon on 19 January. It will tour to The Lab, Dublin and Uilinn, Skibbereen, Cork in 2019.
- LCGA's visitor attendance for January was 5,140
- LCGA loaned two works by Mary Swanzy from the Permanent Collection to a major retrospective exhibition of her work, being toured by IMMA to the Crawford Art Gallery, Cork. This exhibition will tour to LCGA in the summer.
- LCGA continues to negotiate the use of the HUB with local groups for workshops and events.

5. Limerick Sports Partnership (LSP)

- Limerick Sports Partnership (LSP) hosted the annual Operation Transformation Walk in Lough Gur with 1,600 participants completing the walk with local Leader Jean Tierney.
- Limerick LSP was allocated €378,000 in Funding from our principal funder Sport Ireland, this was again the highest allocation across all 29 LSP's. This is in recognition of the work being done and the level of support being contributed by local stakeholders.
- The LSP commenced its 20 week Boxing Clever Physical Activity and Education programme. This programme contains three components, QQI Level 5 Health Related Fitness, QQI Level 5 Community Addiction Studies Course and Fitness through Boxing. All 24 participants are on a pathway of recovery from addiction. LSP has partnered with MWRDAF, CSMT and DEPS on this project.
- The LSP has recruited a Sports Development officer working with schools and projects for Women in Sport – LSP has eight full time staff.
- LSP were successful in securing another candidate (Assistant SDO) for the Aspire Graduate programme funded under dormant accounts.

Housing Development Directorate

1. Housing Strategy Implementation

Housing Delivery

Limerick City and County Council continues to provide social housing through the following programmes:

- Construction
- Acquisitions
- Leasing

Limerick City and County Council also works closely with Approved Housing Bodies/Voluntary Housing Sector in supporting both the acquisition and construction of social housing to meet the objectives of Rebuilding Ireland.

Serviced Sites Fund

- Limerick City and County Council recognises the challenge of affordability both for private tenure and private-rented tenure and welcome measures by the Department of Housing, Planning and Local Government on the prioritisation of affordable housing policy.
- On 29 June 2017, Minister Eoghan Murphy invited applications under the serviced sites fund from 11 local authorities, where it is felt there is a more pressing need for affordable homes, to support the provision of key enabling infrastructure on their land, to get their sites ready for the delivery of affordable housing.
- Limerick was not included in this initial call but made a significant case to the Department of Housing, Planning and Local Government in Q4 2018 and again in January 2019 demonstrating the requirement for affordable housing in the City and some key settlements in the County.

Southside Masterplan

- Under the Public Land Activation Programme the Housing Development Directorate, commenced the reimagining of 75 hectares of land to the southside of Limerick city with the appointment of a masterplanning team led by Allies and Morrison.

- Allies and Morrison, an architecture and masterplanning practice based in London and Dublin, is working with a team of Irish consultants and will now embark on the holistic masterplanning of the Baggot Estate, Ballinacurra Creek, Toppin's Field and the Rosbrien lands adjacent to the M20. The process to date involves thorough engagement and consultation with local community groups and interested stakeholders.
- A second roundtable public workshop was held on 31 January, where a presentation on the feedback of the first workshop in November was discussed.
- The team is at the early stages exploring a wide range of options for new recreation uses, nature conservation, homes, employment and community infrastructure. In addition to public workshops, focussed consultation with key stakeholder groups will be progressed throughout February and March 2019.
- Of particular interest to the Housing Development Directorate is the provision of affordable housing at Toppin's Field in accordance with its current residential land use zoning and the tenure diversification strategy adopted as part of the Limerick Regeneration Framework Implementation Plan /Limerick City Development Plan 2010-2016 (as extended).

Housing and Disability Strategy Group

- A meeting of the Housing and Disability Strategy Group took place in January 2019 with key service providers (HSE, Acquired Brain Injury Ireland, Enable Ireland, Brothers of Charity and other key service providers).
- Key actions agreed and being progressed to ensure efficient allocations of Limerick City and County Council housing stock include:
 1. Submission of Demand Information from Service Providers.
 2. Development of a design checklist for the construction and refurbishment of building stock for prospective clients of the key service providers.

2. Rebuilding Ireland

Rebuilding Ireland – Limerick exceeds 2018 targets

- Rebuilding Ireland is the primary policy document underpinning the work of the Housing Development Directorate. A €6 billion programme set to deliver 50,000 homes across the country by 2021.
- In Limerick the delivery target for 2018 was 251 new homes through building, buying and leasing. Limerick City and County Council have exceeded the target set by the Department of Housing, Planning and Local Government.
- The Housing Development Directorate are actively progressing capital appraisals for funding approval to meet the overall 2018-2021 target of 1365 new homes under the construction, acquisition and leasing streams.



Customer Services

- Several members of the Customer Services team attended a training workshop on the topic of Age Friendly Housing and Public Realm. This workshop was aimed at informing relevant staff members and elected representatives on how the regulations and guidance to housing and the built environment affect older people. This was an important workshop for Customer Services staff as they continue to support the frontline services provision of the Council.
- Customer Services received 14,803 calls via our call centre throughout the month, handling 41% of calls at first point of contact.
- This works out at approximately 645 calls per day.
- As well as logging 1,108 housing maintenance

cases for the North Operational Division, Customer Services also logged 21 cases for housing maintenance in both the West and South Operational Divisions.

- In January, there were 616 cases logged on behalf of elected representatives by Customer Services.
- Overall, on the SugarCRM (Customer Relationship Management) System, 3,293 cases were logged throughout January, 60% of these being logged by Customer Services in both our Merchants Quay and Dooradoyle offices.
