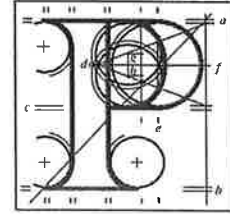

Dear Sir / Madam

I am writing to you in relation to the above application which was lodged on 22nd March 2019

It is our contention that the applicant – Limerick City and County Council, has submitted to yourselves a transformational project for Limerick city centre that will deliver both an exciting cultural and tourist amenity for the city and a much needed economic stimulus for the city as a whole.

The buildings in question, some of which are of the Georgian period are in an increasing state of dereliction, the majority of which have been largely vacant for several years. The proposal respects fully the Georgian nature of the area and in bringing world-class architecture, a theme fully embraced at the time by Georgian architects, to the area and of the period as a whole and will not only create a great addition to the city centre but also reinforce the premise of architectural statement that was championed by Georgian architects and builders.

It is unarguable that the city centre of Limerick needs further grade A office space and a new best in class library to replace its existing location in the Granary on Michael Street. Limerick City and County Council in conjunction with Limerick 2030 DAC have already delivered a magnificent new office development – Gardens International and I have every confidence that these organisations

can again deliver for Limerick well needed and long sought after commercial and cultural facilities that will return Limerick City Centre to the top of the Mid West commercial and cultural hierarchy. The provision of a modern tall building at Bank Place is welcomed and will fit well within its surrounding.

I strongly believe that the location and design of the proposed amenity will, as previously stated deliver to Limerick a facility that is sadly lacking in the area and as previously mentioned will delivered a much needed economic benefit to the city and reinforce the principles of "Limerick 2030 – An Economic and Spatial Plan" – the planning and development framework adopted by the City and County Council in 2013.

I trust that this observation will be considered fully and that the Bord will see fit to grant this very important project the requisite permission.
