I refer to the above.

You will be aware that the road was realigned at Killaghteen and Ballintubrid, Newcastle West following the construction of the N21 Killarney Pole to Barnagh Road Safety Scheme. On completion of these works land totalling 0.020 Ha has been deemed surplus to the requirements of the scheme. The Mid West National Road Design Office is now agreeable to arrange the transfer of the above land to Don Colbert, subject to Council approval. See attached Drawing No. 0068/55/0037, Revision 0.

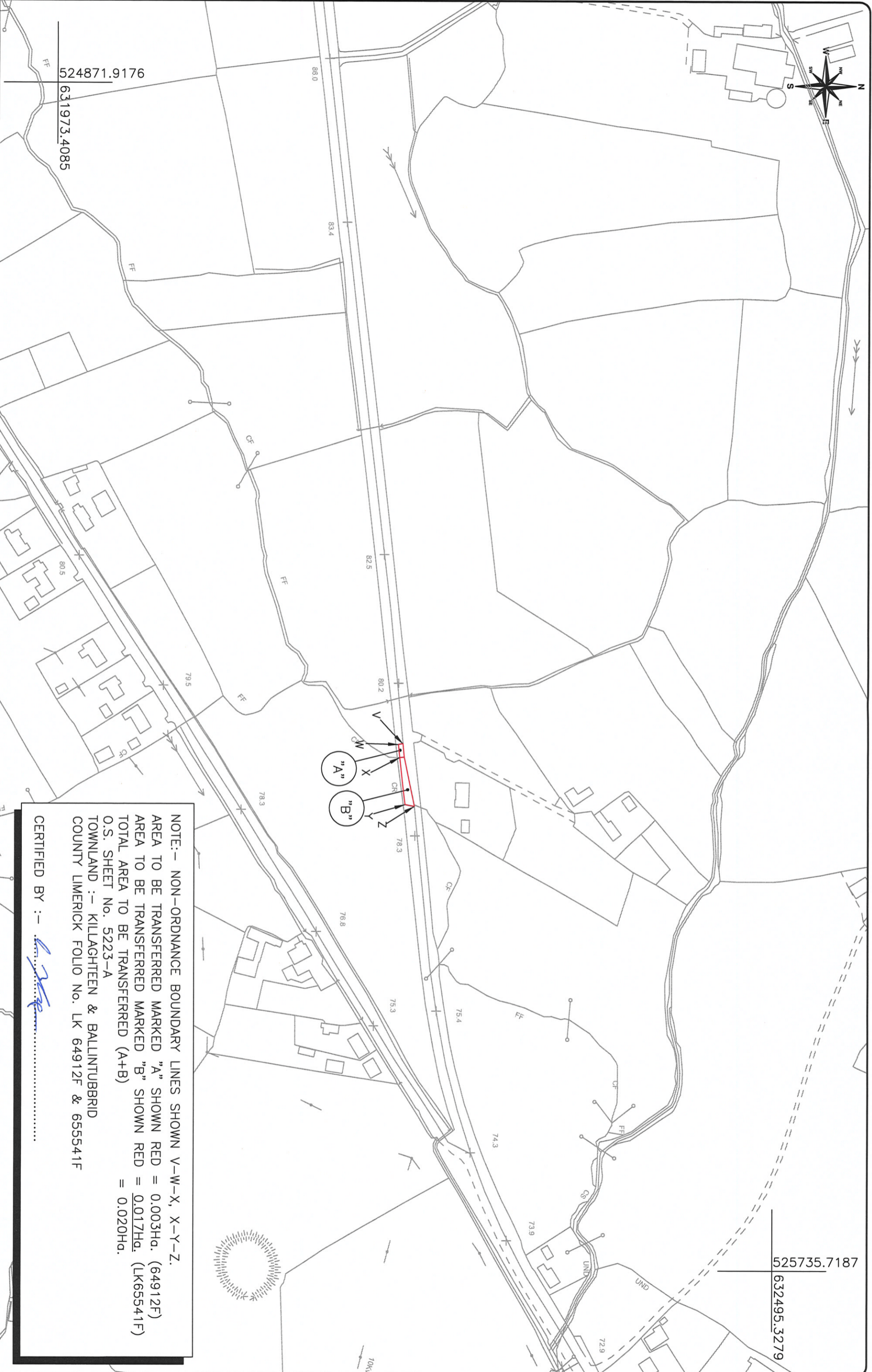
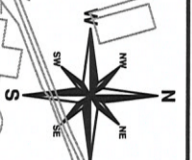
