1. Councillor Requested Reports

1.1 Drainage Issues at Courtmatrix

These works will be commenced when the resources come free from working on the Roadworks Programme.

1.2 Flooding Issues at Foynes

The Municipal District has met with a telemetry contractor on site and they are shortly to commence a radio survey of the area, with a view to fitting a pressure switch at the reservoir which will connect with an actuator valve on the fire control pipe, thus regulating the reservoir depth.

Concurrently, the Municipal District has appointed a consultant to carry out Rainfall and Runoff calculations to determine the preferred depth to be maintained in the reservoir and to determine capacity requirements on the outfall culvert.

1.3 Flooding issues in Askeaton

This project is included in the works requirement for the CFRAMS project under the control of the OPW. It has not been approved under the first tranche of funding for same.

As this project is not under the control of the Municipal District, it is recommended that it be removed from the District Engineer's Report.

1.4 Marine Cove, Foynes

The Municipal District will undertake a CCTV survey of the Storm Water system in the coming weeks to determine necessary works.

1.5 Slí na Sláinte, Askeaton

Approval has been received from the TII for the proposed works. These will commence in the coming weeks.






3.3. Foynes Yacht Club Rock Armouring

3.4 Slí na Sláinte, Askeaton

TII Approval of Works received. Scope of works now extended to bridge over the River Deel. Estimated cost of work now €227,000, with €118,000 received from ORIS 2018 and balance to come from the TII. Works to commence shortly.





Askeaton Slí na Sláinte Extension



4 Report on Applications for funding made


4.1 Askeaton TVR Town Centre


4.2 Askeaton ORIS 2019 Riverside Walk

Application has been made for €96,000 to extend the Riverside Walk in Askeaton.




4.3 Foynes ORIS 2019 Monument Hill

Proposed Works, The Mall, Ballingarry


4.5 Gerald Griffin GAA Clar Application
