#### **Economic Development Directorate**

#### 1. Trade & Investment

- Tiernan Properties announced a major development of up to €60 million for Arthur's Quay with leading retailer Marks and Spencer as the anchor tenant.
- Golf's most prestigious tournament the Ryder Cup - has been awarded to Adare Manor in 2026.
- Troy Studios secured a major deal to host €45m Apple TV drama.
- A new retail store has opened on Dublin Road, with Spar as the main tenant, creating 42 new jobs (25 full time and 17 part time).

## 2. Digital Strategy

- A public consultation for the "O'Connell Street Revitalisation Project - Phase 1" was published on the Council's new MyPoint Public Participation Portal, while Digital Strategy continues to work with Business Improvement and Marketing & Communications to raise awareness of the platform both internally and externally.
- The LITe project progressed with rollout to Property Services, bringing the total number of users to approximately 260. The rollout will now continue to Customer Services and then Design and Delivery. Work is also underway to get all elected members working with Sharepoint Online before the September meeting.
- The procurement process to deliver an enterprisestandard CRM for the Council commenced, with the tender published in the EU Journal. The deadline for responses is 21 August, with award of the tender contract scheduled for mid-September.
- Seven community consultation sessions have been arranged for the Smart CCTV Pilot Project between 24 and 31 of July with members of local community councils, councillors, council enforcement officers and local garda officers who were invited to view a live demonstration of the CCTV monitoring centre in Moyross Community Enterprise Centre. The purpose of the consultation sessions was for community representatives to gain a better understanding of how the CCTV systems are used, how live monitoring works, what the impact on privacy is, and what controls and processes are implemented in order to safeguard people's data and privacy while providing adequate

support to fight rural crime and investigate offences.

• The Safer Communities website has been developed to provide all the information in relation to the use of CCTV together with a map of CCTV cameras in use by the Council. The website can be accessed at https://safercommunities.limerick.ie/

- At the monthly +CityxChange meeting in July in the Engine, Robbie Keelan from AVIS Budget Group Ireland presented a Nissan Leaf to the consortium, to demonstrate the type of Electric Vehicle that they will deploy as part of the EU H2020 funded project.

#### **1. Travel & Transportation Strategy**

Completed bus shelter installations at Fr. Russell Road, Dooradoyle and The Forts, Ballycummin in July. These facilities will provide greater comfort to commuters and thereby assist the use of public transport.

#### 2. Environment Strategy

Adoption of the Limerick City and County Climate Change Adaptation Strategy 2019-2024.

At its Meeting held on Monday 8 July, Limerick City and County Council in accordance with the requirements of the National Adaptation Framework, considered and adopted the Limerick City and County Council Climate Change Adaptation Strategy 2019-2024.

Climate adaptation relates to addressing the impacts of climate change. The adopted Strategy is a crossdirectorate document, which aims to embed the concept of climate change adaptation into the policies, plans and processes of the Council. The Strategy identifies the risks to the Council posed by recent climate events, and sets out a number of objectives and actions under six key themes to enhance the resilience of the Council's policies, plans and operations to severe weather events, which will be implemented over the lifetime of the strategy.

### 1. Tourism Development, Culture & Arts

# Wayfinding Strategy and Implementation Plan

• A Steering Group was established and work commenced on developing a Wayfinding Strategy and Implementation plan for Limerick city centre and environs. This project will be delivered through Limerick City and County Council and a tender brief is currently being prepared.

#### Regional Festivals and Participative Events Fund

• Limerick City and County Council has launched the Regional Festivals and Participative Events Fund. A funding arrangement has been put in place between Fáilte Ireland and Local Authorities to drive the implementation of tourism focused festivals and participative events. This new funding arrangement will replace Fáilte Ireland's existing annual Regional Festivals and Participative Events Programme. Closing date for receipt of applications is Tuesday 20 August.

#### **CAPITEN** project

• Staff from Limerick City and County Council attended an EU partner meeting in Las Palmas as part of the CAPITEN project. CAPITEN is an EU Interreg funded project under the Atlantic Area Programme focused on developing innovations in marine tourism, itineraries and port information points. This project will assist in the implementation of the 'Into the Blue' pillar of the recently launched Limerick Tourism Development Strategy.

#### **Open Calls**

## Festivals and Events Grant Scheme and Assessment Panel

On the 8 July, at the meeting of the full Council, the report and recommendations for the Festivals and Events Grant Scheme 2019/2020 was approved by the Elected Members. Sixty applications had been received and 37 were recommended for funding when the assessment panel met in June and considered all applications based on the guidelines and criteria for the festival and events grant scheme. All applicants have since been notified in writing of the outcome of the assessment process.

#### International Mobility Award 2019, Round 2

On 8 July at the full Council meeting the report and recommendations for the International Mobility Award 2019, Round 2 were approved by the elected members. Seven applications were received and six were recommended for funding when the panel met in June and considered all the applications based on the guidelines and criteria for the International Mobility Award scheme. All applicants have since been notified in writing of the outcome of the assessment process.

#### Words Ireland National Mentoring Programme 2019

Limerick City and County Council in partnership with Words Ireland, offered an opportunity to a Limerick writer for a structured mentoring programme. Mentoring was open to emerging and early-career writers who wanted to develop their work in the areas of: literary fiction; creative non-fiction; poetry or children's/young adults fiction. Mentoring will consist of four meetings between each of the selected mentees and their writer-mentors over a period of up to eight months. The mentor will read the mentee's work in advance of each meeting, and offer feedback and guidance at each meeting. Applications closed on the 31 July.

# Strategic Fund for Culture and Arts Scheme, 2019

The Strategic Fund for Culture and Arts Scheme supports applications to national and international funding bodies to help leverage funding by offering a percentage of any funding awarded, in the event of a successful application.

#### Bursaries: Blas International Summer School and the Meitheal Summer School

Following open call and assessment panel, a bursary place was awarded to allow one successful applicant to attend the Blas International Summer School of Irish Traditional Music and Dance, 22 June-3 July and two bursary places awarded to allow two successful applicants to attend the Meitheal Summer School, July 22-27.

# Festivals in July supported by Limerick City and County Council

The inaugural Celtic Band Festival took place from the 26-28 July, saw The Irish Marching Bands Association welcome bands, musicians, and visitors from around the world to a new Summer band festival in Limerick. This festival was open to national and international bands including Marching Show Bands, Concert Bands and Traditional Marching Bands. Participants took part in an array of events including Field Shows, Parades, Soundsport and Concerts as well as master classes and workshops. Events took place in University of Limerick and Limerick City Centre including a live event on Saturday evening in The People's Park. This festival is accredited by the Irish Marching Bands Association, World Association of Marching Show Bands, Soundsport and Drum Corps Europe. Celtic Band Festival was supported by Limerick City and County Council through the Festivals and Events Grant scheme 2018/19.

#### **Programme Activity**

#### Art Collection

The work of documenting and assessing the art collection for Limerick City and County Council was substantially progressed, a numbering system for the artworks decided, works numbered and documented and a long list of loans for University Hospital Limerick was collated.

#### **Castleconnell Autumn Concerts Series**

Castleconnell Autumn Concerts have an international focus in 2019, beginning with one of Britain's foremost pianists, Leon McCawley on Tuesday 27 August. In July promotion for the Castleconnell Autumn Concerts Series began, with the distribution of brochures and posters to the library service and public areas.

#### **Civic Festivals**

#### Riverfest

Riverfest Limerick, which broke records in 2019 with more than 120,000 people enjoying Ireland's premier May Bank Holiday festival, beat off competition from festivals and other events across the country including Pope Francis's Visit to Ireland, New Year's Eve Festival in Dublin and Seafest to win the 'Best Event' at this year's Event Industry Awards. The Event Industry Awards celebrate excellence and showcase the very highest standards in Ireland's event industry. The 11th annual ceremony took place recently at Citywest Hotel in Dublin, where Riverfest Limerick won Best Live Event and then won the overall prize of Best Event.

This awards ceremony recognises the varied nature of live events in Ireland and stand-out categories include Best Live Event, Best Event Team, Best Awards Ceremony and Best In-House Event Team. Overall, 27 awards were presented on the night, with a judging panel consisting of three co-ordinators and 16 industry professionals and peer experts who have national and international experience of organising events.

Riverfest Limerick was entered into the awards by Grooveyard, which event manages the festival on behalf of Limerick City and County Council.

#### Limerick Culture Night 2019

Culture Night 2019 will take place this year on Friday 20 September. Limerick City and County Council put out a public call for participants who would like to be involved in Limerick Culture Night 2019. This closed on 19 July. Last year, Limerick hosted over 80 events in more than ninety locations drawing an audience of over 21,600 people. These registrations are now being processed.

#### Invitation to Collaboration

July 2019

A new report, compiled by Indecon Consulting, outlined the value and impact of local authority arts programmes and advised on what the sector can achieve and the measures required to support further success. The report, developed as part of the Arts Council funded 'Invitation to Collaboration' programme by the arts offices of Limerick, Fingal, Kildare and Leitrim local authorities with Indecon Consulting, was launched in July by Jackie Maguire, Chair of the County and City Management Association (CCMA) and Chief Executive of Meath County Council. Since the first Arts Office was established in 1985, local authorities have grown to become the most significant network of agents for arts development in Ireland today, with a vast knowledge base and depth of experience and expertise. Working within the local authority structure provides unique opportunities to develop diverse projects and programmes, often in partnership with agencies or groups within the community, which makes the work intensely relevant and rooted into the fabric of a wider perspective of integrated social, cultural and economic development. However, the diversity of approaches and the interdisciplinary nature of the work often results in the function and scope of the arts office itself being harder to define and obscured as a result.

In commissioning this report, the four local authorities set out to sharpen that focus, not on the work of the arts office as a whole, or the entire local authority or arts sector, but to concentrate on a small number of projects to contribute to a better understanding of what can be achieved and what is required to make that happen. The four case studies focus on long-term strategies in areas such as arts and health (Kildare) young people and the arts (Fingal) supporting artist's professional development (Leitrim) and enabling international development and perspectives (Limerick). These case studies represent only a fraction of the work carried out in each of the four areas, and each of the 31 local authority arts offices throughout Ireland implement similar exemplars. Exceptional work that impacts locally is also undertaken by other agencies and organizations, many of whom are funded by the local authority and/or The Arts Council.

#### **Helium Arts**

Helium Arts third Advisory Committee group meeting took place and received a presentation on outcomes from the first six months of the Limerick Creative Health Hub.

# International Partnerships European Projects

Limerick City and County Council was successful as associate partner on two Creative Europe projects:

- 1. The European Outdoors Arts Academy, School of Participation builds on the legacy of the School of Spectacle and will develop and deliver five 'School of Participation' eight day training schools, which will be presented in five partner cities between 2018 and 2020. Each school will bring together 27 creative practitioners together from the eight partner cities and countries, to gain new skills and experience in co-creating an outdoor participatory arts event. All schools will be delivered by a team of outdoor arts experts drawn from across the core partnership. Each school will result in the creative practitioners collaborating with each other and 25 local community participants in each school hosting city to deliver an "end of school" outdoor participatory arts event to the public. The programme will underpin the development of a professional network of European outdoor and participatory creative practitioners and contribute to the strengthening their creative careers. It also provides a practical opportunity to build capacity and create a programme of "action learning" for cultural organisations and practitioners.
- 2. TRAINART aims to give new skills to cultural operators/artists, to strengthen their business models, by focusing on two particular fields: (1) management models of cultural spaces and (2) artistic interventions in nonconventional contexts. The project focuses on cultural spaces that serve a diverse audience base. These centres typically offer to their local audience touring productions (performances, musicals, commercial concerts and comedy). A Training Hotspot will take place in Ireland, in Limerick at the Belltable, to foster business competencies and develop new models of governance and management.

#### **New Developments**

#### Wild Geese / Bastille Day - Sunday 14 July

Limerick celebrated Bastille Day and commemorated its historic 'Wild Geese' links with France at a FREE family event on Sunday 14 July at King John's Castle. Organised by Limerick City and County Council and the Honorary Consul of France in the Mid-West, in association with Shannon Heritage and Alliance Française de Limerick, the Limerick celebration featured family entertainment, a tour of King John's Castle, displays in the courtyard, musical performances and an historical talk on 'The Flight of the Wild Geese'. Members of the public, and particularly those from the French community living in Limerick, attended the event from 1-5pm at King John's Castle on Bastille Day, 14 July. A parade of En Garde, dressed as 18th century soldiers of the Légion irlandaise, members of the French Foreign Legion Association of Ireland and members of the Irish Defence Forces as well as Limerick's Boherbuoy Band created a jovial but respectful atmosphere as both the Irish and French national flags were raised with performances of both national anthems.

A talk by Cornelius O'Sullivan, President of En Garde, on the history of the Flight of the Wild Geese and its long-lasting impact on the shared history of France and Ireland was followed by a gun salute by En Garde members. The term 'Wild Geese' had been used to describe those Irish serving in European armies since the 16th century. The historical episode known as the 'Flight of the Wild Geese' refers to the 12,000 Irish Jacobite soldiers, commanded by Patrick Sarsfield, who left Ireland for France as agreed in the Treaty of Limerick in 1691 ending the Williamite War in Ireland. The Wild Geese formed King James's army in exile but by 1692 were incorporated into the French Army. The Mayor of the City and County of Limerick, Councillor Michael Sheahan addressed those gathered and expressed his desire to restore links with French towns and cities Limerick is twinned with as well as establishing the 14 July as an annual event to celebrate the Wild Geese connections worldwide.

#### Tender for Formulation of a Festivals and Events Strategy for Limerick 2020-2030

Limerick City and County Council believes that Festivals and Events play a distinctive role in developing vibrant and sustainable communities. Research has proven that festivals and events drive tourism growth as well as grow capacity within the creative sector itself. Festivals and Events also offer important opportunities for residents, visitors and creatives to gather, collaborate, experiment, explore and present work in an atmosphere of celebration. Festivals and Events celebrate diversity and change and encourage people and places to value their lives and the communities they live in. Financial investment by Limerick City and County Council in festivals and events has already contributed to:

- Limerick's revitalisation, complementing economic development and community growth.
- The tourism offering, understanding the interdependence between culture and tourism.
- Culture as a shared resource that has energised and enabled a USP for Limerick City and County Council's collective ambition.

This tender is part of the actions to support the ongoing transformative revitalisation of Limerick, which is repositioning Limerick as an attractive European destination in which to invest, work and live, is underpinned by a cultural renaissance, which has changed the face of Limerick. Local perceptions of Limerick have been renewed with a confidence and a sense of belonging to which other places aspire. Wider national and international perceptions of Limerick have been energised by the stronger identity we have forged. #### Health and Wellbeing

- The Urban and Rural Community Development Department was part of a Limerick City and County Council team that attended a meeting hosted by University of Limerick to discuss collaboration and preparation for Stage 2 submission of a H2020 project that focuses on health and wellbeing.
- The Urban and Rural Community Development Department was part of a Limerick City and County Council team that attended the launch of the Yarn Social Club led by Care Bright. The clubs will focus on aiding older people who are tackling dementia.
- Progress continued on the preparation of a twoyear programme of work that will be submitted by the Limerick Local Community Development Committee (LCDC) to Pobal/Department of Health for up to five projects funded by Round 3 Healthy Ireland funding 2019-2021. This is of the value of up to €184,000.

#### Men's and Women's Shed Fund

Limerick City and County Council received an allocation of €27,487 (third highest in country) under the Community Enhancement Programme. Funding for Men's Sheds. This was launched for the first time in 2018 and provided in excess of €31,000 of funding for Men's Sheds projects across Limerick city and county.

This funding is for small capital grants to enable individual Men's and Women's Sheds to purchase equipment or to carry out minor works to improve their premises. All details such as what groups can apply along with the application form are available to download on www.limerick.ie. The closing date is 16 August 2019. The decision for the allocation of this fund will be decided upon by the LCDC.

#### Social Innovation Fund

The Social Innovation Fund Ireland, in partnership with Limerick City and County Council and IPB Insurance, announced Munster/Connacht Awardee winners in Limerick on 12 July. From a shortlisting list of 200 applicants, two Limerick based social enterprise projects were named as awardees of a social enterprise development fund, St. Gabriel's Orthotic Services and The Urban Co-Op. They will receive cash grants of between €10,000 and €50,000 and a place on Ireland's most prestigious Accelerator Programme for Social Enterprises.

## Launch of Limerick Going for Gold Competition for 2019

This year the competition was launched in Kilteely, Co. Limerick on 7 July – one of the joint overall winners in 2018. Over €60,000 will be distributed across various categories including a Tidy Towns Category, Limerick Bee Friendly in Bloom, Champions Category, Residential Areas, Endeavour Award, Reuse Award and Best Front Garden Category. In judging the competition consideration is given to litter control, general tidiness and upkeep, pollinator friendly planting, sustainable planting, overall impression, works undertaken/improvements from 2018.

#### Launch of Refill.ie campaign in Limerick

Launched on the 8 July Refill.ie hopes to prevent plastic waste by reducing the amount of single use drinking water plastic bottles we consume in Ireland. The initiative is aimed at tackling the amount of plastic bottles ending up as litter on our streets, waterways and seas. The nationwide initiative encourages the public to refill their reusable bottle for free from commercial locations. Twenty additional businesses have signed up in Limerick since the launch bringing the total number registered to 31.

#### Limerick Sports Partnership (LSP)

- The LSP delivered six Multi Sport camps for targeted disadvantaged groups across Limerick City and County. 220 participants engaged in these camps.
- The LSP facilitated the opportunity for 538 children 5-12 years to attend the Adventure World Sports Camp hosted at UL Sport Arena. This is a great partnership where children are facilitated to attend a mainstream camp and make new friends.
- The Sports Partnership delivered two 2-day Mental Health First Aid training courses for 40 club coaches. It was great to see coaches upskilling to enable them look after the participants physical and mental wellbeing.
- The very popular Activator Pole walking programmes were very well attended at the UL Golden Mile, Shannon Fields, Mungret Park, Garryowen, Castleconnell and Newcastle West.
- The LSP Sports Development Officers continue to develop programmes for key target groups, Men and Women 30-65 years, marginalised communities, Older Adult groups, walking groups and general populations across the county. See www.limericksports.ie for more information.

- The HAP SSC Debt Management Unit issued 3,830 differential rent arrears letters to HAP recipients in July 2019.
- The HAPSSC Debt Management Unit collected a total of €65.5m in differential rent from January to July 2019.



#### National Day of Commemoration 2019

Limerick City and County Council hosted the National Day of Commemoration ceremony on Sunday, 14 July. The ceremony, organised by Corporate Services, was to honour all Irishmen and Irishwomen who died in past wars or on service with the United Nations. More than 300 people attended the event representing a broad cross-section of various religious beliefs. The ceremony finished with a minute's silence and the Mayor of the City and County of Limerick, Councillor Michael Sheahan laid a wreath.

#### **Customer Serices**

Customer Services staff met with new councillors during July to train on the use of the MyLimerick platform. This platform, on www.limerick.ie, is a very convenient and efficient way to both log representations and receive updates on requests logged. July saw a total of 289 cases logged through MyLimerick, 272 of which were logged by local representatives.

Customer Services also continued to support the Housing Maintenance Department by logging 73% of cases throughout the month of July, as well as logging 56 cases for housing maintenance in the area offices. Following a review of the Residential Parking Permit application form and a meeting with some of the service users, a new form has now been devised. This sets out in a clear and concise way the checklist for accompanying documentation and lends itself towards ongoing work to make this an online process for our customers.

Throughout July, Customer Services have handled 100 Residential Parking Permits.

Customer Services received 11,803 via our call centre throughout the month, handling 42% of calls at first point of contact.

This works out at approximately 513 calls per day.

In July, there were 725 cases logged on behalf of elected representatives by Customer Services.

Overall, on the SugarCRM (Customer Relationship Management) System, 2,906 cases were logged throughout July, 70% of these being logged by Customer Services in both our Merchant's Quay and Dooradoyle offices.

The majority of cases logged were for the following services:
