I will ask at the next meeting of the Municipal District for details of the Council's social housing units which are currently vacant in the Municipal District, and the anticipated timeframe for the turnaround and allocation of each of these properties to new tenants.

Response to Question

The number of vacant social housing units in the Municipal District of Cappamore-Kilmallock is 35 as at start of September, 2019.

These units are broken down as follows:

Allocated:	3
Casual Vacancies:	23
Major Refurbishments:	9

The timeframe for turnaround and allocation varies with the condition of each property and the scale of refurbishment work required. The average turnaround time noted in the most recent National and Oversight and Audit Committee (NOAC) report is 28.49 weeks.

I will ask at the next meeting of the Municipal District for an update on when will the Speed Ramp/Cushion be installed on the R513 in Caherconlish.

Reply:

There are 2 locations on the R513 where Speed Ramps / Cushions are proposed. At Lynch's corner, a table top ramp is to be installed on the junction of the R513 / L1149 / L5096. This is part of the 'Lynches Corner Caherconlish' LCSS. These works are to commence in the coming weeks.

Another speed cushion has been requested on the Herbertstown approach to Caherconlish Village. As part of Limerick City and County Council's Traffic Calming Policy, a Traffic Calming Assessment is required. This will be carried out as soon as resources are available.
