The Strategic Policy Scheme 2019-2024 was formally adopted by Council at its September Meeting held on 23<sup>rd</sup> September, 2019. A total of 18 nominations have been sought as follows:

- Agriculture/Farming Pillar (5)
- Development/Construction Pillar (4)
- Business/Commercial Pillar (7)
- Trade Union Pillar (2)

16 nominations have been received from the sectoral groups. Two vacancies remain to be filled from the Agriculture/Farming Sector for the Economic Development, Enterprise and Planning SPC and the Community, Leisure and Culture SPC. The Irish Farmers Association have advised that they will submit the names of the nominees in due course.

Vacancies remain in relation to positions to be filled from the Environment/Conservation, Community/Voluntary and Social Inclusion Sectors to be nominated by the Public Participation Network.
