#### Reply:

#### (i) N21 Ward's Cross

The technical consultants appointed for the scheme, Barry Transportation, have progressed the detailed design for the right turn lane and a number of design issues arose as part of this process. These issues arose from retrofitting a right turn lane into a road constrained by the carriageway alignment, the location of properties in the vicinity of the junction and the topography of the surrounding land. Many of these issues do not conform to current road design parameters and will require a departure from standards from TII.

The technical consultants have worked to refine the design and remove as many departures from standards as possible by means of a workshop and consultations with the Road Design Office and TII Safety and Pavement sections. This process has been largely successful but a number of issues still require a departure from standards.

We are endeavouring to finalise the design, prepare the Preliminary Design Report and submit the departure application as soon as possible.

# (ii) N21 Devon Cross

Barry Transportation have recently submitted a draft feasibility report for the N21 Devon Cross junction and the report outlines three options that have been developed for the junction. The three options are as follows:

- 1. To construct traffic calming measures on approaches to and through Devon Cross
- 2. To create a staggered junction by realigning the local road north of the N21, the L7059 that commences at Buckley's Shop, to the east of Devon Cross

3. To create a roundabout junction to the west of Devon Cross and realigning the regional road, the R515 that commences at Hartnett's Service station, to the west.

Staff of the Road Design Office have reviewed the options developed and the draft report was also submitted to TII for their consideration.

Subject to TII approval of the recommendations in the finalised feasibility report and allocation of the necessary funding, Barry Transportation could then proceed with the detail design process for the preferred option and preparation of tender documents.
