

Dear Mr. Clune,

I refer to your correspondence of 22 July 2019 to An Taoiseach, Mr. Leo Varadkar T.D., in which you conveyed the call by Limerick City and County Council for urgent reform of the insurance sector in response to the current crisis surrounding the availability and cost of insurance cover. I apologise for the delay in replying.

I should state that overall responsibility for the insurance sector lies with the Department of Finance and that Department has been asked to respond directly on the actions being taken to address the issue of rising insurance costs in the childcare sector.

That being said, the Department of Justice and Equality has been an active participant in the Cost of Insurance Working Group which was established to ascertain what measures Government could take to address the very high costs that insurance companies are imposing on their customers - including by reference to those solutions operated in other jurisdictions. In that context, the Department has taken a number of actions designed to address insurance costs including:

- The publication of guidelines for the reporting of allegations of fraudulent insurance claims to An Garda Síochána;
- The inclusion of a new claim fraud category on the Garda PULSE system which will enable the production of better statistics on fraudulent claims;
- The establishment of an Insurance Fraud Database Working Group which is working to establish an integrated insurance fraud database;
- The introduction, by the Garda Commissioner, of a focused model aimed at tackling insurance fraud at divisional level throughout the country;
- The amendment of sections 8 and 14 of the Civil Liability and Courts Act 2004 to improve their effectiveness against fraudulent claims.

In addition, the Minister for Justice and Equality, Charlie Flanagan, recently signed the Commencement Order for the Judicial Council Act 2019, allowing the Council to formally come into being. Part of the functions of the Council will be the adoption of guidelines for awards in personal injuries cases. The work on drafting such guidelines will be carried out by the Personal Injuries

Guidelines Committee which is chaired by Justice Mary Irvine. It is due to report back to the Judicial Council within six months of its establishment.

Further to the above, the Law Reform Commission published an Issues Paper on the subject of "Capping Damages in Personal Injuries Actions" on 11 December. The Issues Paper will provide contributors with an opportunity to express their views and to make any related submissions on the questions that arise in the Paper. The closing date for receipt of submissions is 31 January, 2020. It is expected that the final Report of the Commission will be published next year.

There is more to be done within the insurance industry to address the issues of high costs. The Department of Justice and Equality has called on the insurance industry to be more responsive to the needs of their customers and to address the situation that certain areas of risk are being commercially avoided to the detriment of businesses and customers. The Department will continue to make every possible effort to help ensure that relevant legislative and other measures are taken to address the issue of high insurance costs.

There is some evidence of the positive impact of the range of measures taken by Government. In May, the Central Statistics Office revealed that the price of motor insurance fell again in April and is 6.6% lower than this time last year and 24.4% lower than its peak in July 2016.

As you will observe from the above, the groundwork has now been completed to enable this issue to be tackled comprehensively and the coming months will see action being taken by the Judicial Council and its relevant committees to address issues affecting the cost of Public Liability Insurance and ensure the continuing viability and vitality of our community and voluntary sector.

In responding to your correspondence, I can assure you and the members of Limerick City and County Council that Minister Flanagan fully recognises the adverse impact that prohibitive insurance costs, and the unavailability of any suitable insurance cover for some, is having at present. He particularly appreciates that these matters are having a negative impact on small business, play centres and other activities at local community level, including in economic and employment terms. These concerns are central to the Government's ongoing drive for insurance costs reform including through the programme of actions now being taken under the Cost of Insurance Working Group.

I hope I have been able to be of some assistance to you on this matter.

My name is Niamh Connolly. I am a bereaved parent and I live in Celbridge, Co Kildare.

Today, the motion below was carried unanimously by all Kildare county council councillors. I am delighted to say that there was cross-party support. I would be grateful if you could bring this to the attention of your county council elected representatives (councillors) so that a similar motion might be posed.

That Kildare county council requests that the Minister undertakes the following: That the stillbirth register and stillbirth registration be removed and be replaced with a birth and death certificate for babies who are stillborn, so that babies who are stillborn can be registered on the birth and death register and can receive the same state records of their existence as everyone else. Parents whose babies are currently listed on the stillbirth register should be given the opportunity to have their babies placed on the birth and death register and to receive a birth and death certificate for their babies.

This motion was posed by Cllr Ide Cussens.

Below is my personal story which might help give some insight into this request.

Personal story

My name is Niamh Connolly. I had twin girls in 2015. Emma was born well and healthy but very sadly, her twin sister Mia had a heart problem called hypoplastic left heart syndrome and she died 4 weeks before she was born. When I went to register Emma in Naas, Co Kildare for a birth certificate, I realised that because Mia was stillborn she would not be receiving a birth certificate and a death certificate like everyone else but instead she would be listed on a special Stillbirth register that is closed to the public. Only my husband and I can have easy access to a copy of Mia's stillbirth certification from the General Registers Office. Mia's siblings would not and neither do any other relatives or friends. The General Registration Office currently process applications to obtain a copy of her stillbirth certificate from other family members when they are satisfied that sufficient evidence has been produced to demonstrate knowledge of the stillbirth in question. This means that when I am gone, no one will have easy access to any state records about Mia and future descendants might not even know that she existed. This does need to change.

I would be great if you could send me an acknowledgement email and confirmation that it has been sent to elected representatives.
