QUESTIONS

7. Question submitted by Councillor Donegan

I will ask at the next Meeting of the Municipal District of Cappamore-Kilmallock for a report outlining the extent of use of mobile CCTV equipment to tackle the issues of littering and illegal dumping.

- (a) The report will include the number of locations where such equipment was used over the past two years and the number of fines/prosecutions that resulted from its use;
- (b) The types of locations and areas of open spaces that mobile cameras have been used in the past 2 years;
- (c) The annual budget available for the use of such equipment and if the Council owns its own equipment or engages private operators to manage these mobile units.

8. Question submitted by Councillor Teefy

I will ask at the next Meeting of the Municipal District of Cappamore-Kilmallock that Irish Water give an update on the capacity of each Waste Water Treatment Plant in the Cappamore-Kilmallock Municipal District, having regard to possible future developments in these towns and villages. I will also ask what are Irish Waters future plans to upgrade Waste Water Treatment Plants that currently do not have additional capacity.

9. Question submitted by Councillor M. Ryan

I will ask at the next Meeting of the Municipal District of Cappamore-Kilmallock for a list of viable and operational Business Parks in the Cappamore Kilmallock Municipal District area that are operated by Limerick City and County Council and Shannon Commercial Properties.

10. Question submitted by Councillor Mitchell

I will ask at the next meeting of the Municipal District of Cappamore-Kilmallock that Irish Water clarify fully the statement made on local public airwaves on the 7th July 2020 by Ian O' Mahony of Irish Water that Hospital water supply was incurring problems. New water pipes have been laid and a new borewell was provided by the appointed operators which I was reliably informed had adequate supply.
