Economic Development Directorate

1. Trade and Investment

- Sinead Ryan, Chartered Quantity Surveyor, has been appointed as new Project Manager for Limerick 2030 ahead of the commencement of work on the Opera Site.
- Construction has commenced on the new Lidl store in Corbally, which will create 30 permanent jobs when the store opens.

and associated industries. The project is open to individuals and businesses who are located or domiciled in counties Limerick and Clare.

After a series of online events and ideation workshops, interested parties will be encouraged to make a presentation of their proposed Industry 4.0 aligned solution. Six entries will be chosen to receive up to €25,000 of funding vouchers to help create and develop a viable business solution.

2. City Centre Revitalisation

- Work is currently ongoing on a programme to improve walkways between the main shopping areas, Milk Market to Thomas Street/Catherine Street. Todds Bow is the first of these projects which has been very well received by traders and citizens alike. It has been cleaned, painted, footpath repaired, lighting improved and signage installed. It is light, clean and now appears safer for pedestrians.
- Decorative lighting has been installed in the trees on Bedford Row and Thomas Street to create a pleasant atmosphere for outdoor diners of the restaurants located in this area.

4. Strategic and Forward Planning

- The statutory preparation of the first joint Limerick City and County Development Plan commenced with the publication of a pre-draft issues and background papers on 14 August. As part of the public display documents, a virtual room has been created on the Mypoint portal. A social media campaign, as well as a direct mailing campaign, were run in an effort to inform the public.
 Comments and observations are welcomed during the public display period, which runs until 12 October 2020.
- The Forward/Strategic Planning Section prepared a Draft Supplementary Development Contribution Scheme for the development of road infrastructure at Mungret. The proposed Supplementary Scheme is being prepared to assist finance the delivery of a link road, which will connect the Local Infrastructure Housing Delivery Activation Fund Road to the R526 Regional Road. Submissions are invited on the draft scheme until 5 October 2020.

3. Local Enterprise Office (LEO)

Tech Disrupt 4.0

Local Enterprise Offices (LEOs) Limerick and Clare announced the launch of Tech Disrupt 4.0, an exciting pilot project where participants can secure up to €25,000 in funding vouchers to help create and launch solutions that align with the principles of Industry 4.0.

The Tech Disrupt 4.0 pilot project aims to encourage cutting edge technology, innovation and software development in counties Limerick and Clare. Managed by the LEOs of Limerick and Clare, the project, through a competitive structure, will support individuals and businesses that develop solutions that will deliver automation and smarter decision-making tools to manufacturers

5. Innovate Limerick

The Metropolitan District of Limerick, at its Meeting on Monday, 21 September 2020, approved a Part 8 Planning Application to build an extension on to ENGINE building, Cecil Street, Limerick. The extension, costing in the region of €2.7m, will be used as a Digital Collaboration Centre which will facilitate collaboration between multinational and indigenous companies in the Region.



September 2020 - Film in Limerick

- Innovate Limerick / Film in Limerick's new 'Writers' Factory' Screenwriting Programme received local media and online coverage and the 22-week course was full within 24 hours of its launch showing the huge demand for film and TV training in the Region. The course begins on 21 October and is supported by Limerick and Clare Education and Training Board. A waiting list has been set up at writersfactory.ie for those who wish to sign up and to hear about future courses.
- Innovate Limerick / Film in Limerick's new 'Introduction to Creative Producing Course' is now open for enrolment through fetchcourses.ie. The 20-week programme is supported by Limerick and Clare Education and Training Board and is aimed at new producers in the Mid-West looking to professionalise their practice and to develop independent production companies in the Region. Designed by Film in Limerick and Screen Skills Ireland, the programme will take place online initially and will be taught by Irish and international screen industry experts.

6. Urban Innovation Department

Living Georgian City – Urban Regeneration Development Fund (URDF)

The Living Georgian City (LGC) Programme is an historic city centre revitalisation process which tests out new models of living and new ways of engaging with citizens on the design and use of their shared spaces. It is supported by the Urban Regeneration Development Fund (URDF) 2018 and is a rolling four-year programme with an overall value of €10.5 million.

In September, the following activities were completed:

- The first draft report to develop the governance and financial structure for community-led housing (CLH) initiatives in the city centre.
- The appointment of a design team for the housing demonstration project (No. 33/34 Thomas Street and No. 58 O'Connell Street, Limerick), led by Paul Keogh Architects.

 The appointment of a Design Team for the laneway's demonstration project, led by Tobin Consulting Engineers.

Small Business Innovation Research (SBIR) Programme - Fire Safety in Historic Buildings

This project has progressed with the collection of data in a number of buildings that will be used to inform the development of a new product.

+CityxChange - City Engage Week - Theme: Renewables

The Urban Innovation Department hosted the second City Engage Week from 14-18 September 2020 on the theme of renewable energy. The City Engage series is part of the +CityxChange project funded by the European Commission through Horizon 2020. The overall aim of the project seeks to create positive energy districts and influence citizen behaviour to meet the challenge of moving to a low carbon sustainable future.

- Urban Innovation, in collaboration with +CityXChange partners, hosted a full programme of nine online webinars and workshops over the course of the week.
- Attendees got the opportunity to explore the potential and the challenges of installing renewables and creating positive energy districts in Limerick's Georgian Quarter.
- Participants mapped solar potential in the Georgian Neighbourhood, learned about the proposed tidal turbine in the Shannon and had the chance to build their own home energy monitor.
 Presenters from Ireland and Europe shared their experiences of energy generation and creating energy communities.
- 195 attended and participated in events throughout the week, taking the opportunity to learn about the project and share their vision for a low carbon future for Limerick.
- The next City Engage Week will take place in Spring 2021.



Living City Initiative (LCI) - September 2020

The Living City Initiative tax incentive has been extended to December 2022. The Urban Innovation Department holds fortnightly advice clinics in ENGINE, Upper Cecil Street, Limerick, giving multi-disciplinary advice to property owners, potential property owners and landlords who want to avail of the tax incentive for qualifying renovation works. In attendance at the clinics are the Fire Officer, Conservation Officer, Senior Architect and Town Planner.

- A dedicated campaign page was created at www.limerick.ie/photography-competition allowing entrants to submit their photographs to the competition online.

Limerick 50 Days of Summer

- Concluded eight-week multimedia national tourism marketing campaign positioning Limerick as a staycation destination.
- 38,454 users logged onto www.limerickie /50days over the duration of the campaign generating 197,889 page views.
- Digital marketing earned total paid impressions of 9,210,441.
- The campaign reached an audience of over 50,000 through local, national and international press coverage.
- Secured double-page staycation feature Limerick Fairytale in the Sunday World Magazine by travel writer and broadcaster, Suzanne Kane, following her recent visit to Limerick.

- Engaged with Tourism, Culture and Arts and Economic Development to commence work for PR and Marketing Campaign for Christmas in Limerick 2020.
- Limerick City and County Council was shortlisted as a finalist in the Sockies 2020 Social Media Awards in four categories for its marketing campaigns; Limerick – Atlantic Edge European Embrace, Virtual Riverfest Limerick 2020, Shop Limerick, and Limerick 50 Days of Summer. Physical Development Directorate

1. Travel and Transportation Strategy

The Limerick Shannon Metropolitan Area Transport Strategy was launched on 2 September 2020. The National Transport Authority document was prepared in conjunction with Limerick City and County Council, Clare County Council and Transport Infrastructure Ireland. The strategy aims to deliver a high quality, accessible, integrated and more sustainable transport network that supports the role of the Limerick-Shannon Metropolitan Area as the major growth engine of the Mid-West Region, an internationally competitive European city region and main international entry to the Atlantic Corridor.

The strategy was placed on public display on 2 September 2020 and will remain open until 30 October 2020.

A meeting of the Travel and Transportation Strategic Policy Committee (SPC) was held on 14 September to brief all 40 Elected Members and the Sectoral representatives of the SPC.

2. Environment Strategy

The European Green Leaf programme of webinars continued in September with "Let's Go Bats," a fascinating presentation by the Vincent Wildlife Trust on the lesser horseshoe bat. The presentation highlighted the importance of Limerick for the survival of this endangered species. This webinar attracted a large audience from as far afield as India (which is also home to the species).

Staff training on invasive species was held in Westfields Wetlands, as was an information day for the public on the biodiversity of the wetlands.

In celebration of Bike Week, the European Green Leaf Programme sponsored an exhibition of vintage bicycles, including a beautifully restored Penny Farthing, from the High Nellie Company in Pallasgreen. The exhibition was held in the Bank of Ireland's Work Bench on O'Connell Street.

3. Water Services

The replacement of the 300mm asbestos water main on St. Nessan's Road, Dooradoyle, with a 350mm HDPE water main was commenced by Irish Water contractors on 14 September 2020. This work is projected to finish on 18 December 2020. Approx. 1000m of water main between the Crescent Roundabout and Ballycummin Road, Limerick, will be replaced.



Community Development Directorate

1. Tourism, Culture & Arts

CULTURE AND ARTS - OPEN CALLS

Festivals and Events Grant Scheme 2020/21

Total Fund Available €245,000. The assessment panel met on Friday, 4 September. Fifty-five applications were received at a total ask of €709,387. The panel recommended the allocation of funding to 42 successful applicants totalling €245,000. These were approved at the September Meeting of Limerick City and County Council.

Tyrone Guthrie Bursaries

The Tyrone Guthrie Centre at Annaghmakerrig is a residential workplace for artist of all disciplines. In September, Limerick City and County Council announced an Open Call for three Bursaries for the Tyrone Guthrie Centre. The deadline for applications for three one-week bursaries was Wednesday, September 30. Six applications were received.

Strategic Fund

The Strategic Fund for Culture and Arts Scheme supports applications to national and international funding bodies to help leverage funding by offering a percentage of any funding awarded, in the event of a successful application. In September, eight letters of support were issued, six to Arts Council Projects Awards and two to the Arts Council Commissions Award.

Museum of Mythological Water Beasts: River Residencies

Limerick Culture and Arts Office and Ormston House, in partnership with Cavan Arts Office, Clare Arts Office and Tipperary Arts Office, are delivering the River Residencies under the Arts Council's "An Invitation to Collaboration" scheme. Applications were sought from artists who would like to meet and work with rural communities along the River Shannon in Ireland during the Spring and Summer of 2021. The Limerick River Residency will work with communities in the heritage town of Glin on the south shore of the Shannon Estuary. The residencies will be divided into two parts: two weeks dedicated to community engagement and research during Spring 2021, and two weeks dedicated to co-production and delivery during Summer 2021.

This call for submissions was open to artists working in all art forms. One artist or artist-led collective will be hosted in each rural location in Cavan, Clare, Limerick and Tipperary. The River Residencies are part of the Museum of Mythological Water Beasts, an artistic project about, along and on the River Shannon which began in 2017. The call opened on Friday 14 August and the deadline for submissions was 12 Noon on Monday 21 September. 296 submissions were received and are being processed.

CREATIVE IRELAND FUNDED PROJECTS

Emerging Limerick Filmmakers (ELF) Open Call

Emerging Limerick Filmmakers (ELF) is a new home for young filmmakers in Limerick. Applications closed for Emerging Limerick Filmmakers, aged 13 to 18 years on September 20. Based in Castletroy, ELF empowers its members with the opportunity to grow and develop as storytellers. For the first programme, ELF is undertaking four months of weekly meetings every Thursday evening.

Focus Ireland Graffiti Art Project

Focus Ireland offered their clients an opportunity to participate in a Graffiti Art project 'Vision for Hope and Change' as part of a social and creative intervention. They designed the back of an apartment building with street art, displaying messages of hope and change for the future.

The Preparation for Education, Training and Employment (PETE) project is a preventative service offering those affected by marginalisation access to mainstream education or employment.

St. Gabriel's Centre 'Sing Me To The Sea'

Sing Me To The Sea is an immersive multi-sensory water adventure for children with profound and severe disabilities. Children who participate have wide ranging diagnoses and special needs e.g. Autism, Cerebral Palsy, Learning Disabilities, Epilepsy and other genetic syndromes or neurological conditions. The programme was developed specifically with these children in mind by Ireland-based theatre director Anna Newell and composer David Goodall in collaboration with professional Healthcare specialists.



Sing Me To The Sea is a magical experience for these children. The artists are in the pool with the children and they provide a sensory interaction with each child demonstrating a high level of specialist expertise and skills.

From 21 to 25 September, this water-based artistic programme ran in St. Gabriel's hydrotherapy pool for children with the most complex disabilities and high medical needs.

Digital Skills Workshop

Commenced on 21 September, this new and unique seven-week programme is running in association with Limerick Culture and Arts Office and Creative Ireland and is facilitated by visual artist and folklorist Michael Fortune. (folklore.ie).

Aimed at Art Practitioners, Heritage Experts and Community Facilitators in Limerick City and County, this course has been offered for free through Creative Ireland funding.

CULTURE AND PLACE MAKING

Submission of Annual Arts Council Application

A Framework Agreement Report Form was submitted to the Arts Council in September. This form outlines the potential four shared strategic actions Limerick City and County Council and the Arts Council are working to deliver:

- Strategic Action One: Supporting Artists and Key Strategic Organisations
- Strategic Action Two: Rural Arts and Excellence
- Strategic Action Three: Young People, Children and Education
- Strategic Action Four: Festivals and Events

Limerick Culture Night 2020

Limerick Culture Night went digital for 2020 with a wide range of events for the public to see and interact with online. It took place mostly online this year due to COVID-19, with digital events kicking off from 3pm until late on Friday 18 September. Artists and cultural organisations in Limerick presented 30+ events and activities to showcase what they do all year round!

Culture Night is always great fun and offers the perfect opportunity for us as a region to showcase the wealth of culture that Limerick has to offer. This year was no different, despite safety restrictions and adherence to national guidelines. At the centre of the programme were two new and exciting digital commissions.

Fidget Feet, in association with King John's Castle, filmed across the city for their digital aerial film project 'Limerick: Undreamed.' Theirs is the story of finding oneself or finding that there is more to oneself than first imagined. It takes as its premise that a city and its people are not separate, that one shapes the other to the extent that it would be hard to say where the people of the city end and the city begins.

EVA International also created a new digital work for Culture Night, a three-part spoken word performance, to camera, by MuRli, God Knows, and Hazey Haze, featuring accompanying dance performance by Salma Ataya and bass by Danny Lanham. Directed by Stephen Hall (Hallway Media) and performed at each of EVA's key venues (Limerick City Gallery of Art, Hunt Museum, The Sailor's Home). The performance was released on Culture Night to officially launch the 39th EVA International Edition. Other events on the night included:

- Digital tour of Limerick Museum
- Screening and workshop for young filmmakers from Fresh Film
- Live music from Emma Langford as she launches her new Album Sowing Acorns
- Digital Exhibition from South and Proud in association with The Gaff from Tait House
- Behind the scenes look at St. John's Brass and Reed Band
- Online workshop on how to track your home energy usage from +City Xchange
- Dance Limerick presented a live performance of Bloodlines by John Scott at their space in John's Square, Limerick. Seating was strictly limited and tickets were booked through Dance Limerick.



The County Limerick Youth Theatre

Programmed workshops began in adherence to COVID-19 restrictions.

The Integrated Dance Programme

The Integrated Dance Programme is delivered by Mary Hartney. Workshops were suspended in March due to COVID-19. Due to COVID-19, Transition Years cannot participate in the programme and the focus is on providing Dance to Service users, with professional dancers. Workshops began with Brothers of Charity in Newcastle West and Enable Ireland, Castleconnell.

Artists in Schools

In response to COVID-19, the Artists in Schools Programme for 2020/21 has been re-modelled, working in partnership with Music Generation Limerick City, who have developed an innovative LiveStream Model, in response to COVID-19. This is a once-off approach to deliver a high quality programme to children in schools, when the traditional model of artists in schools is not feasible. This programme has been offered to all 26 National Schools in the Newcastle West Municipal District, to engage children and young people in rural county Limerick.

The Sliabh Luachra Residency

This was initiated through the Invitation to Collaboration Scheme, led by Cork County Arts Office and in partnership with Kerry County Arts Office. The purpose of the project is to promote the musical heritage of Sliabh Luachra, build capacity among local organisations for artistic growth, developing supporting partnerships and sustain and develop local social and cultural networks, preserve and make available musical artefacts and support cultural and creative tourism to the region. Musician, Eoin O'Sullivan, has been appointed Musician in Residence for 2020/2021.

Professional Development-Music Network Music Capital Scheme 2020

The Music Capital Scheme is a fund to provide support for the purchase of instruments and related items. In association with the Music Capital Scheme, Music Network, in partnership with Limerick Culture and Arts Office, hosted a seminar for Limerick based non-professional performing groups on 17 September.

The seminar featured three expert speakers on the topics of governance (Sheila Cahill), strategic and artistic planning (Liz Doherty), and creating recordings (Mairéad O'Reilly). For 2020, high quality Music Capital Scheme applications from non-professional performing groups in Leitrim, Limerick and Monaghan will be prioritised for funding support. In addition, funding has been allocated for the delivery of special supports to music groups in these counties.

LIMERICK CITY GALLERY OF ART (LCGA)

- The Limerick Connections exhibition closed on 6
 September after a seven-week run. The exhibition celebrated the work of 67 artists who are included in the Permanent Collection with associations with Limerick. It was a resounding success with over 5,000 visitors seeing the exhibition.
- Since re-opening, we have used the Permanent Collection extensively including the above works and paintings that were included in the First Exhibition in 1938 and works from two limited editions, again featuring Limerick artists.
- LCGA worked with Limerick and Clare Education and Training Board to host an exhibition of young people from Rathkeale and also a hip-hop workshop.

- The opening of the 39th edition of EVA International took place on 18 September to coincide with Culture Night.
- LCGA has commenced a project with LIT Limerick School of Art and Design (LSAD) on a project that will connect the People's Park and the Gallery, titled Park Life. It will run, on a weekly basis, throughout EVA International.
- LCGA worked with LIT LSAD to develop a project based on the Michael O'Connor poster exhibition.
- LCGA hosted a meeting with University of the Third Age.
- Interviews have taken place through September to recruit Gallery Assistants through the Community Employment Scheme.
- Building maintenance work was carried out on the exterior of the building.





 Road and Footpath Reconstruction Rylanes to the Grotto

Footpath work is completed in Rylanes. New kerbing has been installed to the church. Pavement repairs in advance of overlay now underway.

Footpath Link to Playground

An application has been made under the Town and Village Renewal Scheme to connect the playground to the town centre.

Shanagolden

• Shanagolden Junction Improvement Works

Final design has now been completed. An additional €80,000 has been secured for this project (from Active Travel) to include for footpath links on the Foynes Road and to the Community Centre.

Municipal District of Cappamore-Kilmallock

- The processing of applications under the Pilot Home Improvement Scheme for Tenants of Social Housing was completed during the month. In total, 53 tenants from across the Municipal District were approved grants to do various refurbishments on their Council properties, entailing an overall budget of €100,000 for the Municipal District. It is expected that these works will be completed by contractors, and grants claimed by tenants, before the end of 2020.
- The construction of 20 social housing units at Glenview Drive, Hospital, continues with Griffin Brothers Contracting Ltd. as the main contractor on site.
- The 2020 Roadworks Programme for the Municipal District continues across the Municipal District with the intention of fully completing it before the end of 2020.



Municipal District of Newcastle West

- The 2020 Roadworks Programme for the District, which was delayed due to COVID-19 restrictions, is now complete with Local Improvement Schemes projects almost 90% completed.
- The Newcastle West District Office has sent over 400 reminders to landowners/occupiers during the month of September to cut back hedges where necessary. Under the Roads Act 1993, landowners and occupiers of land are obliged to take all reasonable care to ensure that trees, hedges, ditches and other vegetation growing on their land are not, or could not, become a danger to people using or working on a public road. As such, the onus is on landowners/occupiers to keep their hedges cut. The Wildlife Act, 1976, prohibits hedge cutting between 1 March 31 August but landowners/occupiers can cut hedges from 1 September to 28 February.
- The District received funding of €726,954 for Housing Adaptation Grants for Older People and People with a Disability in Private Homes.

- A total of €420,000 was allocated under a number of different measures as part of the Government's Stimulus Package with confirmation of the amount of funding received confirmed. The sum of €250,000 was allocated towards footpaths in Churchtown, Newcastle West, and €60,000 towards footpaths in Dromcollogher as part of the Active Travel allocation. Under the Climate Action allocation, €60,000 was allocated towards drainage design works at The Hill, Abbeyfeale, and the Grove, Abbeyfeale. The design of proposed cycle lanes at Lacey's Cross on the N21 to the junction with St. Ita's and onwards towards Churchtown, Newcastle West, is also included in the funding received.
- During the month of September, 887 transactions were processed by the Newcastle West Motor Tax Section.

3. Digital Services and EU Programmes

Digital Services

- Digital Services attended a virtual meeting of the All Ireland Smart Cities Forum. In addition to its recurring agenda items, the focus of this meeting was a presentation on United Nations - United for Smart and Sustainable Cities Key Performance Indicators (U4SSC KPIs), as part of a collaboration on supporting local authorities in Norway, Ireland and EU to achieve the UN SDGs.
- Digital Services and ICT successfully concluded a procurement process to identify a supplier to design and implement a network of 40 additional public WiFi access points across Limerick City and County before the end of 2020, under the EU's WiFi4EU initiative. This deployment of additional public Wi-Fi services will be important both to attract tourists, investors and a talented workforce, as well as to minimise digital exclusion and complement the public services already provided in those locations.
- **EU Programmes**
- Three Horizon 2020 Proposals were submitted in which Limerick City and County Council is partnering. They are:
 - SEEDING: Sustainable Energy Examined and Demonstrated, Inspiring New Governance, led by Trinity College Dublin.
 - TENURE: Next Generation of Public Energy Governance, as part of the call supporting public authorities in driving the energy transition, led by University College Dublin.
 - SARGON: Smart management of retrofit for energy efficient multi-resources buildings, in cooperation with LightSource Labs (University of Limerick) and led by The Engineering Group Italy.

- Corina Hanrahan presented the Urbact III Project Find Your Greatness at the Digital Leaders' Network on 4 September. The Urbact Local Group on this project will work closely with the Digital Leaders' Network to formulate the next brand strategy for Smart Limerick. This was followed up at an online Project Steering meeting with International partners on 16 September.
- Corina Hanrahan and Anne Goggin (Limerick City and County Council), and Helen Fitzgerald (Paul Partnership) took part in the online Urbact University to learn techniques for engagement and co-creation activities with local stakeholders.
- On Wednesday, 30 September, Terry Connolly and Rory Corbett (Economic Development) took part in a site visit to CONFIRM, Science Foundation Ireland's research centre in Smart Manufacturing based in University Limerick, with the aim of finding synergies between the Centre and the Council in relation to Advanced Urban Manufacturing.


No of days in overdraft

The Register of Electors Team in Corporate Services is preparing for the Draft Register 2021/2022 which will be published in November 2020.

Information to update the Register is sourced from the following:

- New Applications submitted through An Post or via email.
- Change of Address Applications.
- Forms received from other Local Authorities for addition and deletion.
- Information submitted by An Post and the County Registrar following the General Election.

Over 1,800 entries have been processed to date and the Register will continue to be updated.

Advertisements have been placed in local newspapers advising those entitled to Postal Votes i.e. those unable to attend Polling Stations due to Physical Illness or Disability, Occupation or Students and those resident in Nursing Homes, to apply to be included in the Postal Listings 2021/2022 before 25 November, 2020.

Application forms have also been distributed via An Post to all those on the 2020/2021 Postal Lists.



Health and Safety Training

The Health and Safety Training Unit continues to organise training courses for staff.

- Safe Pass Training: Is being provided to staff
 whose training has expired, or is due to expire, and
 those who do not have a Safe Pass. A total of five
 staff members have been trained during the
 month of September.
- Manual Handling: Courses have commenced and a total number of 15 staff members have been trained during the month of September.
- CPC Training: Has taken place and a total number of eight staff members have been trained during the month of September.
- First Aid Response and First Aid Refresher: A total number of six staff members have been trained during month of September.
- COVID-19 Induction Toolbox Talks: A further 21 staff members, both indoor and outdoor, have been trained during September.

- The logging of cases through the MyLimerick portal continued and increased, with a total of 348 cases being logged in September, 329 of which were logged by Public Representatives.
- Customer Services also continued advising tenants making housing maintenance requests of the current procedures during the pandemic. A total of 1,173 cases were logged for Housing Maintenance, 862 of which were logged by Customer Services.
- Customer Services continued to provide other frontline services to the general public, such as the processing of Residential Parking Permits. There was a total of 94 new Residential Parking Permits processed.
- The public counters in both Merchant's Quay and Dooradoyle saw a combined footfall of 2,460.
- The Customer Services Team also attended 'Refresher Training' sessions. The training covered a variety of topics, ensuring that the Customer Services Team is up to date on Standard Operating Procedures for the various services under its remit.
- Customer Services also assisted the Housing Support Services Team as part of the Social Housing Assessments (SSHA) 2020, taking calls and updating the iHouse system as appropriate.

Customer Services

Customer Services continued their frontline duties, to all, through our various points of contact. The following figures highlight the activity within the Contact Centre throughout September:

- Customer Services Call Centre dealt with 12,674 calls, an average of 576 per day. 52% of these calls were handled at the first point of contact.
- Customer Services Cases Management Team continued working with key service areas of the Council in supporting closure and update of representations from Elected Members.
- 3,202 cases were created, with 903 of these logged on behalf of Public Representatives, as well as the closure of 3,104 cases, 863 of these being cases logged by Public Representatives.
- A total of 2,187 emails were processed through the Customer Services mailbox.

5. Business Improvement

- The Business Improvement Department launched two staff surveys in September.
