TC Banogue – Councillor John O'Donoghue requested the Lane widths for Banogue when the TC is complete

The carriageway width on the N20 Banogue Traffic Calming Scheme is a minimum 6.5m (3.25m lane widths) as set out in the Part VIII Particulars for the traffic calming scheme.

Adare – Councillor Bridie Collins requested if remedial works could be done with a view to installing footpaths this year at Murphys Cross to the Traffic Lights in Adare

The local area office are looking at an option for a temporary footpath to be installed in the interim until the N21 Adare Western Approach Scheme can commence.
