The Council further agrees to write to the Minister for Housing, Local Government and Heritage urging a removal of that provision and to ensure that Elected Councillors retain the right to control such sales or transfers and be able to prepare and plan for appropriate housing delivery on Council-owned lands.

The Council further agrees to circulate this Motion to each Local Authority, the Association of Irish Local Government and the Oireachtas Members for Limerick requesting their support for this."

I refer to your correspondence of 16 April in relation to the Land Development Agency Bill, which will place the Land Development Agency (LDA) on a statutory basis as a State agency, and the queries you have raised.

The purpose of the LDA is to increase the supply of housing in the State, and in particular affordable housing, by developing and regenerating relevant public lands for the development of housing. It has two central goals to build affordable homes on relevant public lands and strategic land management. It is being set up to make the most of all relevant public lands in order to tackle the housing crisis. Relevant public lands are lands in a census town with a population of over 10,000 that is owned by a relevant public body listed in Schedule 1 or 2 of the LDA Bill, or a local authority.

The LDA has a core remit of providing affordable homes at scale in sustainable communities based on best environmental practise across under used or unused relevant public lands. Every tool needs to be used in addressing the housing crisis and relevant public lands can play an important role in providing homes for cost rental or affordable purchase in our towns and cities. In the long run the LDA will also help to strategically manage land by assembling sites in key areas.

In relation to your query concerning reserved functions under Section 183 of the Local Government Act, the matters contained in Section 56 of the Bill would only arise where the local authority has decided to put lands up for sale and must give the LDA 'first refusal' to purchase the lands under Section 51(1). This is consistent with the arrangements under Part 7 of the LDA Bill requiring all public bodies, who have decided to dispose of lands, to offer them first for sale to the LDA. In this situation, Section 183 of the Local Government Act will not apply to avoid duplicator decision making processes arising which could delay the delivery of homes on these lands. It should be emphasised that the LDA legislation has no provisions compelling local authorities to sell their land to the LDA or any other third party. The initial decision to



sell land remains with the local authority. Furthermore under Section 55 of the LDA Bill, the LDA requires the consent of the Minister for Housing for any proposed land sales by the agency itself. Section 183 of the Local Government Act will remain in force for local authority land disposals to all other parties.

Under Section 14 of the LDA Bill a local authority can direct the LDA to provide services to it in relation to the development of large scale sites for housing and urban development in population centres of 30,000 or more. These sites will predominantly remain in local authority ownership post development. It is envisaged that the majority of the LDA's work on local authority lands will be in such co-operative arrangements with the LDA as an additional resource to assist local authorities in housing delivery. The primary responsibility of local authorities as housing authorities to deliver housing will not be impacted by the LDA Bill.

I hope the above clarifies matters.

At the April meeting of Clare County Council the members passed the following resolution:

"That Clare County Council ask the HSE and the "Connecting for Life" initiative to pilot a Community Psychiatric Car service in the County. This has been successfully piloted by the NHS in London. The Mental Health Joint Response Car (MHJRC) involves having a Community Psychiatric Nurse and Emergency Medical Technician on call 24/7. The rationale is that people in mental health crises in the community do not often require admission to hospital, rather to address their issues with trained personnel in their own homes. Equally the qualified personnel can also make the call if actual hospital admission is warranted. To date. evaluation of the pilot has proven successful in the UK and a further 7 cars are now in operation.

Currently, Goal four of Connecting for Life, Ireland's national strategy to reduce suicide 2015-2020, aims to enhance accessibility, consistency and care pathways of services for people vulnerable to suicidal behaviour. This motion seeks to enact this in real time in our communities. I also ask for the motion to be circulated to every local authority."



I refer to your recent correspondence addressed to Charlie McConalogue T.D., Minister for Agriculture Food and the Marine in relation to the appointment of an Independent Meat Regulator.

As are aware, there is a commitment in the Programme for Government to the establishment of a new authority called the National Food Ombudsman (NFO) to enforce the Unfair Trading Practices Directive. The NFO, whose remit will include the beef sector, will have a specific role in analysing and reporting on price and market data in Ireland. It is important to be aware, however, that the Ombudsman will not have a role in determining prices for beef or any other commodity. The Minister has no plans to establish a separate regulator for the meat sector as this function will be performed by the NFO.

Establishment of the NFO is ongoing and firstly requires the drafting of a statutory instrument to transpose the UTP directive before the deadline of May 2021. Legislation is then required to establish the new office of the NFO. It is intended that there will be a national consultation process on the functions of the NFO prior to the primary legislation being enacted.

With regard to the work of the Beef Taskforce on transparency; the completion of the three market transparency studies commissioned by the Department will be an important step towards improving visibility of the complex supply chain which is integral in fostering trust and enhancing supply chain relationships. These studies will act as an important starting point for driving increased transparency. It is more important than ever that we all work together given the unique set of challenges currently faced by the sector. Continued strong and constructive engagement in the Beef Taskforce is key to meeting these challenges.

I refer to your correspondence requesting to have the remains of Joe Brady, Daniel Curley, Michael Fagan, Thomas Caffrey and Tim Kelly, sensitively disinterred and reinterred at Glasnevin cemetery with the appropriate decorum.

The Office of Public Works is aware of the current campaign led by the National Graves Association to exhume and reinter the five people known as the Invincibles in Glasnevin Cemetery. Requests such as this are of a very sensitive and delicate nature and there are a number of matters to consider, both in terms of the significant practicalities involved and the ethical issues. While the general area of the site of the graves in Kilmainham is relatively well known, there is no detailed plan showing definitively exactly where individuals were interred and even were it to be precisely located, there would be practical issues involved in positively identifying the remains. It is understood from contemporaneous accounts that after execution, the remains were buried in quicklime and this would render an exhumation and positive identification very difficult, if not impossible.

Kilmainham Gaol is a National Monument and an iconic and much respected site in the context of the national independence struggle in particular. The fact that it is also a grave location adds a significant resonance to its penal and historical significance and there is a strong opposing view to the current campaign that believes that the grave should not be disturbed and the remains should be left within the confines of the Monument.

The Rebuilding Ireland Home Loan is a Government-backed mortgage for first-time buyers and has been made available nationwide from local authorities from 1 February 2018. The loan can be used to purchase both new and second-hand properties, or to build a home. It does not cover renovations.

The final decision on loan approval is a matter for each local authority and its Credit Committee on a case-by-case basis. Decisions on all housing loan applications must be made in accordance with the statutory credit policy that underpins the scheme, in order to ensure consistency of treatment for all applicants.

The new Programme for Government "Our Shared Future" contains a commitment to expand the Rebuilding Home Loan.

Re: Motion - Protection of Native Honeybees

At its meeting held on 4 May 2021, Fermanagh and Omagh District Council resolved that details of a Motion which it adopted at its April Council meeting, should be circulated to all Councils across the island of Ireland.

"Given Fermanagh & Omagh District Council's commitment to the All-Ireland Pollinator Scheme, and noting previous Council decisions taken in relation to reducing the use of harmful pesticides, reducing grass and hedge cutting and encouraging protection and promotion of natural habitats for our bee population, this Council calls on the British Government, and on the relevant Stormont & Dáil Ministers, to oppose the importation of Italian honeybees onto this island, and to move to completely ban such actions in future.

The recently publicised move by a Kent bee keeper to avoid the import ban by importing 15 million Italian bees into Britain, via the island of Ireland, poses a serious potential threat to thousands of hives, to our native bee population and to its future viability.

The Ulster Beekeepers Association and Low Country Native Irish Honeybee Association have expressed serious concern in relation to the small hive beetle and to the potential threat posed to native black Irish honeybees (which academic studies have established as the "best gene of black bees in Europe"). These worries have been echoed by beekeepers in Britain.

Mindful of such risks, FODC calls on the British & Irish Government, as well as on the relevant Ministers in Stormont, Dáil Éireann & Westminster, to stop the import of Italian bees into Britain via the North of Ireland, as well as onto the island of Ireland, North and South, with or without the intent of forward exportation".

The Council trusts you will support the Motion and the actions detailed therein.
