Update from Innovate Limerick.

The Head of the Local Enterprise Office outlined to Members that in 2014, Limerick City and County Council became the first local authority to establish a special purpose innovation company. Innovate Limerick was established to help drive innovation and act as the delivery mechanism for the projects outlined in the Limerick 2030 Plan, the Limerick Regeneration Implementation Plans, the Mid West Action Plan for Jobs and others.

Innovate Limerick is a designated activity company whose Board and Advisory Board is comprised of four Elected Members, the Director of Economic Development, Limerick City and County Council, Semi-State Bodies, Third Level Institutions and Entrepreneurs. The Board is currently chaired by Mr. John Gleeson, Transact Campus, and has three sub-committees Film, LDIF and SME Taskforce.

He gave a PowerPoint presentation updating the Members in relation to the following:

The Director, Support Services, referred to the significant support to the Local Government Sector. He also acknowledged the efforts and support of Council Members and the commitment of staff.

The report stated that the Annual Report 2020 had been prepared in accordance with the requirements of Section 221 of the Local Government Act, 2001, as amended, and set out details of the policies, programmes, services and other activities undertaken by the Council. It also included the Financial Statements for 2020 and an outline of activities to promote the interests of the local communities and twinning. As required under Section 134 (11) of the Local Government Act, 2001, as amended, an Annual Progress Report in respect of the Council's Corporate Plan was attached as an Appendix.

The Chief Executive confirmed to Members that the inclusion of an area in a regeneration programme was subject to specified criteria. He agreed to review the criteria and revert to Members.

Recommendation 1:

"That, Limerick City and County Council recommend that Annacotty Weir be adapted to improve fish migration."

The Recommendation, as amended, was agreed.

The Director, Physical Development, acknowledged that, since the April Meeting of the Climate Action, Biodiversity and Environment Strategic Policy Committee, Mr. Eamon Ryan, TD, Minister with responsibility for Inland fisheries, had announced that Inland Fisheries Ireland (IFI) would lead an Annacotty Weir Fish Passage Improvement Project, and that IFI would progress this project in collaboration with various state agencies and key stakeholders through the multiple phases involved in the improvement of fish passage at the Weir.

Councillor Secas wished for it to be noted that a Motion on this topic submitted by her for a Meeting of the Metropolitan District was withdrawn as a result of this matter being discussed at the Climate Action, Biodiversity and Environment Strategic Policy Committee, and subsequent referral as a Recommendation to the Full Council. She welcomed Minister Ryan's recent announcement.

- (ii) Circulated, Report of the Chairperson of the Community, Leisure and Culture Strategic Policy Committee dated 10th May, 2021, in relation to Meeting of the Committee held on 19th April, 2021, together with Draft Burial Ground and Interment Strategy.

Recommendation:

"That the Draft Burial Ground and Interment Strategy be approved by Full Council."

6. Community Development

(a) Grants under the Arts Act

Circulated, report of the Arts Officer dated 13th May, 2021, seeking the Council's approval to recommended grants, as set out in the report, under the Arts Act, 2003.

And Resolved:

"That, the approval of the Council be and is hereby given to the payment of grants under the Arts Act, 2003, as recommended, and as set out in the report of the Arts Officer dated 13th May, 2021."

(b) Working Capital Loan – EI Travel Group/Lazy Bike Tours - Limerick Greenway

Circulated, report signed jointly by the Deputy Chief Executive and Director of Support Services, and the Director of Community Development, dated 17th May, 2021, seeking the Council's approval to a working capital loan of €300,000 to EI Travel Group/Lazy Bike Tours to assist in the provision of bike hire and shuttle bus service on the Limerick Greenway at Limerick City and County Council owned properties.

Members welcomed the reopening of the Limerick Greenway and the importance of such amenities for locals and tourists. Members referred to the importance of supporting local business and queried the Working Capital Loan required to establish a business following an Expressions of Interest process for a bike hire/shuttle service.

The Director, Community Development, informed Members that an Expression of Interest process to attract an operator of scale had been completed. He informed Members that extensive research had been undertaken on the services required to attract tourists to the Limerick Greenway. He confirmed that the Bike Hire Service was requesting a Working Capital Loan to establish their business and that the loan, if fully drawn down, was repayable.

Following further discussion, Members emphasised the importance of retaining local business and creating employment opportunities for local people.

The Director, Community Development, confirmed that no operator would be precluded from operating on the Greenway. He also confirmed that an extensive marketing and promotional campaign would be undertaken to ensure that the Greenway was promoted locally and nationally.

It was proposed by Councillor O'Hanlon, and seconded by Councillor Sheahan (J), that the Council approve the working capital loan of €300,000 to EI Travel Group/Lazy Bike Tours to assist in the provision of bike hire and shuttle bus service on the Limerick Greenway at Limerick City and County Council owned properties.

Councillor Scanlan proposed that the Council not approve the loan and this was seconded by Councillor E. Ryan.

REPLY: To help strengthen and consolidate the settlement structure and reverse the decline in Limerick's towns and villages, the proposed Draft Development Plan 2022-2028 supports the development of Serviced Sites within settlements served by individual wastewater treatment systems. This type of development offers an alternative to the single one-off rural house.

9. Question submitted by Councillor L. Galvin

I will ask at the next Meeting for (a) a full report from Irish Water on the capacity of all the sewerage treatment plants in Co. Limerick; and (b) for a detailed programme of work for all sewerage treatment plants in Co. Limerick.

REPLY: Please find below the capacity status of Irish Water wastewater treatment plants in Limerick. Irish Water has advised that an updated wastewater treatment capacity register will be issued to Limerick City and County Council once finalised in the coming months.

REPLY: Shall the Elected Members of Limerick City and County Council require legal advice on a particular issue in relation to the proposed Limerick Development Plan 2022-2028, the Council will seek such advice from the Council's Legal Advisors.

12. Question submitted by Councillor C. Sheehan

I will ask at the next Meeting of Limerick City and County Council for the Council to outline what engagements the Council have had with Ó Cualann Cohousing Alliance in relation to affordable housing and whether the Council intends to dispose of land to Ó Cualann Cohousing Alliance for affordable housing in the near future.

REPLY: The Housing Development Directorate has consulted with Ó Cualann Cohousing Alliance, an Approved Housing Body, to understand their model of delivering affordable housing with Dublin City Council. Any proposal by Limerick City and County Council to activate Local Authority lands for affordable housing with Approved Housing Bodies needs to go through a transparent and open Expression of Interest process with qualifying criteria for assessment, as was recently undertaken by the Directorate for a number of landbanks in the city.

13. Question submitted by Councillor C. Sheehan

I will ask at the next Meeting of Limerick City and County Council for the Council to outline what if any arrangements it has in place in relation to long term leasing from private developers in relation to social housing and the cost of any such arrangements.

REPLY: Leasing arrangements are delivered under the Social Housing Current Expenditure Programme (SHCEP). It provides for the leasing of suitable properties by Limerick City and County Council for periods of between 5 to 25 years under the following schemes: (a) Long Term Leasing; and (b) Repair and Lease.

An independent valuation of the market rental is sought for each supported property and Limerick City and County Council agrees this market rent with the property owner, which is then discounted by 15%/20%. If a property owner is availing of the Repair and Lease Scheme, any loan advanced will be offset against the discounted market rent agreed. Limerick City and County Council will agree with the property owner on a case-by-case basis what the appropriate offset period will be. Monies paid to property owners under leasing arrangements are recoupable from the Department of Housing, Local Government and Heritage under the Social Housing Current Expenditure Programme.
