1. To elect a Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been elected.

The outgoing Cathaoirleach, Councillor Egan invited nominations for the Office of Cathaoirleach for the coming year.

Proposed by Councillor Donegan;
Seconded by Councillor Mitchell;

“That Councillor Martin Ryan be appointed Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been appointed”.

As there were no other nominations, the outgoing Cathaoirleach declared Councillor Ryan (Martin) elected as Cathaoirleach of the Municipal District of Cappamore-Kilmallock and offered him best wishes for the coming year.

The outgoing Cathaoirleach, Councillor Egan thanked the Director, Support Services-Finance, Corporate, HR & ICT, (Mr S.Coughlan) and the staff of the Area Office for all their courtesy, help and support during his term as Chairman of the Cappamore - Kilmallock District.

“That Councillor Michael Donegan be appointed Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been appointed”.

As there were no other nominations, the Cathaoirleach declared Councillor Donegan was elected as Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock and wished him well for the forth coming year.

Councillors Donegan expressed his thanks at his nomination and election and looked forward to working with his fellow Councillors in the year ahead.
