Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2021

Limerick City and County Council in exercise of the powers conferred on it by Section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), hereby makes the following Bye-Laws in respect of the area comprising the administrative area of the County of Limerick.

The maps annexed to these Bye-Laws are for illustrative purposes only and in the event of a conflict between the maps and the text of the Schedule hereto, the text of the Schedule shall take precedence.

- These Bye-Laws may be cited as the Limerick City and County Council Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2021.
- 2. These Bye-Laws shall come into operation on the 30th day of November, 2021.
- 3. In these Bye-Laws:

"the Act of 2004" means the Road Traffic Act, 2004 (No. 44 of 2004);

"local road" has the meaning assigned to it by the Act of 1993;

"regional road" has the meaning assigned to it by the Act of 1993;

"road" means a public road and includes a motorway.

4. The provisions of the Limerick City & County Council County Limerick Road Traffic Special Speed Limit Bye-Laws 2019 for National, Regional & Local Roads, insofar as they apply to any of the roads or part thereof referred to in the below text of these Bye-Laws are hereby amended insofar as they relate to the said roads or part thereof with effect from the date on which these Bye-Laws come into effect.

The following roads at Abbeyfeale:
