#### Footnotes:-

- 1. Occupied Territories: a territory which is occupied within the meaning of the 4th Geneva convention and confirmed as such by the International Court of Justice, International Criminal court or International Tribunal.
- 2. Illegal Settlers: a member of the civilian population of an occupying power whose presence within the relevant occupied territory is being facilitated by the occupying power<sup>3</sup>.
- 3. Occupying Power: as defined by fourth Geneva convention."



## Water Services-Seanad Tuesday 6th July

## Senator Robbie Gallagher

Cuirim failte roimh an Aire Stait go dtí an Teach inniu. I welcome the Minister of State to the House and thank him for taking time out of his busy schedule to be here. I wish to discuss Irish Water and the service level agreement with local authority staff. I am not, and never was, a fan of Irish Water in the first instance. I fail to see the purpose of setting up another layer of bureaucracy - some would refer to it as a quango - which currently has 800 staff on its books. Local authorities continue to provide an excellent service to the people of this country in terms of water services.

Local authorities have a service level agreement with Irish Water in that the latter has tasked local authorities with providing water services to the people of this country. They are doing an excellent job. Irish Water has what it calls a balanced scorecard for each local authority, which rates each one on key performance indicators. In layman's language, it rates the service provided by local authority water services staff to the general public. I am delighted, but not surprised, to note that each local authority is performing excellently, as I am sure the Minister of State is aware. The percentage levels of performance are in the high 90s consistently year on year. In Monaghan and Cavan the levels are consistently above 90% and I thank local authority water services staff for the excellent job they do. Given such high levels of service, the question arises as to why we are taking the service away from the water services sections of local authorities and not keeping it where it is. Perhaps that is a question to which the Minister of State might relate.

Public ownership of Irish Water is the clear will of the Irish people. People want control of this utility into the future. There is a commitment in the programme for Government that Irish Water will remain in public ownership, but many are calling for a referendum to be put to the people in order that this can be enshrined in the Constitution for eternity. I support that call. Has the Government committed to holding a referendum? If so, does it have a date in mind?

Another issue I would like to raise is the fact that many local authority staff are quite happy to stay where they are. The 3,500 workers who are providing an excellent service want to stay with their local authority, and I fully agree with and support them in that notion. I understand talks are ongoing between the Government, Irish Water, local authorities and trade unions. We do not want local authority staff, who are doing an excellent job, to be forced down a road they do not want to go.

It is important that we take their concerns on board.

I respectfully appeal to the Minister of State to answer the two questions I have posed. I would like to think that local authority staff, who provide an excellent service, will be looked after and that their wishes will be respected.

# Minister of State at the Department of Housing, Local Government and Heritage (Deputy Malcolm Noonan)

Gabhaim buíochas leis an Seanadóir as an gceist seo a ardú. The Government published a policy paper, Irish Water - Towards a National Publicly-Owned Regulated Water Services Utility, in February which sets out its views and expectations on the next phase of transformation in the water sector. This will involve the integration of the public water system within the organisational structure of Irish Water. This will complete the broad policy and legislative reforms that have seen public water services embark on a journey of transformation from a structure based on locally organised water services authorities towards a single, national water utility in public ownership. In setting out its views and expectations on the next phase of the water sector transformation programme in this way, the Government is enabling stakeholders to engage in a meaningful change process that will give them the strongest possible say in determining their future working arrangements.

Significant issues relating to the workforce remain to be addressed in the context of integrating the day-to-day operation and delivery of water services within Irish Water. To resolve these issues, my colleague, the Minister for Housing, Local Government and Heritage, Deputy Darragh O'Brien, has tasked the Workplace Relations Commission to recommence engagement on water sector transformation with all parties aimed at reaching a collective agreement on a framework for the future delivery of water services. This engagement is currently under way, although the inability to hold face-to-face discussions due to the Covid-19 restrictions has hampered the process. I imagine the Senator will appreciate that is a challenge and it is important that these discussions can take place face to face as that is the best way forward. I understand, however, that the discussions will take place in the coming weeks in line with the current relaxation of restrictions.

Change is difficult for any workforce and I am fully aware that many in local government services do not necessarily wish to see changes to the current arrangements, as the Senator has outlined. However, the fact that the Government has decided that Irish Water is to become a fully integrated direct labour national public utility means the *status quo* is not an option. Continued uncertainty about the future does a disservice to everyone currently employed in water services within local authorities. It is important, therefore, that the parties to the transformation process engage intensively in the coming weeks at the Workplace Relations Commission to agree an outcome that will deliver for all parties and for the greater good. The Government believes it will be possible to reach a collective agreement that addresses the interests and concerns of all parties.

Senator Gallagher raised a second matter. It is certainly is the case that there is a commitment in the programme for Government to refer the issue of the environment, including water and its place in the Constitution, to the relevant joint committee for consideration, namely, the Joint Committee on Housing, Local Government and Heritage. My role includes responsibility for electoral reform. We have a schedule of proposed referenda throughout the lifetime of this Government. It is not my intention, and I do I believe it would be appropriate, to hold a number of referenda on the same day. I believe it is important that we hold a standalone referendum on this issue as to do otherwise would dilute the message - excuse the punand dilute what we are trying to achieve with this referendum. In any event, , I am keen to give the assurance that this referendum is significant and important in assuring the people on

the issue of ownership of water infrastructure in public hands for the common good. It is important to emphasise that. The policy paper on water transformation agreed by Government further commits the Department of Housing, Local Government and Heritage to consult with the Irish Congress of Trade Unions' local authority group of unions in respect of the proposed referendum. I hope that offers some assurance to the Senator on the questions posed and to the utility workers currently within local government around the transformation process.

The process is in place for the common good of all. We hope it will lead to a robust and transformative process around regulation and the provision of critical water infrastructure for the country for nature, for biodiversity and for communities.

## Senator Robbie Gallagher

My thanks to the Minister of State for his comprehensive reply. As he outlined, the uncertainty for local authority staff and water services staff is disappointing. They find themselves in a stressful situation.

I welcome the commitment of the Minister of State to hold a referendum and I look forward to an early date for that. The old adage holds that if it is not broken, we should not fix it. That springs to mind in the context of water services provided by local authorities. Having said that, as long as the views of staff are respected and as long as they are happy - ultimately, with the terms and conditions put in front of them - then I fully support them. The service they have provided to the public, to me as a public representative and to many others has

been top class and I am keen to acknowledge the excellent service we get from them. I hope that will be respected by decision makers when a final call is made.

## **Deputy Malcolm Noonan**

I wish to reassure the Senator on the matter. I wholeheartedly concur with his comments in respect of water services staff and local authorities. They provide an exceptional level of service to communities. They are constantly on call winter and summer, as well as during emergencies throughout the year. We must and do give due regard to that wonderful level of service. We want to achieve a transition towards Irish Water with which they will be happy and such that they will be satisfied that they are being taken care of.

The issue of the referendum is critical as well. I want to give an assurance that the process with the Workplace Relations Commission is inclusive. We want to ensure that all parties are brought on board to create the transformation that we all require for the country to move forward.

On behalf of the Minister for Foreign Affairs and Minister for Defence, Mr. Simon Coveney T.D., I wish to thank you for your letter of 17 June 2021 concerning Limerick City and County Council's Motion on the development of links with an African country.

Africa is the world's youngest continent, with a growing population and vibrant economies. The Government attaches great importance to deepening Ireland's partnerships with Africa and has set out a framework to deepen and expand Ireland's footprint in Africa over the coming years.

Ireland has a long history of engagement in Africa. In 2020, we marked sixty years of a diplomatic presence on the continent, which has now grown to 12 Embassies from Egypt to South Africa. This year, Ireland will open an Embassy in Morocco, with two further new Embassies to follow in francophone West Africa by 2025.

The Government's Strategy for Africa, 'Global Ireland: Ireland's Strategy for Africa, 2019-2025', was launched in November 2019 and builds on Ireland's long history of engagement with Africa. It includes all countries on the continent in a single strategic approach engaging political, economic, cultural and development relations with Africa, placing partnership at the heart of Ireland's engagement with the continent.

For almost fifty years, Ireland has supported sustainable development in Africa. Today Ireland operates international development programmes in twelve African countries, working in close partnership with governments, international partners and civil society organisations to support the furthest behind first (in Ethiopia, Kenya, Liberia, Malawi, Mozambique, Nigeria, Sierra Leone, South Africa, Tanzania, Uganda, Zambia, Zimbabwe). Our development cooperation in Africa is guided by the priorities set out in the Government's international development policy, 'A Better World: prioritising gender equality, reducing humanitarian need, climate action and strengthening governance. Ireland is working closely with African partners to support their response to the COVID pandemic, as part of €100 million being provided to support global public health in 2021.

The deep and wide-ranging partnerships between Ireland and African countries across the continent may provide a suitable avenue for Limerick City and County Council to consider closer links with an African country. Ireland's Ambassadors in Africa (located in Egypt, Ethiopia, Kenya, Liberia, Malawi, Mozambique, Nigeria, Sierra Leone, South Africa, Tanzania, Uganda, Zambia) have been informed of the motion by Limerick City and County Council and asked to reflect on potential opportunities for engagement in their countries of primary or secondary accreditation. Officials in the Department of Foreign Affairs (James Kilcourse, Tel.: 01-408 2492), with my support, are available to engage with you, with a view to further strengthening the ties between Ireland and Africa.

Dear Councillors,

I wish to acknowledge receipt of your motion in relation to restrictions at University Maternity Hospital Limerick (UMHL).

I wish to acknowledge receipt of your representation in relation to visitor restrictions at UMHL.

We were pleased to announce last week an important step in the ongoing relaxation of COVID-19 access restrictions at University Maternity Hospital Limerick (UMHL), with partners now being permitted to accompany women for appointments in the hospital's Early Pregnancy Access Unit (EPAU) since Thursday July 8th. This is an important service that provides timely access to consultation with a midwife, an obstetrician and an ultrasonographer for women who experience irregularities during the first 12 weeks of pregnancy.

The further easing of restrictions comes just one week after the introduction of 45-minute visiting slots for partners of women on the hospital's ante-natal ward, M3, from 6-9pm daily. In recognition of the importance of maximising contact between parents and infants, while working to safeguard all patients, infants, partners and staff from the threat of COVID-19, UMHL has since late April been engaged in a gradual relaxation of the COVID-19 restrictions on access that have been in place at the hospital throughout the pandemic.

Since then, UMHL has introduced 45-minute visiting slots on the hospital's postnatal words, M1 and M2, from 6pm-8pm daily. All mothers on M1 and M2 are offered this daily scheduled visit for their nominated partners, including on day of delivery.

We also offer the option to have nominated partners present for anomaly scans, and visiting for fathers/parents of babies in the neonatal unit. All nominated partners must adhere to the wearing of face masks, observe hand hygiene and social distancing. Temperature monitoring is in place at the main reception, along with the completion of a COVID-19 screening questionnaire.

Visiting on compassionate grounds continues to be facilitated, as it has been throughout the pandemic, and we also continue to support the attendance of birthing partners in the Labour Ward and Theatre.

The recent introduction of visiting on the antenatal ward M3 and now the facilitation of partners to accompany women for EPAU appointments are important steps in an ongoing process, and fulfil the objectives of the

national guidance on access to maternity hospitals, which seeks to balance the competing requirements for partners to be present and support women, while giving priority to the safety, welfare and privacy of all women and infants in our care, and our staff.

In taking decisions to implement or relax restrictions, UMHL has regard to three primary factors: the rate of COVID transmission within the local community, the number of staff in the hospital and the possibility of those staff becoming unwell, and the infrastructure of the hospital site. More recently, we particularly note the concerns nationally and internationally about the transmissibility of the Delta variant of the SARS-CoV-2 coronavirus.

We continue to review the access situation at UMHL on a weekly basis, to plan for the safe, controlled and phased relaxation of restrictions, and to ensure all processes are safely introduced and managed.

I refer to your letter dated 14th of July with regards to the provision of Reasonable Accommodations for State Examinations for students with epilepsy.

The SEC provides a scheme of Reasonable Accommodations at the Certificate Examinations (RACE Scheme) to support candidates who might have difficulty in accessing the examinations due to their special educational needs. The scheme provides accommodations for candidates with a variety of complex needs including learning difficulties as well as permanent or temporary physical, visual, hearing, medical, sensory, emotional, behavioral or other conditions.

In 2019, the SEC introduced, on an interim, pilot basis, a limited provision for supporting Leaving Certificate and Leaving Certificate Applied candidates who experienced the death of a close relative during the period of the written examinations under the emergency provisions of the RACE Scheme. Under that arrangement, a candidate who experienced a bereavement of a close relative was allowed to defer up to three days of their examinations and to take the examinations that they missed at an alternative sitting of the examinations in July 2019. The purpose of this measure was to allow the bereaved candidate some time to prepare for and attend the funeral of their loved one without having to contend with the added pressure of a full set of examinations.

It is acknowledged that students also experience other forms of trauma and adversity, such as serious illness, around the time of the Leaving Certificate examinations. The issues arising here are complex and must be balanced against the absolute need to maintain integrity and public confidence in the examinations system. Following the interim, pilot measure in 2019, the Board of the SEC had commenced a comprehensive review of the broader issue of how best to support students experiencing all forms of trauma and adversity at examinations time. The review process, which has been interrupted due to COVID-19, included research into practices in other jurisdictions

as well as engagement with stakeholders and candidates. The SEC will be recommencing this extensive review process as soon as it is feasible.

## **Accommodating Candidates with Epilepsy**

Under the existing provisions of the RACE Scheme, every possible effort will continue to be made by the SEC to accommodate candidates who experience accidents, or other trauma either immediately before or during the examinations. There are arrangements that can be made between the State Examinations Commission and the school in the best interests of an ill or injured candidate provided the candidate is able to proceed with their examination on the scheduled date. For candidates who suffer from epilepsy, these arrangements might include supervised rest breaks during the examinations; access to a smaller examination centre; and alterations to the start and end time of the examinations as long as the examination is taken on the date as on the published timetable.

#### **Examinations 2022**

It is intended that an alternative set of Leaving Certificate examinations will be run in 2022, shortly after the main set of examinations. These examinations will be limited to certain students who are unable to sit the main set of examinations due to close family bereavement, COVID 19 illness and certain other categories of serious illness to be determined.

The advisory group on planning for State Examinations 2022 includes representatives of students, parents, teachers, school leadership and management bodies, the State Examinations Commission (SEC), the National Council for Curriculum and Assessment, the Department of Further and Higher Education, Research, Innovation and Science and the Department of Education, including the National Educational Psychological Service.

The SEC will issue further details regarding the 2022 examinations, with all arrangements guided by prevailing public health advice. There will be further engagement with stakeholders in advance of this.

I trust that this information is of assistance in clarifying the position.

Ms. Heather Humphreys TD, Minister for Social Protection, has asked me to reply to your correspondence on behalf of the members of Limerick City and County Council regarding access to the free travel scheme for people who suffer with epilepsy.

The Free Travel scheme provides free travel on the main public and private transport services for those eligible under the scheme. These include road, rail and ferry services provided by companies such as Bus Átha Cliath, Bus Éireann and Iarnród Éireann, as well as Luas and services provided by over 80 private transport operators. There are currently approx. 1,003,000 customers with direct eligibility. The estimated expenditure on free travel in 2021 is €95 million.

In general, access to a free travel pass for those aged under 66 is linked to a person being in receipt of certain primary Social Protection payments such as Disability Allowance, Invalidity Pension, Carer's Allowance, Blind Pension and Partial Capacity Benefit.

Any possible extension to the eligibility criteria for free travel to include those diagnosed with epilepsy regardless of whether they receive a qualifying payment would have significant implications for the free travel scheme. It would be expected that any such decision would immediately lead to calls for all people who had a disability and/or significant health issues to be eligible for a free travel pass.

If the Free Travel scheme was to be extended to all people who had a disability and/or significant health issues, regardless of whether they receive a qualifying payment, a medical assessment process would be required for all such applications, significantly changing the nature of the scheme and requiring additional administrative processes to be put in place in order to adjudicate eligibility. Significant extra funding would also be required and accordingly, it could only be considered in the context of overall budgetary negotiations.

Under the Supplementary Welfare Allowance scheme, the Department may award a travel supplement, where the circumstances of the particular case so warrant. The supplement is intended to assist with ongoing or recurring travel costs that cannot be met from the client's own resources and are deemed to be necessary. Every decision is based on consideration of the circumstances of the individual case, taking account of the nature and extent of the need and of the resources of the person concerned.



At the time of Aer Lingus's acquisition by the International Airlines Group, certain connectivity commitments were made, one being to operate flights between Shannon and London Heathrow to a defined level.

Due to the COVID-19 Pandemic, *force majeure* provisions on these commitments have permitted the suspension of the operation of this route. Furthermore, these connectivity commitments expire in September 2022 and there is no facility to extend them. After this time, Aer Lingus will be free to utilise its London Heathrow airport slots as it wishes, and the operation of this route and its frequency will be a commercial decision for the company.

The closure of the Aer Lingus cabin crew base at Shannon Airport was an unfortunate development, and a consequence of the financial impact that COVID-19 has had on the aviation sector. Both Minister Eamon Ryan and Minister Naughton met with the CEO of Aer Lingus soon after their announced restructuring. At this meeting, we welcomed confirmation that there was no strategic intent to reduce operations at Shannon, and that restoration of services would depend on prevailing market conditions. The CEO of Shannon Group was also met to inform them of developments, to reiterate our support, and to acknowledge the important role played by Shannon Airport in regional development.

The resumption of non-essential international travel from 19 July, in conjunction with the introduction of the EU Digital COVID Certificate, are positive developments for the market that will facilitate the restoration of air services.



#### Dear Chairperson

The Minister for Education, Ms Norma Foley, TD, has asked the State Examinations Commission to respond directly to your letter of 22 July 2021, on behalf of Meath County Council and South County Dublin County Council, in relation to the provision of Reasonable Accommodations at the Certificate Examinations for students with epilepsy.

The SEC provides a scheme of Reasonable Accommodations at the Certificate Examinations (RACE Scheme) to support candidates with a complex variety of special educational needs including learning difficulties as well as permanent or temporary physical, visual, hearing, medical, sensory, emotional, behavioural or other conditions. The purpose of the scheme is to allow candidates who have special educational needs that interfere with their capacity to engage with the standard examination arrangements to demonstrate what they know and can do, without compromising the integrity of the assessment. This involves such candidates being held to the same standard as other candidates with regard to what the examination is intended to measure. In common with similar schemes which operate in other jurisdictions, the focus of the RACE scheme is on the need to remove barriers to accessing the examinations, while retaining the need to assess the same underlying skills and competencies as are assessed for all other candidates, and to apply the same standards of achievement as apply to all other candidates.

Access to the state certificate examinations is facilitated, in the first instance, by developing examination papers and other test instruments that are designed to be as accessible as possible to the broadest range of candidates, including those with special educational needs. All examination materials are reviewed in the course of their development with a view to eliminating inappropriate barriers, and careful consideration is given as to whether the means of assessment rely on a skill or competence that is not properly part of the focus of the assessment but which could exclude candidates with certain disabilities.

#### **Range of Accommodations**

The range of accommodations provided within the scheme has been designed to ensure fairness when facilitating candidates in demonstrating their level of achievement of the objectives of the course concerned in a manner which is fair to all other candidates.

The range of accommodations available within the scheme includes:

- Access to a reader or reading assistant or use of an examination reading pen for candidates with learning or visual difficulties
- Use of a word-processor, or a recording device or, in very exceptional circumstances, access to a scribe for candidates with learning or physical difficulties
- A waiver from the assessment of spelling, grammar and punctuation in language subjects for candidates with learning difficulties
- Alternative format examination papers (enlarged; Brailled; etc.) for visually or physically impaired candidates.
- A modified oral or aural or an exemption from these tests for hearing impaired candidates
- Use of drawing aids in certain examinations
- · Access to a special shared examination centre or, exceptionally, an individual centre

#### **Eligibility for RACE**

Conditions of eligibility, including, for some accommodations, specific measurable criteria, apply to the various access arrangements which can be approved under the scheme and accommodations can only be provided in accordance with the principles and requirements of the scheme.

It is important to note that the existence of a learning or other difficulty does not automatically mean that a candidate requires accommodations to access the certificate examinations. For example, even though candidates may have some difficulty with reading, writing or spelling they may not require the provision of any special facilities if they can read the examination papers at the appropriate level and communicate what they know to the examiners.

#### **Accommodating Candidates with Epilepsy**

Under the existing provisions of the RACE Scheme, every possible effort is also made by the SEC to accommodate candidates who experience accidents, serious illness or other trauma either immediately before or during the examinations. There are arrangements that can be made between the State Examinations Commission and the school in the best interests of an ill or injured candidate provided the candidate is able to proceed with their examination on the scheduled date. For candidates who suffer from epilepsy, these arrangements might include supervised rest breaks during the examinations; access to a smaller special examination centre; and alterations to the start and end time of the examinations as long as the examination can be taken on the date as on the published timetable.

#### Interim Pilot Provision in 2019

In 2019, the SEC introduced, on an interim, pilot basis, a limited provision for supporting Leaving Certificate and Leaving Certificate Applied candidates who experienced the death of a close relative during the period of the written examinations under the emergency provisions of the RACE Scheme. Under that arrangement, a candidate who experienced a bereavement of a close relative was allowed

to defer up to three days of their examinations and to take the examinations that they missed at an alternative sitting of the examinations in July 2019. The purpose of this measure was to allow the bereaved candidate some time to prepare for and attend the funeral of their loved one without having to contend with the added pressure of a full set of examinations.

It is acknowledged that students also experience other forms of trauma and adversity, such as serious illness, around the time of the Leaving Certificate examinations. The issues arising here are complex and must be balanced against the absolute need to maintain integrity and public confidence in the examinations system. Following the interim, pilot measure in 2019, the Board of the SEC had commenced a comprehensive review of the broader issue of how best to support students experiencing all forms of trauma and adversity at examinations time. The review process, which has been interrupted due to COVID-19, included research into practices in other jurisdictions as well as engagement with stakeholders and candidates. The SEC will be recommencing this extensive review process as soon as it is feasible.

#### **Examinations 2022**

On 30 June 2021, Minister Foley announced the adjusted arrangements that would apply to the 2022 Leaving Certificate and Junior Cycle examinations to take account of the disruption to learning as a result of the COVID-19 pandemic. These arrangements include adjustments to the assessments similar to that applied by the Assessment Arrangements For Junior Cycle and Leaving Certificate Examinations 2021, as announced in December 2020. The revised arrangements for 2022 also include the intention to run an alternative set of Leaving Certificate examinations, shortly after the conclusion of the main set of examinations. These examinations will be limited to certain students who are unable to sit the main set of examinations due to close family bereavement, COVID 19 illness and certain other categories of serious illness to be determined with due regard for the principles of equity, fairness and integrity which govern all aspects of the examinations system. There will be no second sitting of the Junior Cycle examinations.

The SEC will issue further details regarding the 2022 examinations, with all arrangements guided by prevailing public health advice. There will be further engagement with stakeholders in advance of this.

I trust that this information is of assistance in clarifying the position.
