## **Matters Arising:**

### **September Municipal District Meeting**

Councillor Donegan requested an update as to whether the Maigue River Trust had been contacted to deliver a presentation to the Elected Members. The Meetings administrator agreed to make contact with the Maigue River Trust.

The Elected members sought clarification as to whether there was an update on the sale of the Green area in Bruree as discussed at the Municipal District Meeting on 16<sup>th</sup> September. The Elected Members requested that this issue be kept on the agenda. The Senior Executive Engineer provided an update on the auction process.

## **3. Water Services**

Questions posed by the Elected Members regarding Water Services were answered by Senior Engineer Water Services (Anne Peters) and A/Senior Executive Engineer Water Services (Neal Boyle).

It was agreed that Anne Peters would present long term plans with regards to Irish Water as part of a workshop to the Elected Members. There would also be an opportunity for the Elected Members to submit questions prior to the workshop which would be answered as part of the workshop, or else be further submitted to Irish Water for response. This workshop would co-incide with a date of a Municipal District Meeting.

#### **5. Notice of Motion submitted by Councillor Egan**

I will move at the next meeting of the Cappamore-Kilmallock Municipal District that Limerick City and County Council do a survey of the old graveyard in Abington to see if there are any vacant plots available. I would also like Limerick City and County Council to look into the possibility of looking for an extension to Abington graveyard, Towerhill graveyard and Ballinure graveyard.

**Reply:**

The Council wishes to advise that the old Graveyard in Abington is not in the ownership of the Council. It is therefore not possible to survey the grounds as this burial ground is vested in the Representative Church Body (RCB).

The Council recently prepared a Burial Ground strategy for Limerick. The capacity remaining in all of the burial grounds in the City and County was determined. The strategy revealed that there was five years capacity remaining in the Abington Burial ground. There was no capacity remaining in the Towerhill or Ballinure burial grounds. Accordingly, the strategy recommended a new burial ground to serve the Murroe/Cappamore areas. The Council will progress with identifying possible sites for the new burial ground in the first quarter of 2022.

#### **6. Notice of Motion submitted by Councillor Mitchell**

I will move at next meeting of the Cappamore Kilmallock Municipal District that Irish Water in conjunction with Limerick City and county Council, as announced in the next capital phase of projects, will carry out the complete necessary works and investment to the Hospital Sewerage Plant to comply with present regulations and make it fit for purpose to future proof Hospital for future expansion in every aspect because of its strategic location between Cork and Limerick on the R513.

**Reply:**

Please note below the response received from Irish Water. "As part of our Small Towns and Villages Growth Programme, a project to provide additional treatment capacity and improve

compliance at Hospital WWTP was recently announced. Further updates on timelines for delivery will be provided as the project progresses.”

It was also agreed by the Elected Members that due to the high Covid Numbers that a workshop would be held in January to look at organising a Civic Reception to recognise local Sporting and Community Achievements.

The Elected Members wish James Brown of the Road Maintenance Team a swift recovery following a recent injury.

The Elected Members wished to express their sympathy to the family of Jimmy Fox, husband of Carmel Fox, formerly of Ballyhoura Development Limited, who passed away recently.
