#### **Film Offices Forum Event**

As part of our national film offices forum, set up and chaired by Film in Limerick, we arranged an online event in January with Screen Ireland and forum members looking at building regional crew skills and supporting infrastructure.

Our Creative Producing Programme, run in conjunction with Limerick and Clare Education and Training Board ran seven sessions during the month with industry guests including:

Our Writers Factory: Intro to Screenwriting Course, with Limerick and Clare Education and Training Board, continued weekly online sessions in January with four sessions for 20 budding film and television writers from the Mid-West.

#### **Virtual Production Facility**

Film in Limerick are a partner in a project led by LEDP to establish a Virtual Production Facility in Limerick for film and TV production. This month the project has sought bidders to carry out a feasibility study on the opportunity.

#### **Production Support**

Film in Limerick supported seven productions in January (feature, TV Drama and TV productions) with location scouting, crew database enquires, Section 481 information and facilities support.

## 4. Forward Planning

- Work continued on the preparation of the Draft Limerick Development Plan 2022 – 2028, with five workshops held with Elected Members to consider the Chief Executive's report on the submissions received during the draft plan public consultation period.
- At the Full Council Meeting held on 24 January, the Elected Members adopted the Development Contribution Scheme 2022.

## 5. Digital Services

- On 10 January, Limerick City and County Council staff met with the Southern Regional Assembly to discuss the path taken on the early development of Smart Limerick. The Southern Regional Assembly is researching how to go about creating a smart region, and are consulting with several cities on how this might be achieved.
- On 24 January, members of EU Programmes and the Arts and Culture Department met with representatives from Provincie Fryslan, Technological University of Shannon, and St. James's Hospital to discuss participation in the Culture Cares project proposal. If successful, this Creative Europe project would investigate how art can be used in a care setting for the benefit of patients and staff.
- On 25 January, Limerick City and County Council submitted the Horizon Europe Proposal "ShannonTiDe" in response to the European Commission's New European Bauhaus call. If successful, this €5m project will develop pilot interventions in Limerick. This cross departmental effort, led by the Urban Innovation team, was in itself a worthwhile exercise as it made all involved think about novel ways in which Limerick City and County can do its part for Climate Action.
- On 26 January, the EU Programme Manager and members of the Community team attended the INTEgreat Kick-Off meeting. This Asylum, Migration and Integration Fund (AIMF) project in Cooperation with Doras Luimní will, over the next three years, develop new migrant sensitive trainings for public services bodies.
- On 28 January, members of the EU Programmes and the Environment team met with representatives from the Irish Bioeconomy Foundation, and the University of Florence to discuss potential participation in the S-Tree FOOD Project. Thanks to TUS MidWest, this opportunity might see Limerick working with African cities to explore the potential of urban trees from a cultural, social, and economic perspective.



## **Transportation and Mobility Directorate**

#### 1. Travel and Transportation Strategy

Approval granted for Part VIII - Junction Improvement works on the R445 (Dublin Road) / R506 (Cappamore Road)

#### 2. Active Travel

#### **Projects**

- Childers Road Work got underway on a new two-way segregated cycleway between the Roxboro Roundabout and the Kilmallock Roundabout. Once complete, the new stretch of cycleway will link up with the existing two-way segregated cycleway between the Kilmallock Roundabout and Parkway Shopping Centre.
- St. Nessan's Road Kerb segregation was added to a large section of the cycle lane The Active Travel team collaborated with the Operations team to deliver new kerbs on large stretches of St. Nessan's Road from the St. Paul's junction down as far as St. Nessan's Church.

#### 2022 Allocation

The Department of Transport confirmed that Limerick City and County Council has been allocated approx. €24.4m by the National Transport Authority for the delivery of Active Travel infrastructure in 2022.

#### **Marketing and Communications**

- Active Travel tweeted seven times from the Limerick Council Twitter account with total followers of 17,100.
   The most popular post was liked 134 times.
- Active Travel produced a short social media video about the recently installed kerb segregation on St. Nessan's Road. The video was posted on the Limerick Council Twitter account and was viewed 2,441 times.

- Active Travel published one post on Limerick Council LinkedIn with total followers of 8,197. The post was liked 92 times.
- Active Travel issued one press release announcing the Active Travel funding allocation for 2022.

Active Travel Road Sweepers – pupils at our Round 1 Safe Routes to School primary schools took part in a competition to name our new Active Travel road sweepers. A total of 63 entries were submitted and judging took place in early January.

A presentation was delivered by a Senior Executive Engineer with Active Travel as part of the Rapid Development Active Travel Workshop.





## Community, Tourism and Culture Directorate

## 1. Urban & Rural Community Development

#### **Local Community Development Committee (LCDC)**

The January meeting of the LCDC was held on 19 January via Microsoft Teams. The Local Action Group (LAG) approved funding of €460,945.18 under the LEADER Programme 2014-2022 (€376,786.02 funded from the Transitional LEADER Programme and €84,159.16 funded from the European Union Recovery Instrument Fund).

#### **Limerick Public Participation Network (PPN)**

- Limerick PPN Secretariat met once this month and continues to successfully deliver on its key functions.
- One PPN Linkage Group meeting took place this month: Economic Development, Enterprise and Planning.
- Details of the Linkage Groups are on the Limerick PPN website
- A new Resource Worker commenced working with Limerick PPN at the beginning of the month.
- 16 organisations across Limerick City and County applied to join Limerick PPN this month and membership now stands at 174 members. The membership registration form is on the Limerick PPN website and eligible groups in Limerick can register at any time.
- Limerick PPN continued to have an active social media presence on its regularly updated website and on Twitter and Facebook.

#### **Environmental Awareness**

 The "@limerickenviron Don't Idle" social media campaign was launched along with an interview on Live 95 Limerick Today Show.

#### 2. Tourism

#### **Limerick Greenway**

The Greenway recorded 30,000 visitors during the Christmas season.

#### Ardagh Station House and Abbeyfeale Railway Shed

The Ardagh Station House and Abbeyfeale Railway Shed have been allocated funding under the Rural Regeneration Development Fund.

A total of €600,000 has been allocated to Limerick City and County Council for the projects in Ardagh and Abbeyfeale in the latest tranche of funding by the Department of Rural and Community Development.

The project will develop plans to renovate the heritage buildings and sites adjacent to the Limerick Greenway providing improved visitor services and experiences for the public and visitors along the Limerick Greenway.

This in turn will provide a range of benefits to the adjacent villages.

#### 3. Arts Office

Update on the Strategic Policy Committee (SPC) Sub-Committee for the recovery of the Arts and Culture Sector in Limerick, following the impact of COVID-19 on the sector

An online meeting with GM Innovations, who are providing Research Evaluation, took place on 11 January. The presentation provided an overview of the brief, approach and methodology. A survey has been prepared.



#### **OPEN CALLS**

#### Grants under the Arts Act Open Call

On 14 January, Limerick Arts Office announced the open call seeking applications from individual artists or organisations under the "Grants Under the Arts Act" scheme. Limerick City and County Council offers grant funding to amateur, community or voluntary groups, or organisations, and individual arts practitioners, which, in the opinion of the authority, will stimulate public interest in the arts, promote the knowledge, appreciation and practice of the arts or assist in improving the standards of the arts. In the 2003 Arts Act, the arts are defined as painting, sculpture, architecture, music, film, drama, dance, literature, design in industry and the fine arts and applied arts generally. The awards can be used for the professional development of artists and the arts, and increasing access and participation in the arts. The closing date for applications to the scheme is 23 February.

#### **CREATIVE IRELAND FUNDED PROJECTS**

Creative Ireland Limerick secured a total funding allocation of €175,161 (€145,161 Core funding + €30,000 Cruinniú na nÓg funding) to support Limerick creatives and to bring creativity to our communities. Funding for Cruinniú na nÓg, the national day of creativity for children and young people, has been doubled, to support empowering children and young people to develop their creative potential.

#### Creativity in Older Age 2022

An application was prepared by Limerick Arts Office in collaboration with Age Friendly Limerick and Healthy Limerick and submitted to the Creative Ireland Creativity in Older Age 2022 for funding, closing date was 25 January. The proposal was for Musicians-on-Call (Phase 2), delivered in partnership with Artistic Partner Kids Classics, the Health Service Executive (HSE) and Clare and Tipperary County Councils. This brings professionally trained musicians from Music in Health Organisation Kids Classics to work in healthcare settings in the Mid-West Community Healthcare Region, to connect music-making opportunities to residents and healthcare staff in Nursing Homes and Community Hospitals. Musicians-On-Call provides a music

sharing experience that puts the residents' interests and choice at the heart of music making, by connecting closely with the setting before each visit and facilitating the residents to curate each visit through a two-way responsive engagement.

## ARTS COUNCIL FRAMEWORK AGREEMENT PROGRAMME

#### **PARTNERSHIPS**

#### Limerick Artist in Schools Programme 2021/2022

Letters were sent out to primary schools offering the opportunity to take part in a series of five weekly creative dance workshops facilitated by Dance Limerick and attend a special performance, entitled Bill & Fred, by professional dancers as part Of Dance Limerick's 'What Next Festival'. Two schools from Adare-Rathkeale (Shanagolden National School and Coolcappa National School) and one school from Cappamore-Kilmallock (Knocklong National School) were successful.

Expressions of Interest have also been sought from all schools in the Cappamore-Kilmallock Municipal District for workshops facilitated by Ballyhoura's The Joyce Brothers Festival, and from Adare-Rathkeale Municipal District for workshops facilitated by the Feile na Greine Festival.

#### ST. PATRICK'S FESTIVAL THEME ANNOUNCED

With the easing of Government restrictions on 23 January, Limerick City and County Council was able to announce that the Limerick St. Patrick's Festival will make a welcome return to the city streets following a COVID-enforced absence of two years. This year's theme is Belonging and Identity, ideas that many people have been thinking about and discussing throughout the two years of enforced restrictions. This year also marks the 100th anniversary of the Irish Free State and the 50th anniversary of Ireland joining the European Economic Community (now the European Union). The Limerick St. Patrick's Festival will include the traditional St. Patrick's Day Parade on 17 March and the Limerick International Band Championship taking place this year on 20 March.

#### 5. Libraries, Gallery & Museum

#### Library

Newcastle West Library created the following book displays during the month of January: "You Never Know Where a Book May Take You ..." showcasing a selection of popular novels set in different countries, and "Green Fingers" with some wonderful new gardening books. Celebrating Lewis Carroll's birthday on January 27, Library staff made a large board display depicting extracts, illustrations and quotations from his famous books "Alice Adventures in Wonderland" and "Alice through the Looking Glass", with a short biography of the novelist's life. Weekly visits from Courtney Boys and Scoil Íosaf National Schools continued. Scoil Íosaf's Autistic Spectrum Disorder (ASD) Unit enjoyed a fantastic visit to the library with a fun filled morning

with rhymes and stories ending with a lively spell on the library's Magic Table. The Magic Table is an interactive projector designed for adults and children with diverse care needs. The projected games stimulate movement, create a shared experience and enhance emotional wellbeing. This table was funded by Pobal. The children really enjoyed their visit and they hope to make it a weekly event. A further relaxation of Covid-19 restrictions allowed Newcastle West to welcome back Library members, from St. Joseph's Foundation and their carers. They enjoyed a lovely morning browsing through new non-fiction books, reading the local newspapers and chatting about their favourite books and movies.

- Throughout January, Kilmallock Library issued 25 more Touch Type Read and Spell (TTRS) licenses to local schools and individuals, bringing the total issued by Kilmallock Library to 150 to date. TTRS is a multi-sensory course that teaches touch-typing skills to help children and adults improve both their reading and spelling. It is of particular benefit to those adults and children with dyslexia and other learning difficulties. Voices: A Story for Everyone is a very special anthology of short stories by some of Ireland's most beloved writers designed to be accessible to readers at all levels. The stories are written in plain English and are designed to encourage adults who do not read often, or find reading long texts a challenge, to discover the joy of reading. The National Adult Literacy Agency (NALA) has also published a new student workbook - 'Voices Matter' to accompany the short stories. The 'Voices Matter' workbook has worksheets and fun activities based around each of the stories in 'Voices'. The branch actively promoted this title and workbook online and in branch.
- In Watch House Cross Library classes returned in line with Covid-19, guidelines and two groups returned to the designated computer room for training in Fetac Level 2: Computers, and Driver Theory Test preparation.
   The branch was also delighted to welcome back classes from Corpus Christi Primary School, with visits from Second Class and Fourth Class to browse and borrow.



- Library staff attended the first two online seminars in the Youth Library Group 'Recommending With Confidence' series with topics including: Bibliotherapy, with Children's Books Ireland Chief Executive Officer, Elaina Ryan, and supporting LGBTQI+ Youth (Lesbian, Gay, Bisexual, Transgender, Queer and Intersex), with Collette O'Regan from LGBT Ireland.
- Library Shelfies offer Libraries and book lovers an opportunity to express their reading preferences through a single photograph, which can be printed or posted online. Limerick Libraries took part in the annual #LibraryShelfieDay day, 26 January, with fun displays, both adult and juvenile, and posted them on the Library's Facebook, Twitter and Instagram accounts with 17 posts on Library platforms, reaching over 4,000 social media users.
- Glin Library welcomed back a small group of enthusiastic early readers for the local pre-school.
- The City Library marked the beginning of the New Year with a series of displays designed to usher in 2022 with positivity and change. In the adult Library, visitors were encouraged to adopt a New Year Resolution-Read More with an ever-changing display of the best new titles, fiction and non-fiction. While those dreaming of foreign lands had a host of new travel guides to choose from in the Travel Inspiration book promotion. For the children, the Library promoted books on themes of Mindfulness and Positivity with a selection of books recommended by Children's Books Ireland. A special display of books around the topics of Health and Wellbeing in support of the Healthy Ireland at Your Library campaign also proved popular for both adults and children. School and class visits began again with the regular Friday visit from Ms. Mullins and her students from Christian Brothers School (CBS) Primary School. Another student group from the Autism Unit of CBS Primary School also dropped in to spend some time browsing, reading and enjoying their local Library on the 18. Other visitors to the Library in January included class groups from Saint Michael's National School on 20 January and a group from Limerick Youth Service who came for a Library tour on the 21.
- The Local Studies Department at Watch House Cross Community Library was busy throughout January. In line with Covid restrictions, visits to the department remained by appointment only and there were twentythree such visits by researchers between 5 and 28 January. Nine of these visits involved research on the microfilm archive of Limerick newspapers, a further eleven on the subscription digital resources to which the department provides access (primarily the Irish Newspaper Archive, but also the British Newspaper Archive, and FindMyPast). Of the remaining three visits, two involved research on the Ordnance Survey Ireland (OSI) map collection in both hardcopy and digital format, and one comprised an advice session on family history research. Twenty-six research queries were received via telephone or email, all of which were resolved, or are being currently dealt with, remotely. Work also commenced on the department's primary Decade of Centenaries project for 2022, viz. the production of a richly illustrated edited collection of essays by ten historians on Civil War in Limerick city and county.

#### **Limerick City Gallery of Art (LCGA)**

- Aideen Barry's major solo exhibition, By Slight
  Ligaments, continues. This is Barry's most ambitious
  exhibition to date and the culmination of several year's
  work. It includes film, sound, drawing, digital animation
  and several specially commissioned collaborations with
  artists, designers and craft workers. At the heart of the
  exhibition is OBLIVION /SEACHMALLTACHT, which
  receives its premier in LCGA, it is an Irish Traditional
  Music Archive and Music Network, Bunting Commission.
- Through the Lens and Unwrapped from the Permanent Collection selected by Siobhan O' Reilly continued through January. The exhibition in the East Gallery comprises a selection of photographic work including work by Limerick artists, Maighread Tobin, Sinead McKillican, Deirdre Power, Andrew Kearney and Eamonn O' Mahoney. In total, there are 54 works by 24 artists on show. Unwrapped is an exhibition of a selection of recent acquisitions to the Permanent Collection, which will run until the end of January.



- Work continues on future exhibitions programme, including Belonging, works from the European Investment Bank Collection, which will feature in a number of venues throughout the city. Work continues on Tom Fitzgerald's major retrospective.
- The collaborative relationship with Dance Limerick continues with the Bridges project under the aegis of the Shinnors Scholar at LCGA with four workshops delivered in January. This project received funding from Creative Ireland.
- LCGA have welcomed third year Business student,
  Hannah Keane, on a five-month placement. Hannah will
  develop an audience questionnaire and carry out a
  series of interviews with visitors to the Gallery to
  evaluate their experience and response to the
  exhibition programme.
- The Director/Curator continues to attend virtual meetings with colleagues to discuss the sectoral needs of the visual arts in Ireland. The Group presented a report to the Arts Council on pay and conditions for artists and art workers.

 Work has commenced on research for the digitization of the Permanent Collection and the first provisional selection of work has been made. The exhibition will mark the 75th anniversary of the opening of the purpose built gallery to house the Permanent Collection. The selection reflects the works that were in the Collection at the time of the opening.

#### **Limerick Museum**

 Limerick Museum's long standing collaboration with the annual Robert Burns Night in Dolans on the Dock Road continued this year, when Dr. Matthew Potter, Museum Curator, gave a short talk on the many connections between Limerick and Scotland. For the first time ever, the 2022 Robert Burns Night was broadcast live on social media.





## **Regeneration Directorate**

#### 1. Regeneration

#### **Economic**

#### **Jobs Initiative Programme Update**

A number of stakeholder meetings took place in January. Ongoing consultation with community partners to engage mentors in each regeneration areas to support the programme. A database of employers has been established and work continued on engaging new employers into the programme. In order to enhance the programme additional resources have been committed through agencies such as Limerick and Clare Education and Training Board and TUS.

Various site visits were held with prospective employers in the construction industry who visited partner organisations involved in the programme.

#### **Social**

#### Social and Economic Intervention Fund

- Social Intervention Fund (SIF) 2022 Update SIF 2022 application process has closed. Applications to the value of approximately €5 million are currently being processed.
- Social Regeneration Impact A further example of how the Social Intervention Fund is supporting meaningful and impactful work in the communities was recently highlighted by the Changing Ireland magazine https:// www.changingireland.ie/moyross-where-everyyoungster-backs-wesley/

#### **Community Engagement**

#### **Clinics for Resident Queries**

Clinics took place with residents in the regeneration communities in person on a weekly basis throughout January.

#### **Regeneration Committee Meetings**

Regeneration Committee meetings took place online in all the regeneration communities in January with Residents Associations meeting in advance of these.

#### **Community Activities**

Some of the examples include:

- The recently formed ABC (A Better Community) Residents Group Ballinacurra Weston held a candlelight vigil in their school yard for all the community to remember those who passed away over Christmas.
- Tait House continue to work with the Mid-West Simon Community to distribute food parcels to those in need.
- A new working group to agree plans for the Kings Island Community Centre in St Mary's Park had their first meeting in January. There are many factors to be considered in this development, i.e. viability of site from the perspective of footfall, general connectivity to the community at large and surrounding communities etc.
- Limerick Employment Services (LES) which has an office in each of the areas is currently being tendered nationally with the community anxious to ensure this service continues.
- Moyross Partners met in January to discuss the topical issues affecting their area.

- Construction works commenced on Churchfield Phase 2 in Southill.
- Construction works ongoing on Cliona Park Phase 3 in Moyross.
- Construction works ongoing on the Peter McVerry Trust Rapid Infill Housing Development in Delmege Park, Moyross.
- Vacant units in Dalgaish Park demolished this month to enable the construction of the 57 unit in Dalgaish/ Cosgrave Park housing development in Moyross.
- Assessment of Approved Housing Body expression of interest ongoing for the Orchard site development, St Mary's Park.
- Construction Works ongoing on Thermal Upgrade Contract 122 (St. Mary's Park).

#### **Community Facilities**

 District Play Area for Castle Oaks View, Southill – Capital Appraisal submission to the Department of Housing, Local Government and Heritage has been approved for progressing to Stage 2 Initial Design.

#### **Demolitions**

Strategic demolition of houses as per the Limerick Regeneration Programme took place in Southill and Moyross.

#### **CCTV Report from the Data Protection Commissioners**

Following an audit by the Data Protection Commission and publication of the decision, the Council is actively working on complying with the data protection requirements to ensure that the public safety network of CCTV cameras in the Regeneration areas is maintained in compliance with relevant legislation.

#### **Local Authority Construction**

#### Affordable Housing Fund (SSF Serviced Sites Fund)

Viability studies for several of the Serviced Sites Fund plots, have now been financially modelled, together with assistance from the National Development Finance Agency (NDFA).

The initial reports are being reviewed in conjunction with the Department of Housing, Local Government and Heritage's Affordable housing team to ascertain if the existing SSF schemes would benefit from transferring to the AHF funding stream, and which model of finance / and development strategy is most suitable.

An updated Site Specific Flood Risk Assessment (SSFRA) to include a Justification Test was produced for the Curragower site.

A SSFRA and Justification Test has been tendered for the Sonny's Corner site and submissions are being evaluated.

A draft archaeological report for Sonny's Corner is under review by the Limerick City and County Councils team and the feasibility study is being tailored to adjust for the finds.

A Scope of services brief is being prepared for an Integrated Design team to advance the Toppins Field framework so it can be tested for viability with various tenure models.

#### Mulgrave Street - Wallace Place, Limerick

Mulgrave Street housing scheme comprising of 17 no. units was completed on 28 January. The scheme was completed by the contractors Conack Construction. The scheme was designed and managed by an external design team with the overall project management being provided by Housing Construction.

The completed scheme consists of the following units:

- Unit 1 to 5 2 Bed 2 Storey house
- Unit 6 2 Bed First Floor Apartment
- Unit 7 2 Bed Ground Floor Apartment
- Unit 8 2 Bed Second Floor Apartment
- Unit 9 to 16 2 Bed 2 Storey house
- Unit 17 1 Bed Ground Floor (two Storey unit)

#### 1. BUILD, BUY AND LEASE

In Limerick, the delivery target for 2022-2026 is 2,693 new homes. This is twice the target under the 'Rebuilding Ireland' programme from 2018-2021 of 1,365 homes. Build is the main delivery streams to deliver 2,693 new homes with 40% to be delivered by AHBs and 60% by Limerick City and County Council.

As at January, Limerick City and County Council has over 200 projects approved to deliver homes through the Build, Buy and Lease delivery streams as follows:

## Advance Purchase Turnkeys for Affordable Housing and Mixed Tenure

A new campaign was launched, seeking home builders and housing developers in Limerick city and county to consider offering unbuilt houses or apartments with planning permission to Limerick City and County Council under an advance purchase turnkey arrangement.

Limerick City and County Council are seeking to enter into advance purchase arrangements to secure turnkey homes in areas where the need, in particular for affordable housing, is most acute. This call is targeted at advance purchase opportunities for a minimum of 10 and a maximum of 150 dwellings in any one scheme.

Limerick City and County Council is seeking to agree advance purchase of unbuilt turnkey properties 'off-plan' in the following areas:

- Limerick City (all areas including suburbs)
- Newcastle West
- · Abbeyfeale
- Kilmallock
- Castleconnell

This advance purchase opportunity has been put in place to provide for accelerated delivery of housing generally, and primarily, to provide affordable homes for eligible



applicants nominated by the local authority in areas where a significant need for affordable or social housing has been identified. It is anticipated that, depending on circumstances and proposals, local authorities will enter into an advance purchase agreement for an approved number of homes, with payment on completion. The advance purchase agreement also provides for the direct sale of homes by the developer to an eligible purchaser nominated by the local authority. Joint venture arrangements that include an Approved Housing Body (AHB) will also be considered.

Applications closed on the 31 January and the Housing Directorate is currently assessing applications received.

#### **Private Rightsizing Scheme at Mungret Gate**

The Housing Directorate launched its first rightsizing scheme at Mungret Gate aimed at private homeowners over the age of 55. The scheme allows eligible homeowners to request the local authority to purchase their home in return for a life-long tenancy in a managed Older Persons' Scheme. The 'rightsizing' scheme is entirely voluntary and in partnership with Clann Housing.

The first pilot at Mungret Gate, Limerick City consisted of eight two-bed townhouses with large rear gardens and front curtilage parking. The pilot was successful and now has expanded to a new scheme of 23 two-bed apartment.

The closing date to apply for the second phase of Private Rightsizing Scheme at Mungret Gate was 24 January. The Housing Directorate is currently assessing applications received.

#### Housing Disability Strategy Plan for Limerick

A meeting was held in January of the Housing and Disability Strategy Group (HSE, Acquired Brain Injury Ireland, Enable Ireland, Brothers of Charity and other key service providers) to finalise the Housing Disability Strategy Plan for Limerick. This Plan will proceed to the next Strategic Policy Committee meeting for endorsement.

#### **Vacant Homes Workshop**

Addressing vacancy and maximising the use of existing housing stock is a primary concern of this Government and the new Housing for All Strategy outlines a multi-faceted approach to addressing this matter, including:

- A new local authority-led programme to help Local Authorities buy or compulsory purchase 2,500 vacant homes in their areas which can then be sold on the open market will ensure homes do not lie vacant.
- Reform of the Fair Deal Scheme to remove disincentives to selling or renting unused homes.
- The Croí Cónaithe (Towns) Fund will be delivered by local authorities for the provision of serviced sites for housing, to attract people to build their own homes and to support the refurbishment of vacant properties, enabling people to live in small towns and villages, in a sustainable way.
- A new Town Centre First policy, which will include approaches to utilising existing stock and new financial incentive mechanisms.

Staff in the Housing Directorate attended a virtual workshop on the 27 January to discuss the above matters in more detail.



#### **Customer Services**

This January customers continued to use the online application facility for the Household Waste Subsidy Scheme (Bin Waivers). Customer Services staff liaised with both the Property and Community Facilities and the Digital Strategy departments to streamline the application process and continue to facilitate online applications, making the process quicker and easier for new and existing applicants. Throughout the month, Customer Services staff forwarded over 2,000 application forms for the Household Waste Subsidy Scheme to potential applicants, as well as advising how to apply online and fielding all other queries through our call centre. Customer Services managed a total of 788 calls in relation to this scheme during the month.

The following figures highlight the activity within the contact centre throughout January:

- In January, Customer Services call centre dealt with 12,652 calls. This represents an average of 633 per day, with the number of calls exceeding 600 on several occasions and reaching 798 on our highest days of calls. 58% of calls this month, were handled at first point of contact.
- Customer Services case management team continued working with key service areas of the Council in supporting the closure and update of representations from our Elected members.
- During January 3,017 cases were created, with 754 of these logged on behalf of Public Representatives.
   3,287 cases were closed, with 739 of these being cases logged by Public Representatives.
- January saw a total of 3,236 emails processed through our Customer Services email platform.
- January saw 434 calls received through the Voxpro out of hours services.

- The logging of cases through the MyLimerick portal continued, with a total of 381 cases being logged in January; 316 of which were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating the service requests and keeping our citizens up to date on progress made. Throughout January Customer Services logged 95% of cases for Housing Maintenance in the Metro District.
- Customer Services continued to provide other frontline services to the general public, such as the processing of Residential Parking Permits. There were 101 new Residential Parking Permit applications processed throughout January, with 72 issued.
- January saw a total of 2,643 callers to both our Merchant's Quay and Dooradoyle counters.
