

My Department introduced a range of supports to help community and voluntary organisations meet the challenges they faced during and after COVID-19.


For instance, the COVID-19 Stability Fund supported 863 organisations in 2020 and 2021 with total funding of approximately €48.8 million. No match funding was required.

In 2020, €4.2 million was provided under the COVID-19 Emergency Fund which targeted help at groups participating in the Government's "Community Call" initiative.

The Community Enhancement Programme provides vital supports to assist local groups to re-open their facilities post COVID-19. The programme provided €4.5m funding in 2021 for small capital grants for the improvement of facilities and it is planned to run the scheme again in 2022:

In November 2021, I launched the new **Community Activities Fund**. This €9 million fund is being provided to support community and voluntary groups impacted by COVID-19, helping them with their bills and maintenance.

Match funding is required for almost all **LEADER** funded projects with the exception of training related projects, including for projects where the project promoter is a community group. The rate of aid provided to community projects ranges from up to 75% to up to 90% depending on the type of activity being supported. In order to meet the full cost of the project activity, the project promoter must provide the additional funding required through match funds. Providing it is not sourced from an EU fund, match funding for community-led projects only, may come from other public sources but the overall public funding must not exceed 95% of the overall cost of the project. Community groups are required to provide a minimum contribution of 5% to the cost of the project.

The CLÁR programme is a targeted capital investment programme which provides funding for small scale infrastructural projects in rural areas that have experienced significant levels of population decline. Funding is provided under a range of different Measures and administered by relevant local authorities and/or established organisations/groups that operate entirely on a voluntary basis. Match funding for CLÁR is typically a 10% cash contribution, the remaining 10% or balance of the cost should be provided through local authority/community/other resources. Philanthropic contributions will be accepted as full or part of match funding costs.

The Outdoor Recreation and Infrastructure Scheme (ORIS) provides funding for the development and enhancement of outdoor recreational infrastructure such as walking trails, forest walks, beaches, bogs, lakes, blueways and local greenways. The scheme invests in physical infrastructure that underpins recreational activities based on the use of the resources of the countryside. Up to 90% of the total cost of a project under the Scheme will be provided for any individual project. The remaining 10% match funding must be contributed by the successful applicant and/or the community group and/or philanthropic contributions.

The Town and Village Renewal Scheme has been adapted to reflect the significant challenges facing communities as a result of the COVID-19 pandemic. As an exceptional measure for 2020 and 2021, the rate of grant aid was increased to a maximum of 90% of total project cost, with 10% match funding to be provided by the project.

The higher level of aid was introduced in recognition of the fact that for new projects, communities are faced with reduced capacity to fundraise, while there are also increased demands on the resources of Local Authorities in responding to COVID-19. I have no plans to revisit that requirement at this time.



The Local Improvement Scheme supports the improvement of rural roads and laneways that are not normally maintained by local authorities. Funding is provided to Local Authorities who administer the scheme on behalf of the Department. A local contribution is required from all beneficiaries along the road based on a percentage of the total cost of improvement works but this is capped at €1,200. It should be noted however, that the majority of beneficiaries pay much less than the capped amount.

The primary objective of the Connected Hubs Call is to support and complement the development of the National Hub Network, which is a key action of the Rural Development Policy - Our Rural Future and the National Remote Working Strategy – Making Remote Work. The Connected Hubs Call aims to add additional capacity to the existing remote working infrastructure in Ireland by upgrading existing hubs and Broadband Connection Points (BCPs), while continuing to support COVID-19 mitigation measures.

With regards to applications to the Connected Hubs Fund 2022, the match funding requirements are as follow:

- If the applicant is a commercial or for profit hub, matched funding of 10% of the total project cost must be provided in the form of a cash contribution
- If the applicant is a Social Enterprise or Other not for profit hub, matched funding of 10% must be provided with a minimum 5% cash contribution

Match funding is a requirement for this scheme as it demonstrates the applicants' commitment to the initiative.

The Department's Community Services Programme (CSP) is administered by Pobal on behalf of the Department and currently supports over 420 community organisations to provide local services through a social enterprise model. CSP funding provides a cofunding contribution of €19,033 towards the cost of each agreed full-time equivalent (FTE) position and €32,000 towards the cost of each manager position, where warranted. The CSP contribution does not meet the full salary cost of the supported positions, organisations are required to provide additional funds from their own resources such as traded income, to meet the full cost of employment.

In response to the difficulties encountered by CSP supported organisations, as a result of the Covid-19 crisis, the Department developed a €8.95m CSP Support Fund to cover the period 2020 to 2021. This funding helped organisations who required additional assistance, ensuring that they could continue to retain their CSP supported employees on their payroll, provide assistance for the Employers PRSI contribution for all CSP



supported employees, including managers and meet their ongoing operational costs such as insurance, light and heat and audit fees, during the crisis period up to December 2021, in line with other Government wage support schemes. We are monitoring the situation closely in collaboration with Pobal and any additional supports will be considered in light of available resources.

My Department has responded to the needs of the community and voluntary sector throughout COVID-19 and will continue to engage with the sector and its supporting structures to foster sustainable, resilient and empowered communities to live, work and play in.



On behalf of Mr. Malcolm Noonan, T.D. Minister of State for Heritage and Electoral Reform, I wish to refer to your correspondence of 30th January regarding the following resolution that was adopted at a meeting of Limerick City and County Council, held on 24th January 2022:

"That, Limerick City and County Council call on the State to have only one agency with responsibility for our rivers and lakes"

After consulting with Waterways Ireland with regard to the motion we have been advised of the following:

- 1. The management of the inland waterways in relation to flooding is coordinated through the Shannon Flood Risk State Agencies Co-Ordination Working Group. This Group is chaired by the OPW. If the motion from the Council is in relation to flood management then the matter should be referred to the OPW.
- 2. The management of certain inland waterways in relation to Angling is managed by Inland Fisheries Ireland if the motion is referring to angling then the correspondence should be forwarded to IFI.
- 3. Waterways Ireland is charged with the management of certain inland navigable waterways. The remit of WI is to manage, maintain, develop and restore those specific waterways primarily for recreational purposes. The waterways under the

I have been asked by the Minister for Housing, Local Government and Heritage, Mr Darragh O'Brien TD, to refer to your letter of 26 January 2022 regarding the adoption Limerick City and County Council of a recent motion in relation to the directly elected mayor of Limerick and the date of the first mayoral election.

The General Scheme of the Local Government (Directly Elected Mayor with Executive Functions in Limerick City and County) Bill 2021, which was approved by Government and published in April 2021, is in line with the 2019 Government policy proposals for a directly elected mayor with executive functions and reflects many of the recommendations of the Report of the Implementation Advisory Group (IAG).

Following the publication by the Joint Oireachtas Committee for Housing, Local Government and Heritage of its Report on Pre-Legislative Scrutiny of the General Scheme in November 2021, the recommendations of the Committee's report are under consideration with a view to their incorporation in the Bill in such a way that it will build on the work of the Implementation Advisory Group.

Drafting of this complex Bill is progressing steadily and publication of the Bill has been identified as a priority for the Department as soon as practicable in 2022. The time frame for its passage through the legislative process will then be a matter for the Oireachtas. The timing of elections for a mayor in Limerick will be decided by Government once the legislation is enacted.

At the recent meeting of Westmeath County Council held on 24 January 2022, the following resolution was passed, and it was agreed to circulate it to all Local Authorities for your attention:

Cllr. Emily Wallace:

"There are 82 children with Spina Bifida and/or Hydrocephalus currently requiring urgent Orthopaedic intervention.

This was brought to the attention of the Minister for Health Stephen Donnelly's in Decembe: 2020 (1).

However, no action has been instigated by the Minister to resolve this matter and these children continue to deteriorate.

Lack of surgical intervention has caused their limbs and bodies to become deformed and maimed. Some of these children legs are no so badly affected that the soles of their feet permanently rub together causing open sores and bleeding.

Children who have the ability to walk are losing or have lost that ability due to the absence of timely surgical management. Others who are manual wheelchair users, due to the same issue are unable to self-propel themselves effectively leaving them immobile.

The lack of timely surgical intervention means that effectively these children end up requiring more complex surgeries and failing that amputation of limbs.

I am calling on the County Council to write to the Minister for Health, Stephen Donnelly and fast track these children for surgical review as a matter of urgency.

We also wish to call on the Minister for Health to ensure that provision of services is made to Disabled Children within elective Hospital settings as well as acute Hospital settings to avoid a repeat of this situation in the future."

The elected members of the Northern Committee of Cork County Council, with the support of the elected members of Limerick City & County Council, wrote to Irish Water in March 2019 highlighting the urgent need for a new or expanded wastewater collection and treatment system to serve the residents of Kilbehenny and Carriganne on the Cork/Limerick border. The water services departments of both councils had submitted asset needs briefs for a sewerage scheme to serve these areas in December 2016.

Attached is a copy of the letter from the Northern Committee dated 25th March 2019 and the response received from Irish Water dated 18th April 2019 which said that the matter had been referred to the relevant department within Irish Water and that a member of the team would be in contact as soon as further information became available. However, there has been no sign of progress and no further contact from Irish Water to date.

At the December meeting of the Northern Committee members again expressed strong concerns about the impact of the current inadequate public wastewater treatment system near Kilbehenny combined with the level of unserviced development in the village of Kilbehenny and at Carrigane. The members feel that this poses a significant public health and environmental risk which merits urgent attention. They resolved to liaise with Limerick City & County Council seeking agreement to make a renewed joint submission to Irish Water on this issue. The elected members of Limerick City & County Council considered the matter at a full council meeting on 14th January 2022 and agreed that a joint letter should issue from both local authorities.





We therefore request, on behalf of both authorities, that Irish Water would urgently address this issue and would provide a prompt update to the elected members on their plans.

I would welcome your response to this for the purpose of informing members of the committee.
