At the next Meeting of the Metropolitan District of Limerick, we will ask that Limerick City and County Council continue to investigate the potential discharge of pollutants into the Loughmore Canal, Barnakyle Stream, Barnakyle River, Maigue River and Lower River Shannon, and consider, where appropriate, serving Notice under Section 12 of the Local Government (Water Pollution) Acts, 1977 and 1990, to businesses discharging pollutants to drains, specifying measures to be taken in order to prevent pollution. To also work with relevant bodies to develop an Industrial Wastewater Treatment Plant to remove litter, oils and toxic compounds from water before discharge and compile a list of all waste products discharged to these watercourses and liaise with the EPA to determine if discharge licences are required.
