Economic Development and Enterprise Directorate

1. Trade & Investment

- Vitalograph, which produces respiratory diagnostic devices and based in Ennis since 1974, announced the opening of a new site in Engine, Upper Cecil Street, Limerick, creating 100 new jobs.
- Sports Retailer, Decathlon, announced the opening of a new store in the Parkway Retail Park, which will create 60 new jobs.

2. Local Enterprise Office (LEO) Limerick

Funding Approved

- Six businesses were approved funding at the April Evaluation and Approvals meeting to include three Priming Grants, one Business Expansion Grant and one Agile Research and Development Grant to a total value of €310,364.
- 10 businesses were approved for the LEO Trading Online Voucher.

National Enterprise Awards

The Limerick Local Enterprise Awards took place in April with the following awards:

- The Entrepreneur of the Year 2022 Award for Limerick went to Kilteely Dromkeen Innovation Limited, Kilteely.
 KDI is a green company which process and export recyclables and will go on to represent Limerick in the National Finals.

 A Lifetime Achievement Award was made to Bernie Carroll, Student Programmes Ireland Limited (SPIL), who has provided additional income for over 2,500 host families in Ireland over the last 13 years.

FILM IN LIMERICK

· New Film and TV Crew Hub Manager Appointed

Film in Limerick welcomed Rachael Power as the newly appointed Manager for the Munster Film and TV Crew Hub, which is being set up at Innovate Limerick. The training hub, one of three country-wide, is being set up with Screen Ireland support to deliver on-site training for new entrants looking to work in the screen industries, as well as advanced training for those currently working in the industry who are looking to upskill and progress their careers.

Training in Producing and Screenwriting

Our Introduction to Creative Producing course with 15 participants, and our Writers Factory: Introduction to Screenwriting course with 20 participants, continued in April. Both courses are supported by Limerick and Clare Education and Training Board.

· Double Blind - Feature Film Wraps in Rathkeale

The €1.5 million Horror / Thriller feature, funded by Screen Ireland and facilitated by Innovate Limerick / Film in Limerick, has wrapped filming after a 25-day shoot in Rathkeale and at locations in the city.

Production Support

Innovate Limerick / Film in Limerick has been working closely with Fantastic Films to facilitate the production 'Woken,' starring Maxine Peake, filming in Clare and Limerick, and with Treasure Entertainment on the filming of Season 3 of 'Smother.'

The Mid West Regional Enterprise Plan (REP)

To coincide with the launch of the new regional enterprise plans across the country, a new €5 million funding scheme has been announced - The Regional Enterprise Innovation

Scoping Scheme (REISS). See link to relevant documents and further details here: Link

The new scheme will enable the investigation of early stage concepts or accelerate the progress of significant projects seeking to develop new enterprise activities. The new scheme has two separate offerings:

- Feasibility Funding to deliver Feasibility Studies on specific collaborative and innovative projects. A REISS Feasibility Grant with 80% grant support to cover consultancy and travel costs for smaller early stage feasibility projects, up to a maximum grant of €50,000, and
- Priming Funding to scope out detailed project delivery plans including design, costing and planning of infrastructural elements. A REISS Priming Grant with 80% grant support to cover Consultancy and Travel, but also supporting the cost of Personnel, Promotion and the Rental of Office space for larger scale more significant scoping projects, up to a maximum €200,000 in grant aid per project.

A number of high-quality applications from the Mid-West, aligning with the actions of the new REP, are expected to be submitted by the closing date.

4. Forward Planning

 Work continued on the preparation of the draft Limerick Development Plan 2022-2028 with the drafting of the Chief Executive's Report on the submissions received during the public consultation of the Material Alterations. A total of 39 valid submissions were received within the public consultation period, which closed on 01 April.

5. Digital Services

12 April saw the submission of the response of Limerick City and County Council to the Data Protection Commissioner's final report on our Community CCTV Scheme. This submission was the culmination of three

months of intensive work by a dedicated core team which included the Head of Digital Services, the Data Protection Officer and representatives from An Garda Síochána, Arup (public realm CCTV experts) and O'Flynn Exhams Solicitors firm (data privacy specialists). The scope of works involved included:

- The identification and mapping of all CCTV cameras controlled by Limerick City and County Council.
- Auditing all cameras in conjunction with An Garda Siochána for their proportionality, necessity and justification in relation to General Data Protection Regulation.
- Turning off all cameras which failed the proportionality, necessity and justification test.
- Redefining all cameras under four schemes Northside, Southside, Canal and River Bank, Hinterland, and developing a Data Protection Impact Assessment for each one.
- Public consultation carried out on all four schemes online via My Point and within the communities at focus meetings with the Regeneration Team.
- Completing An Garda Síochána Community CCTV applications for all schemes.
- Development and sign-off of a Joint Controller Agreement between Limerick City and County Council and An Garda Síochána.
- Developing a CCTV oversight board, updating data processing agreements, updating limerickie and updating our CCTV policy, along with many other supporting documents.
- CCTV sign locations were identified, with signs ordered for installation.

EU Programmes

- Members of +CityxChange and EU Programmes Teams met with the International Energy Research Centre (IERC) based in Cork. The positive city exchange project was discussed, as well as the Up-Stairs project, and areas of commonality were found, particularly around one-stop-shops and digital twins, leaving the door open for future collaboration.
- Took part in the Budafok transnational meeting as part of the Find Your Greatness project. Limerick was

represented by a physical presence though the URBACT local group chair, and online by the EU Programme Manager. This meeting focused on tourism and the improvement and finalisation of Integrated Action Plans.

 The Horizon Europe SURE proposal was submitted on 26 April, led by Technopolis Group. If successful, this project will enable Limerick City and County Council to identify, plan, and design integrated urban planning and urban regeneration solutions and measures for the existing built environment. Should the New European Bauhaus application be successful, this project would complement it well.

Revised Draft Limerick Shannon Metropolitan Area Transport Strategy

The National Transport Authority (NTA) presented the revised Limerick Shannon Metropolitan Area Transport Strategy (LSMATS) on 26 April in an online briefing to all members of the Oireachtas, Elected Members and Councillors. The Strategy was also presented by the NTA to all Travel and Transportation Strategic Policy Committee members on 27 April. All documents are available to download from the NTA website here.

Submissions

Submissions or observations with respect to the Limerick Shannon Metropolitan Area Draft Transport Strategy 2040 and/or associated Strategic Environmental Assessment (SEA) Environmental Report and/or associated Appropriate Assessment (AA) Natura Impact Statement will be taken into consideration in the finalisation of the transport strategy.

2. Active Travel

Projects

Limerick Active Travel received funding approval from the National Transport Authority for the following schemes:

Metropolitan District of Limerick - Asset Renewal (Cycle Tracks and Greenways)

Scheme	Details
Baggot Estate Upgrade Cycleway	Scheme comprises a new combined cycleway/footpath (approx. 440m) with public lighting linking into the existing cycle path network in Baggot Estate, connecting Dooradoyle Road to Rosbrien Road, providing access to Crescent Shopping Centre and onward to UHL.

These schemes are in addition to the Active Travel schemes previously approved by the NTA this year.

Works

- Castletroy Urban Greenway Limerick Active Travel planted 15 trees along the newly opened Castletroy Urban Greenway.
- Childers Road Work continued on a new two-way segregated cycleway between the Roxboro Roundabout and the Kilmallock Roundabout. Once complete, the new stretch of cycleway will link up with the existing two-way segregated cycleway between Kilmallock Roundabout and Parkway.
- Ballykeefe Roundabout to St. Paul's work is underway to remove the central reservation between the Ballykeeffe Roundabout and St. Paul's junction. This is to allow for the installation of kerb segregation on the on-road cycle lane on the outbound carriageway.

Marketing and Communications

 Active Travel issued one Press Release to coincide with the installation of an Active Travel display along the Castletroy Urban Greenway. The display includes almost sixty essays and pieces of artwork by the children of Gaelscoil Chaladh an Treoigh.

- Active Travel produced one video for social media on the installation of the Active Travel display along the Castletroy Urban Greenway.
- Active Travel tweeted eight times via the Limerick Council Twitter account with total followers now of 17,200.
- Active Travel posted three times on the Limerick Council LinkedIn account.
- A member of the Active Travel Team visited third class pupils at An Mhodscoil and St. Nessan's National School in Mungret to deliver Active Travel workshops. More than twenty students took part in each workshop with more engagement sessions to follow elsewhere in Limerick.

1. Urban & Rural Community Development

Local Community Development Committee

The April meeting of the Local Community Development Committee (LCDC) was held on 05 April. The Local Action Group (LAG) approved funding of €296,648.66 under the LEADER Programme 2014-2022 (€192,844.16 funded from the Transitional LEADER Programme and €103,804.50 funded from the European Union Recovery Instrument Fund).

Limerick Public Participation Network (PPN)

PPN Plenary (i.e. members') meeting held. Agenda included presentation on Community and Local Government response to Ukrainian displaced persons arriving in Limerick, as well as a programme to promote Limerick Autism Friendly which will provide training to Council staff and community groups.

Also considered at the meeting was the 2022 PPN non-financial and financial report, draft 2022 work plan and budget, ratification of successful PPN candidates from 2022 elections.

Changes to the PPN Constitution following a Department of Rural and Community Development Circular indicating an amendment to the PPN Handbook published by the Department at the end of 2020, was also considered.

Two PPN Linkage Group meetings took place in April - the Community, Leisure and Culture and Home and Social Development Linkage Groups. Details of all Linkage Groups are on the Limerick PPN website.

Membership of the PPN continues to grow and now stands at 179. The membership registration form is on the PPN website and eligible groups in Limerick can register at any time.

Limerick PPN continued to have an active social media presence on Twitter and Facebook.

Visit of Minister Heather Humphreys, TD, to Rural Development Projects in West Limerick

On 08 April, the Minister for Rural and Community Development, Heather Humphreys, TD, visited a number of rural development projects in West Limerick. She formally launched projects completed with funding support from the LEADER programme and the Town and Village Renewal Scheme, Department of Rural and Community Development, in the presence of the Mayor of the City and County of Limerick, Councillor Daniel Butler. Projects officially opened by the Minister were Roots Community Shop and Café, Kilmeedy, Dromcollogher Community Park, Ashford Social Hub, Ashford, Barnagh Greenway Hub playground, Ardagh Astro Turf facility delivered by Ardagh District Recreational and Sporting Company and ENGINE E-Hub Abbeyfeale. The Minister and her officials also visited Council-led rural development projects, namely Ardagh Station House where conservation works have been completed on the Station House, the site has been landscaped and plans are advanced to develop Ardagh as a Hub on the Limerick Greenway, with funding support from the Rural Regeneration and Development Fund (RRDF), and the Railway Goods Shed Rathkeale, where plans are in progress to re-develop this building and site as a services Hub on the Limerick Greenway. The Minster unveiled a large wood sculpture of the Ardagh Chalice at the Ardagh Station site. The Minister received a tremendous welcome by the communities in West Limerick towns and villages who were proud to present their achievements and showcase their projects.

Team Limerick Clean Up

In its seventh year, Team Limerick Clean-Up (TLC7) returned to a community gathering format post COVID on Good Friday, 15 April. A record number of 21,300 volunteers set about giving the city and county a spring clean with the tea/coffee gatherings making a welcome

return at various community locations. TLC is a unique collaboration with Limerick City and County Council, communities, public agencies and private partners in terms of an environmental countywide initiative. The collaborative nature of TLCs, with key stakeholders including the citizens of Limerick, schools around the county, along with key partners in Mr. Binman and the McManus Benevolent Fund, promotes sustainable environmental goals and lifelong learning in relation to the environment, particularly in schools. Those that took part included community groups, residents' associations, sports clubs, schools, businesses, families, and charities.

Ukrainian Supports

Limerick City and County Council continued to support displaced Ukrainians arriving in Limerick. The supports are being coordinated by both the Housing and the Community, Tourism and Culture Directorates. The International Provision Accommodation Service (IPAS), a Government Department, manage the allocation of accommodation for the Ukrainians on entry to Ireland and the Council notifies them of possible accommodation options such as multi-occupancy buildings, hotels etc. IPAS manage the contractual options with private sector providers.

Hotel Accommodation, mostly in the city, is the primary option being utilised but rest centres have been established in Ardagh, Foynes, Pallaskenry, Ballynanty, Castleconnell and Kilfinane.

Social Housing options are not being used to ensure there is no impact on Social Housing Applicants.

The Urban and Community Development Team lead the co-ordination of support services for the Ukrainians and the Ukrainian Community Response Forum meets weekly. The membership includes the Mayor of the City and County of Limerick, Councillor Daniel Butler, all state agencies and other key stakeholders and is chaired by the Chief Executive.

Age-Friendly

Croke Park recognised as the first Age Friendly Stadium in the World

On 07 April, Croke Park Stadium was formally recognised as being Age Friendly by the World Health Organisation (WHO) Global Network of Age Friendly Cities and Communities and Age Friendly Ireland. This designation comes after the stadium undertook a process of change to ensure that older people could continue to enjoy the facility, regardless of how their needs change across the course of their lives. The development of Croke Park as an Age Friendly Stadium is very welcome having regard to the projected increase in numbers of older people in society in years to come. The announcement was welcomed by Alana Officer, Unit Head, Demographic Change and Healthy Ageing at the WHO, Peter McKenna, Croke Park Stdium Director and Catherine McGuigan, Chief Officer, Age Friendly, Ireland.

Age Friendly Ireland is a local government-led programme working in partnership with other key service providers. Collaboration is key to successfully creating an Age Friendly Ireland and Croke Park is a stellar example of what can be achieved through cooperation and collaboration. Limerick City and County Council is an active members of the National Age Friendly Programme and leads on the delivery of the programme in Limerick.

2. Tourism

King John's Castle ownership transfers to Limerick City and County Council

A new chapter has begun in the long history of King John's Castle in Limerick with the transfer of ownership and business operations to Limerick City and County Council.

All business operations and staff at King John's Castle have transferred from Shannon Heritage to Discover Limerick DAC, a wholly owned subsidiary of Limerick City and County Council, established specifically to operate and develop key tourism attractions in Limerick that will

strengthen Limerick as a destination and attract increased visitor numbers.

King John's Castle is the first attraction to come under the Discover Limerick umbrella. The 14 staff, who had previously worked in the Castle for Shannon Heritage and contributed significantly to its success, have transferred to Discover Limerick with no change to their employment terms and conditions.

King John's Castle will remain open seven days a week, welcoming people from near and far.

Located at the heart of Limerick's Medieval Quarter, King John's Castle is the largest tourist attraction in Limerick city. It brings to life more than 800 years of dramatic local history through the art interpretive centre and exhibition showcases which tell the story of the most iconic building in Munster.

With around 100,000 visitors annually, the towers of King John's Castle provide panoramic views across Limerick city and the River Shannon.

A reception to celebrate the transfer of King John's Castle to Discover Limerick DAC and Limerick City and County Council was held at the Castle on 05 April, attended by the Mayor of the City and County of Limerick, Councillor Daniel Butler; the Chief Executive of Limerick City and County Council; CEO, Shannon Group, Mary Considine; Interim Chair, Discover Limerick DAC, Tim O'Connor; elected representatives, officials and invited guests.

The Mayor of the City and County of Limerick,
Councillor Daniel Butler, said: "This is a wonderful
start to a new era for King John's Castle. I would like
to acknowledge and thank Shannon Heritage for their
stewardship of King John's Castle for the past 30 years.
With the Castle back under Limerick control, we are
the masters of our own destiny. We have a wonderful
attraction here that we all need to support and showcase
in whatever way we can. And I would encourage all
Limerick people to come and visit King John's Castle over
the coming months. Great attractions on our doorstep are
for locals as well as tourists."

Dr. Pat Daly, Chief Executive of Limerick City and County Council, said: "As the country emerges from a two-year pandemic, tourism recovery is a vital objective for Limerick City and County Council and the wider tourism industry in Limerick. The transition of the Castle from Shannon Heritage to Discover Limerick DAC presents an exciting opportunity for Limerick to grow and develop the tourism industry in the city and county."

Commenting on the transfer, Mary Considine, CEO, Shannon Group, said: "I would like to wish Limerick City and County Council every success as it takes on King John's Castle and, in particular, to thank the Council for working very closely with us to ensure a seamless transfer. The support of the Departments of Transport and Housing, Local Government and Heritage, along with the Department of Public Expenditure and Reform, and our close collaboration with the Council, ensured a smooth transition for our staff at King John's Castle, for which we are most grateful."

On 04 April 2022, King John's Castle entered a new period in its history, with the transfer to Discover Limerick DAC, a wholly owned subsidiary of Limerick City and County Council.

Global Irish Festival Series Launch Event

The Global Irish Festival Series, a Fáilte Ireland and Department of Foreign Affairs initiative, aims to harness diaspora links for the benefit of local and community tourism. The Global Irish Festival Series was officially launched internationally by the Minister of State for Overseas Development Aid and Diaspora, Colm Brophy, TD, at the Consulate General of Ireland in New York on 20 April. Attendance at the event included representatives from Fáilte Ireland, Tourism Ireland, Limerick City and County Council, County Associations, Tour Operators, Irish American Groups, Aer Lingus and key media.

A joint initiative between Fáilte Ireland and the Department of Foreign Affairs, the Global Irish Festival Series aims to encourage diaspora to return home to visit Ireland and provides funding and support, through Local Authorities, for events that tap into international diaspora networks with support from Tourism Ireland. The annual Global Irish Festival Series was initially launched in 2018. This year, the series returns after a two-year hiatus due to the pandemic and is once again supporting Limerick City and County Council on Global Limerick with an investment of €30,000.

3. Arts Office

Riverfest

Now in its 18th year, Riverfest Limerick kicked off on 29 April and attracted families and festival lovers from all over Ireland who enjoyed everything from Irish Naval Vessel tours, stand up paddle boarding, kayaking to zip lining across the River Shannon.

Open Calls

Platform 31

Stage 1 Assessment process took place on 07 April for Platform 31, a nationwide artist development scheme by the 31 Local Authority Arts Offices, in collaboration with the Arts Council. The shortlisted artists were submitted for Stage 2.

Strategic Fund

In April, one letter of support was issued to the Music Network Capital Scheme for application to the Strategic Fund for Culture and Arts Scheme.

Creative Ireland

Creative Ireland Made in Limerick Grants 2022

The Assessment Panel for Creative Ireland Made in Limerick Grants 2022 met on 27 April to make recommendations on all eligible applications according to the criteria of the award. Of the eighteen applications received, the Panel recommended eleven applicants for funding. These grants are offered as part of Limerick Creative Ireland Programme to deliver activities taking place in 2022.

Creative Ireland Bilateral Meeting

A Creative Ireland Bilateral meeting took place with the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media officials from Dublin, with presentations from two members of the Creative Ireland Programme team, Sheila Deegan, and Eamonn Kelly, Principal Officer. It took place in the Council Chamber, Corporate Headquarters, on 25 April. The Creative Ireland programme has "in-principle" agreement for a further five-year framework for the Creative Ireland Programme. The presentation focused on the development of Limerick's Culture and Creativity Strategy 2023-2027.

5. Libraries, Gallery & Museum

Library

- The City Library marked Limerick Writers' Centre annual April is Poetry Month festival by hosting a series of lunchtime lectures. The series began on 01 April with Kieran Beville's talk entitled "The Transformational Power of Confessional Poetry." On 08 April, Micheál Ó hAodha discussed the Irish poet, Seán Ó Ríordáin. On 22 April, Fiona Clarke Echlin gave a talk entitled "Poetry, Symbolism and the Sea." The lecture series successfully concluded on 29 April with Dr. Arthur Broomfield's presentation on surrealism in poetry. Book clubs made a welcome return to in-person meetings this month. On 11 April, the library hosted the Limerick University of the Third Age Book Club and the second Wednesday Book Club met on 20 April. All those in attendance were delighted to be back in their local library to meet and chat again. On 28 April, a special pop-up book club was held with Joachim Fischer, Jean Monnet Chair in European Cultural Studies, University of Limerick. The session took a 'novel' approach to discussing the European Union by reading "The Capital," by Robert Menasse. The novel combines a murder mystery, humour and satire with considerable insights into the inner workings of the European Commission. To celebrate Easter, the Easter Bunny hid some Golden Bunny bookmarks in books in the Children's Library. Children lucky enough to find the bookmarks received
- a special Easter prize. The branch was thrilled to welcome back local author, Róisín Meaney, on 23 April for the monthly children's storytime. A rapt audience thoroughly enjoyed listening to Róisín weave her storytelling magic as she drew illustrations to accompany the tales. School and class visits continued with regular weekly visits from St. Michael's National School and CBS Primary School. This is a wonderful initiative aimed at children who are starting school in 2022. Each bag contains a selection of books on starting school and making friends. Each new member receives a library card with a special 'My Little Library' cardholder. Book bags are available in both Irish and English and Library branches were happy to welcome all the four and five year old children to collect their book bags and begin their library membership journey. Limerick Libraries were delighted with the interest shown.

Limerick City Gallery of Art (LCGA)

- The major celebration of the work of Limerick artist,
 Tom Fitzgerald, continues to attract significant numbers
 of visitors. The exhibition, Spirit Music, includes work
 from private and public collections including Limerick
 City and County Council and University of Limerick. A
 publication to accompany the exhibition was
 launched on 09 April with opening remarks by Marian
 Fitzgibbon; The exhibition catalogue is fully illustrated
 with contributions from architect, Sean Ó Laoire, and
 academics, Gerry Dukes and Niamh Nic Ghabhann.
 Over 150 people attended the launch event.
- LCGA is one of eight venues hosting the major exhibition, BELONGING, from the collection of the European Investment Bank (EIB), which closed on 24 April. This was a unique opportunity to view work by

predominantly European artists who are not represented in the collections of Irish institutions. 8,311 visitors attended the exhibition during its run at LCGA.

- LCGA facilitated the performance by CIKADA Circus on 17 April as part of the BELONGING ancillary programme.
- LCGA facilitated a workshop on O2 April as part of Catalyst International Film Festival taking place in Limerick venues for the weekend.
- LCGA hosted the launch and reading by Imelda Maguire from her second poetry collection on 24 April as part of the Limerick Writers' Centre Poetry Month programme for April 2022.
- The collaboration between LCGA and Dance Limerick continues to develop with a series of workshops with The Model in response to Fitzgerald's exhibition, Spirit Music. The other schools involved in this project are St. Michael's and Limerick School Project. The documentation of this project was supported with funding from Creative Ireland.
- Test Space residencies began on 11 April with Fiona and Rowena Quill, both of whom are printmakers appointed as our in-house artists in residence, while Rachel Rockwell, an artist from Wexford, was awarded the on-line residency. This initiative was piloted at the end of 2021 and we successfully applied for and received funding from the Arts Council to develop this project. This initiative fulfils one of the objectives of our Strategic Plan to support and promote artists in practical ways.
- Siobhan O' Reilly has selected significant sculptural works from the Permanent Collection to reflect Tom Fitzgerald's work in the ground floor galleries. The installation by Alicia Clooney marks her award for her piece of work in the 2020 Degree Show in Limerick School of Art and Design.
- LCGA continues to support the University of the Third Age hosting its monthly Poetry and Music groups.

Limerick Museum

 first live exhibition held in the Museum for two years,
 The Works We Thought We Had, opened to the public.
 It is a group exhibition of artists from seven countries,
 curated by well-known artist, Maurice Quillinan, and Dr.
 Matthew Potter, Curator of the Museum.
- Limerick Museum has commenced a new collaboration
 with the newly established Discover Limerick
 Designated Activity Company (DAC), which has been set
 up to administer King John's Castle. This is a
 continuation of the previous collaboration with
 Shannon Heritage, under which the Curator of Limerick
 Museum is also curator of a significant collection of
 artefacts on loan from the National Museum of Ireland,
 which is currently on display in the Castle.

- As part of the Museum's ongoing and very active outreach programme, the Museum Curator gave lectures on the history of the Museum to Raheen Men's Shed (07 April) and Limerick-Shannon Ladies Probus Group (27 April). He gave a walking tour of the history of the Three Bridges to the Limerick City and County Council Active Retired Association on 26 April.

Community Sustainment Unit

The Community Sustainment Unit is comprised of three main strands: (i) Estate Support (ii) Individual Tenant Support and (iii) Tenancy Enforcement/Anti-Social Behaviour.

(i) Estate Support

The main aim of this programme is the provision of supports with a view to improving quality of life and developing community spirit within Council estates. To this end, the Unit works closely with existing residents' associations and encourages the formation of new such groups, supporting the implementation of key actions identified by them to improve their estates. The support provided varies from assistance in provision of minor infrastructural works such as fencing, walls, signage etc. to softer measures such as committee skills training, contributing towards clean-up days, events for children etc.

Works were carried out by the Community Sustainment Unit on 07 April in the Cois Má estate in Croom. This comprised the supply and installation of railway sleepers and bark mulch to accentuate a tree and plaque originally planted and erected by Cois Má Residents Association a number of years ago. This marks the 30th Anniversary of this community being together. This Residents' Association is an active working group improving the local area.

(ii) Individual Tenant Support

The Unit provides a service, supported by the Housing Welfare Officer, of intensive support for tenants who may be identified as vulnerable or in need of such help for any other reason. In addition, there is monitoring of individual tenancies that may require particular attention to prevent problems occurring. There is an ongoing programme to reach out to all tenants in our estates. During the month of April, 152 such visits were carried out by the Community Sustainment Officers.

Tenancy Induction training is provided for all newly-appointed tenants. Among other things, the terms of the Letting Agreements which are signed are clearly explained so that the obligations of both the tenants and, indeed, the Council are clearly understood. 10 such inductions took place during April.

(iii) Tenancy Enforcement/Anti-Social Behaviour

The Unit deals with in excess of 400 complaints each year, with approximately half of these relating to anti-social behaviour. The Council's policy is to respond to these issues quickly and firmly and it works in close co-operation with An Garda Síochána where necessary. The number of active cases at end of April was 171. The number of cases closed during April was 13.

The Unit carries out formal Garda checks on prospective new tenants. 98 such formal reviews were undertaken during April. April 2022 25 of 50



Customer Services

The Customer Services Case Management Team continued working with key service areas of the Council in supporting the closure and update of representations from Elected Members as well as the general public. April saw a total of 2,473 cases created, with 633 of these being on behalf of Elected Members, and a total 3,888 closed, with 1,248 of these being on behalf of Elected Members.

Throughout the month, a number of enquiries were received from the public via telephone, email and the public counter, seeking information regarding the housing options available for Ukrainian citizens who have temporarily located to Ireland. The Customer Services Team directed these people to the official government information sources.

• The following figures highlight the activity within the contact centre throughout April:

- Customer Services Call Centre answered 9,702 calls.
 This represents an average of 511 per day, with the number of calls exceeding 550 on several occasions.
 58% of calls were handled at first point of contact.
- April saw a total of 3,001 emails processed through the Customer Services email platform.
- The logging of cases through the MyLimerick portal continued, with a total of 285 cases being logged, 254 of which were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating the service requests and keeping citizens up to date on progress made. Throughout the month, Customer Services logged 91% of cases for Housing Maintenance in the Metropolitan District, and logged 68% of all Housing Maintenance cases throughout the Municipal Districts.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Burning of Agricultural Vegetation Permits, 15 of which were processed in April with 13 being issued, as well as processing 94 new applications for Residential Parking Permits and issuing 65.
- Customer Services staff welcomed a total of 1,873 visitors to its public counters in both Merchant's Quay and Dooradoyle.
