I will ask at the next Meeting of the Metropolitan District of Limerick if the Council has any plans to review rents for Council tenants to help cope with the increased cost of living.

**REPLY**

There are no such proposals planned. There is a very marked difference between the Council's Differential Rents Scheme and rents payable in the private sector, in that the former is based on household income and the latter is dictated by market forces. The rent of Council tenants may therefore vary, either up or down, in accordance with the income of household members at any particular point in time, which provides a level of security not enjoyed by those renting privately. The average weekly Council rent at the moment stands at €62.25.

### Reply to Question

Limerick City and County Council is responsible for the coordination and management of Riverfest Limerick when the city becomes a mecca for families, foodies, fun runners and water sport enthusiasts throughout the May bank holiday weekend each year.

The annual festival is a celebration of the city's position on the tidal River Shannon and its designation as a Gateway City to the Wild Atlantic Way, echoed in our brand positioning Limerick Atlantic Edge, European Embrace.

Riverfest Limerick is an opportunity to showcase the city's energy, excitement, grit and limitless possibilities from its Atlantic location, while acting as a stage for street artists, live music and cultural events throughout the May bank holiday weekend.

After a two-year absence, Limerick's biggest festival made a welcome return from Friday 29 April to Monday 02 May 2022 featuring lots of family favourites including Riverfestival Village, BBQ on the Boardwalk, River Shannon Zipline and Irish Naval Vessel tours along with new additions Riverfest Limerick Scavenger Hunt and Party in the Park.

Riverfest Programming and associated expenditure are the responsibility of Festivals & Events.

The Marketing & Communications Department has overall responsibility for the marketing of Riverfest weekend locally, regionally and nationally.

MarComms is responsible for the creation of a weekend guide, which highlights Riverfest and other events taking place in Limerick over the May Bank Holiday, known locally as Riverfest weekend.

It also schedules online and traditional ads across various media, online promotion of programmed events, daily coverage of a selection of the events, installation of Riverfest collateral on flagposts etc and the PR surrounding the weekend.

Marketing & Communications devised and managed a nationwide four-week multimedia marketing campaign from 04 April 2022 across social, digital, radio and print media.

The call to action across all our marketing activities was **Riverfest.ie**, managed and updated by the Limerick.ie team.

Extremely positive coverage was received across various media including: Virgin Media Television, Todayfm, Newstalk, Classic Hits, Limerick Leader, Live95, Limerick Post, TippFM, Spin SouthWest, Irish Times, Irish Independent, Sunday Independent and the Irish Examiner.



I will ask at the next Meeting of the Metropolitan District of Limerick can the Council provide a detailed overview of the plans for the combined works on the Graveyard Boundary Wall for Mount St Oliver; the plan to widen the road at Georgian Village to Good Council Nursing Home; and the design for the Roundabout at Rosmór, Old Cork Road.

### Reply:

#### Part A – Graveyard Boundary Wall

The next stage of the above project is to prepare tender documents, issue for tender, appoint a building contractor and commence construction.

#### Part B – Works to Roadway

Active Travel are currently working on a scheme, which incorporates a 3 metre Shared Active Travel Path connecting the Willows Housing Estate to the Ros Mor Housing Estate. This scheme also incorporates a roundabout and bus stop at the entrance to Ros Mor to facilitate the extension of the bus route to this estate. The design for this scheme is almost complete and a formal public consultation for Part 8 Planning permission is likely to commence in the coming weeks. The Active Travel Team will facilitate a briefing on the scheme to the Elected Members in advance of advertising the Part 8.
