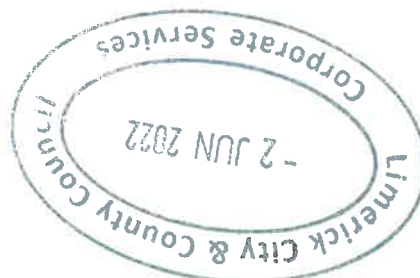

Dear Mr Leahy,

I refer to your correspondence dated 25<sup>th</sup> April 2022 regarding a motion that was adopted by Councillors at the 19<sup>th</sup> April 2022 meeting of the Metropolitan District of Limerick.

In 2020, the Authority asked Bus Éireann to liaise with Limerick City and County Council to ascertain any infrastructural requirements that would be required to facilitate Route 329 stopping additionally on Childers Road in the vicinity of pedestrian access to Flanker Court/ Glasgow Park. Given the narrow width of the strip on the south side of Childers Road, a pair of stops could not be accommodated at that time. In the meantime, a double cycle track has been installed along the north of Childers Road which further diminishes the feasibility of providing a pair of stops at this location. Given these constraints, the Authority cannot serve these areas from Childers Road with Route 329.

I trust that this clarifies the Authority's current position on the matter.
