Pursuant to Section 20(3) of the Planning and Development Act, 2000 (as amended), Limerick City and County Council, hereby gives notice that it

intends to revoke the existing Local Area Plans for Castletroy, the Southern Environs and Kilfinane.

The Limerick Development Plan 2022 - 2028 is currently in Draft format and the Draft Plan includes written statements and maps for all of the settlements that were previously included in the above Local Area Plans. The Planning Authority consequently proposes to revoke these Local Area Plans.
