1. Adoption of Minutes

2. Appointment of Chief Executive

Circulated, report from the Mayor of the City and County of Limerick, Councillor Daniel Butler, dated 17th May, 2022.

The report stated that at a meeting of the Corporate Policy Group held on 16th May, 2022, the recommendation of the Public Appointments Service of 12th May, 2022, that Mr. Pat Daly be appointed to the post of Chief Executive, Limerick City and County Council, was considered. The view of the Corporate Policy Group was that the recommendation should be accepted.

On the proposal of Cllr Sheahan (J), seconded by Cllr Collins (M), the Members agreed to meet 'in committee' for a period to discuss this recommendation.

Following the resumption of the Full Council Meeting, the Meetings Administrator confirmed that as the appointment of the Chief Executive was a Reserved Function, that a resolution of the Council was required.

3. Filling of Casual Vacancy

Circulated, report of the Senior Executive Officer, Corporate Services, Governance and Customer Services, dated 21st April, 2022.

The Meetings Administrator advised that the procedure for the filling of the casual vacancy on the Council consequent on the resignation of former Councillor, John Costelloe, was set out in Section 19 of the Local Government Act, 2001, as amended, a copy of which had been circulated to the Members. He also confirmed that all of the required documentation in relation to the co-option had been received and was in order.

As there were no other nominations, the Mayor declared Mr. Collopy co-opted as a Member of Limerick City and County Council for the Metropolitan District of Limerick and welcomed him as a Member of the Council. The Members congratulated Cllr Collopy on his co-option as a Member of Limerick City and County Council and wished him well in his role going forward as an Elected Member.

Councillor Collopy took his seat in the Chamber and thanked all the Members for their good wishes, and he stated that he was proud to become a Member of Limerick City and County

Council. He looked forward to working with all the Members, Management and staff in representing the people and dealing with all the issues and challenges faced by them.

5. Declaration of Interest

The Meetings Administrator stated that, in line with Part 15 of the Local Government Act, 2001, as amended, and the Code of Conduct, she was inviting those present to notify the Mayor of any declaration of interest in any item due for discussion at the Meeting. No such interests were declared.

6. Limerick Comhairle na nÓg

The Mayor welcomed the Deputation from Limerick Comhairle na nÓg, comprising Christine Houghton (Chairperson), Presenter Andrew Purcell (Vice Chair), Josh O'Dwyer (Media Officer), and Caitlin Guckian (PRO), to the Council Chamber and they proceeded to give a presentation to the Members on the activities of Limerick Comhairle na nÓg .

They outlined how the work of Comhairle na nÓg is the responsibility of the Local Authority and the Department of Children, Equality, Disability, Integration and Youth and that the Limerick Youth Service delivers the project through a service level agreement with Limerick City & County Council. They explained that Limerick Comhairle is a place where young

people in Limerick come together to discuss and work through topics that have a significant meaning to all young people.

Some of the issues currently being worked on at present by Comhairle na nÓg include the issue of young people needing more social spaces to hang out safely (LGBTQIA+ and Autism inclusive); rural young people struggling to access public transport options; and young people would like to have more of a say in local decision making.

The Members commended the deputation on the quality and professionalism of their presentation and noted the issues being raised by them that were important to young people. The Members confirmed that they would support proposals brought by Comhairle na nÓg and encouraged Comhairle na nÓg to keep in contact with the Members in relation to these issues.

- Notify the International Protection Accommodation Service IPAS of possible accommodation options within their administrative area such as hotel accommodation, multi occupancy buildings etc. (This does not include social housing options currently available or planned for social housing applicants);
- Facilitate the co-ordination of services and supports (statutory and non-statutory) for Ukrainians arriving in their area;
- Identify potential properties/ sites to meet medium to long-term accommodation needs.

With regard to numbers, he outlined the accommodation provision breakdown for Ukrainians in relation to Limerick City and County Council's administrative area:

QUESTIONS

11. Question submitted by Councillor M. Donegan

I will ask at the next Meeting for an update regarding monitoring, maintenance and GDPR of CCTV in Limerick City and County by Limerick City and County Council.

REPLY: The Head of Digital Services has conducted a full and robust review of Limerick's Community CCTV cameras to determine the necessity, the proportionality and the justification of each camera in the Community CCTV schemes.

353 cameras met the conditions of necessity, proportionality and justification and were subsequently divided into 4 Community CCTV Schemes (Northside, Southside, Canal and Riverbank and Hinterland) with Community CCTV Scheme applications prepared and submitted to the Garda Commissioner under Section 38 of An Garda Síochána Act 2005 for approval. Only the Northside and Southside schemes are to be live monitored at present. Additional signage has been erected for each camera in the schemes along with signs demarcating the entrance to locations where Community CCTV schemes exist. CCTV maintenance for all Community CCTV cameras is ongoing.

Approximately 60 cameras were decommissioned and removed as a result of the review process. All traffic management cameras were decommissioned since no legal basis currently exists for their operation. National legislation is being prepared that will address this particular traffic management situation.

Limerick City and County Council is currently awaiting the approval from the Garda Commissioner for each of the Community CCTV Schemes submitted.

Work is ongoing within Limerick City and County Council to devise a CCTV Strategy and build a CCTV function to take care of the operations of Community CCTV and be prepared for upcoming legislation that supports the use of CCTV.

12. Question submitted by Councillor G. Mitchell

I will ask at the next meeting for clarification on the process (including fees and appeals) relating to the Derelict Site Register and Compulsory Purchase Orders.

REPLY: All Notices served by Limerick City and County Council are served in accordance with the Derelict Sites Act, 1990. If a property is identified as derelict as per Section 3 of the Derelict Sites Act, 1990, Limerick City and County Council will proceed to issue the appropriate Notices. The owner has an opportunity to make representations upon receipt of any Notices served. These representations are considered by Limerick City and County Council. There are no fees in terms of making an appeal to Limerick City and County Council in respect of Notices served.

If an owner is served a Section 15 Notice which is Limerick City and County Council Notice of Intention to compulsorily acquire a property under the Derelict Sites Act, 1990, the owner can appeal this decision to Limerick City and County Council. Limerick City and County Council is required in the Act to forward this appeal to An Bord Pleanála. An Bord Pleanála then makes an independent decision on the appeal. There is no cost to owner to appeal a Section 15 Notice.

13. Question submitted by Councillor P.J. Carey

I will ask at the next Meeting what plans has Limerick City and County Council to erect crash barriers, in place of current wire fencing, at Barna, Newcastle West, due to safety concerns of walkers and cyclists on exposed sections of the Greenway along the busy N21 Road.

REPLY: Limerick City and County Council has spoken to Transport Infrastructure Ireland and they currently have no plans to install vehicle restraint barriers along this section of road.

14. Question submitted by Councillor S. Keary

I will ask at the next Meeting for the total amount of money paid from January 2018 to December 2021 to private marketing consultants engaged by this Authority; the names of the consultants and the type of service that they provided to this Authority.

REPLY:

As part of the project for the new Limerick brand, M&C Saatchi were procured to develop, create and implement the brand and to devise specific marketing campaigns:

- The creation of assets for the brand launch — logo (various versions), toolkit for use by stakeholders, brand guidelines, photography, videography, the brand launch itself in St. Mary's Cathedral.
- Limerick.ie was completely overhauled from a visual point of view to reflect the new identity.
- Devised, developed and created:
 - 50 Days of Summer - Tourism Campaign 2020.
 - Double Your Summer - Tourism Campaign 2021.
 - Invest Limerick Campaigns - brochures - videos - social media assets.
 - Student Marketing Campaigns - video, social media.
 - They have provided graphic design services for the creation of a wide range of assets, including the Limerick St. Patrick's Festival and Christmas in Limerick brochures and logo creation etc., which reflect the Limerick Atlantic Edge European Embrace branding, as well as the look and feel.
 - New updated banners, pop-ups etc.
- Creating an updated brand for Adare.
- Advising on how best to leverage the Limerick story and collateral to promote Limerick on a national and international stage.

The company used local service providers to deliver on the various aspects of the projects. This gives us the ability to ensure that the same message about Limerick is being heard by all audiences - that of a place that is welcoming to all, warm yet gritty, innovative and a place that people should live in or visit.

I will move at the next Meeting that this Council to write to the Minister for Health, University Hospital Limerick and the Health Service Executive requesting that they provide an estimated timeline of when the UL Hospitals Group will become an accredited DAFNE Centre (Dose Adjustment For Normal Eating), and when the first DAFNE training will be provided to staff and to people with Diabetes.
