The outgoing Cathaoirleach, Councillor M Ryan invited nominations for the Office of Cathaoirleach for the coming year.

Proposed by Councillor Mitchell;
Seconded by Councillor E Ryan;

"That Councillor John Egan be appointed Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been appointed".

As there were no other nominations, the outgoing Cathaoirleach declared Councillor Egan elected as Cathaoirleach of the Municipal District of Cappamore-Kilmallock and offered him best wishes for the coming year.

The outgoing Cathaoirleach, Councillor M Ryan thanked the Director of Services, Transport and Mobility (Mr B. Kennedy) and the staff of the Area Office for all their courtesy, help and support during his term as Chairman of the Cappamore - Kilmallock District.

As there were no other nominations, the Cathaoirleach declared Councillor Mitchell was elected as Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock and wished him well for the forthcoming year.
