Data Protection Privacy Statement for

Drone Technology

Who we are and why do we require your information?

Limerick City and County Council seeks to lead the economic, social, cultural and environmental development of the county and to provide high quality services at local level. Our vision is for an inclusive county of sustainable urban and rural communities that have respect for their environment, a sense of local identity comprising shared purpose and a deep sense of civic pride. The promotion of a culture of excellence in service delivery remains one of Limerick City and County Council's core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment. In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of County Limerick we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being sought or provided, the information sought may include 'personal data' as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past; current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect process and use certain types of personal data to comply with regulatory or legislative requirements.

Why do we have a privacy statement?

Limerick City and County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with Limerick City and County Council that we will ensure the security of the data you provide to us. Limerick City and County Council creates, collects and processes a significant amount of personal data in various multiple formats on a daily basis. Limerick City and County Council's commitment is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

Data Protection Policy

Limerick City and County Council has a detailed Data Protection Policy which outlines how we as a public body are committed to ensuring the security of any personal data you provide to us.

What is the activity referred to in this Privacy Statement?

Use of Drone Technology for the purpose of aerial photography and videography.

What is the basis for making the processing of personal data in this activity lawful?

The legal basis for Limerick City and County Council's use of Drone systems to process personal data consists of any one or more of the following:

Section 71.(2)(a) of the Data Protection Act 2018 in conjunction with;
Waste Management Act (WMA) 1996 as amended

- Section 14 of WMA - powers to use electronic recording for investigation
- Section 15 of WMA - powers to monitor and inspect
- Section 56 of WMA - powers to take measures to prevent or limit environmental pollution

We require your contact details

In order to communicate with you, you will be asked for contact details. You do not have to provide all contact details but providing more, such as email, phone, address, makes it easier to communicate. Please note that to help protect your privacy; we take steps to verify your identity before granting access to personal data. These contact details may also be used to verify your identity.

What other items of personal data do we need to undertake this activity?

Images of individuals and images of activities carried out by individuals;

Is the personal data submitted as part of this activity shared with other organisations?

Access to drone recordings may be provided, using a secure methodology, to the following:

1. An Garda Síochána
2. Legal Advisors
3. Other third parties, such as statutory prosecution agencies and local government agencies.

In this activity, if the personal data is to be transferred to a different country, it will be transferred to the following countries (if there are no countries listed, it is not intended to transfer the personal data abroad):

There are no plans to transfer the personal data to a third country or international organisation.

How long is this personal data held by Limerick City and County Council?

Data recorded on Drone systems shall be kept for no longer than is considered necessary. Limerick City and County Council will not retain it beyond a maximum of 28 days, except in circumstances where the data is required for evidential purposes and/or legal proceedings or in response to a data subject access request, in which case it will be retained longer than 28 days.

Your Rights

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by Limerick City and County Council. You also have the right to data portability. In certain circumstances, blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you.
