Economic Development and Enterprise Directorate

1. Trade & Investment

- Atlantic Projects Company, a power industry contractor specialising in the installation and maintenance of power plants, relocated its new Irish Headquarters to Limerick and announced plans to increase its workforce by 200 over the next 12 months.
- MacMarts, Ireland's leading provider of enterprise cloud applications, announced the creation of 40 new jobs over the next three years at its office space in the National Technological Park, Castletroy.
- Domino's Pizza have opened a new branch in Westbury Shopping Centre, Corbally, creating 15 new jobs.

As part of the 2022 Global Irish Festival Series, the community of Killeedy revived "The Ashford Festival" on 26-28 August and invited their diaspora from around the world to participate in the weekend long celebrations, either in person or online. The format of this event was similar to the Gathering Ireland project in 2013. The aim of this initiative is to connect the community of Killeedy with the Global Limerick network. The festival culminated with a unique event in which Killeedy diaspora from around the world live-streamed into the festival marquee to participate in a discussion about migration and being a member of the diaspora. Participants were given the opportunity to share their stories and to talk about what a connection to the Home Place means to them. Tim O'Connor, former Consul General of Ireland in New York, and Councillor Michael Collins, Cathaoirleach of the Municipal District of Newcastle West, chaired the discussion. There were approximately 100 people present in the festival marquee, with a further 50 tuning in online. The discussion moved between those in the marguee and contributors in Canada, the UK, USA, Iceland, New Zealand and Australia.

Key Takeaways

Diaspora appreciate being asked to tell their story to the Home Place.

- (i) Diaspora want more a newsletter perhaps, or a regular update on what is happening in the community.
- (ii) The Diaspora want to be part of the discussion, consultative or other, in relation to two major issues in Killeedy - housing and an after school/preschool service for the area.

The community is now working on follow-up actions to these key takeaways.

This event was an output of the Global Limerick Diaspora Strategy, adopted by Limerick City and County Council in 2021, which focuses on developing and supporting deeper connections between communities in Limerick and Limerick people around the world.

Engine Collaboration Centre

- Advanced discussions with a US Drone company regarding developing opportunities for health and safety for the Mid-West and establishing an operation in the region.
- Working with Dogpatch Labs to deliver first in-person Technology event in the Engine Collaboration Centre.
- Supported a successful workshop between two multinationals and an indigenous company regarding building out an integrated infrastructure.
- Working with University of Limerick and Technological University of the Shannon on sustainability technology challenges for Science Foundation Ireland proposals.
- Added three new software start-up businesses through the Software start-up programme, bringing the total to 36 companies being supported.

FILM IN LIMERICK

Film and TV Crew Academy Short Courses

Innovate Limerick / Film in Limerick's Crew Academy, in collaboration with Screen Ireland, ran the following courses:

Film and TV Location Management

This course was aimed at those interested in working in locations management on a film and TV production, and offered a practical insight into the work of this fascinating department. Eight participants took part in the course. Two location trainees from the course completed a placement on the feature film 'The Popes Exorcist' filming in Limerick and Dublin.

Firearm Safety for Film and TV at Troy Studios

This course took place at Troy Studios and gave an introduction to firearms safety and safe handling of firearms for film and TV productions. Twenty participants took part in this course.

Movie Magic Scheduling

This course was aimed at Film and TV Drama production personnel looking to upskill and learn 'Movie Magic,' the industry-standard software for breaking down scripts and creating schedules for all types of productions. Seven participants took part in this course.

Production Support

Film in Limerick supported seven productions (including feature films, TV Drama, TV productions and commercials) with location scouting, crew database enquiries, Section 481 information and facilities support.

4. Forward Planning

- Seventeen valid submissions received on the Proposed Rathkeale Local Area Plan 2023-2029, with closing date for submission 02 August.
- Work continued on the preparation of the Draft Castleconnell and Caherconlish 2023-2029 Local Area Plans.

5. Digital Services

EU Projects

 Met with Dublin City Council's new EU Programmes Officer to share best practices. It was an interesting conversation. Dublin City Council has been successful in embedding such a service at the political level to give it long-term stability, while here at Limerick City and County Council we have been successful in the coordination and delivery of projects.

- Held a meeting in the Citizen Innovation Lab in Sarsfield Street, Limerick, with the team from Smart Dublin. We discussed how we can identify common needs between Irish cities and how to potentially cooperate to drive innovation in local government.
- Met with Derville Brennan who is carrying out research on behalf of the Southern Regional Assembly on the integration of outputs from Interreg projects in Local Authorities. We talked about the successes in the Military, Maritime and Industrial Atlantic Heritage (MMIAH) project, where the Lock Quay area is development-ready, and Place-EE and how findings and experience from that project are being applied in Age Action Ireland. We also discussed how findings from the Parks Atlantic project helped to inform later projects such as Health and Greenspace, and Go Green Routes.
- Met with Mark Sweeney from Enterprise Ireland in the Citizen Innovation Lab. Mark is the national contact point for Horizon Europe on Climate and Environment. We discussed project opportunities which will arise in this new funding period and we highlighted the strengths and successes in Limerick which we would like to take forward into new projects.
- On 31 August, we met with ESB Innovation to discuss X_Site, ESB's business incubator. Currently, they are looking at establishing eVehicle charging hubs for car sharing and would like to work with Transport to place two such hubs in Limerick City.

6. Limerick Twenty Thirty (LTT)

Opera Square

 Marketing and Letting Strategy: Originate, Cushman Wakefield, Teneo and LTT are progressing the Marketing and Letting Strategy for the overall site and One and Four Opera Square.

- Finucane Brothers Memorial: The stone used in the pushing wall of the memorial was repurposed from demolished buildings at Opera Square. An image of Tom Roche, Designer of the Memorial, Greg Glynn, Stone Mason, and Diarmuid Hayes, LTT Project Manager, was shared to LTT's social media.
- **Opera Square Hoarding:** Work progressed on the design of Phase Two of the hoarding with several collaborators.

Gardens International

• A brand logo was developed for 'The Vault' at Gardens International to aid in promoting the space for meetings and event bookings.

Cleeves Riverside Quarter

 Rape Crisis Midwest used the Cleeves Riverside Quarter carpark as their base for the Charity Paddle on 06 August. Information was shared to LTT's social media to promote the event and share information for donations.

1. Active Travel

Works - Metropolitan District of Limerick

- Model School, O'Connell Avenue Works commenced on Safe Routes to School infrastructure outside The Model School. The project includes a new School Street on Roden Street and traffic calming measures on O'Connell Avenue.
- Stoneyhurst Pedestrian Ramp Works commenced on a new layout for the Stoneyhurst Pedestrian Ramp in Dooradoyle.
- **R526, St. Nessan's Road** Works commenced on the R526, St. Nessan's Road, in the vicinity of University Hospital Limerick. The works include new footpath and drop-kerbs and realignment of cycle lanes.
- Ballykeefe Roundabout to St. Paul's Orcas were added to the cycle lane on St. Nessan's Road between Ballykeefe Roundabout and St. Paul's.
- **R512, Drombanna** Works ongoing on 360m of new footpath along the R512 in Drombanna.
- School Road, Lisnagry Works ongoing on 430m of new footpath along the L-11062-2 in Lisnagry.
- Castleconnell National School Works commenced on new footpath in front of Castleconnell National School.
- Scoil an Spioraid Naoimh, Roxborough (R511) Works commenced on new footpath near Scoil an Spioraid Noaimh.

Works – Municipal District of Cappamore-Kilmallock

- Herbertstown Works commenced on a new walking and cycling route in Herbertstown.
- **Old Pallas** Works commenced on a new footpath on L5048, Old Pallas.

Works - Municipal District of Adare-Rathkeale

- Holycross to Kyletaun, Rathkeale Works commenced on footpath upgrade on R518, Holycross to Kyletaun.
- **Cappagh** Works ongoing on pedestrian improvements.
- Adare Works ongoing on footpath upgrades on Station Road, Adare. Fencing works also underway along riverbank route.
- **Crecora** Works fully complete on new footpath connecting village centre to GAA pitch.

Communications and Marketing

- Limerick Active Travel hosted two drop-in sessions at the Citizen Innovation Lab at the University of Limerick City Campus as part of the public consultation on the proposed TUS to City Active Travel Scheme.
- Limerick Active Travel hosted a Public Consultation Forum on the proposed route for the Limerick City Greenway (University of Limerick to Annacotty). The project was supported by a virtual public consultation room on the proposed scheme.
- Limerick Active Travel produced a social media video on the new Safe Routes to School infrastructure at The Model School. The video was shared on the school's social media channels in advance of the return to school and was viewed more than 3,700 times.
- Limerick Active Travel tweeted 11 times from the Limerick Council twitter account, with total followers now 17,400.
- Limerick Active Travel posted four updates to Limerick
 Council's LinkedIn account with total followers of 8,887.

2. Mid-West National Road Design Office

Foynes to Limerick Road (including Adare By-Pass)

On 30 August, An Bord Pleanála approved the Foynes to Limerick Road (including Adare By-Pass) which comprises the Foynes to Rathkeale Protected Road Scheme 2019, the Rathkeale to Attyflin Motorway Scheme 2019 and the Foynes Service Area Scheme 2019. The road consists of:

• 15.6 km of dual carriageway from Foynes to Rathkeale, with 1.9 km of single carriageway road between Ballyclogh and Askeaton.

- 17.5 km of motorway from Rathkeale to Attyflin (N21/ N20/M20 junction), including a by-pass to the north of Adare Village.
- A service area for heavy goods vehicles near Foynes.

The project will cost in the region of \leq 450 m and will connect the core port of Foynes to the motorway network near Limerick. The by-pass of Adare will remove 70%-80% of the c. 17,000 vehicles/day passing through Adare village, eliminating regular traffic congestion at Adare.

The Council will continue to work with Transport Infrastructure Ireland to progress the scheme.

N24 Beary's Cross Road Improvement Scheme

The Council appointed Sorensen Civil Engineering Ltd., Forge Hill Cross, Kinsale Road, Co. Cork, as contractor to carry out the main works contract for the N24 Beary's Cross Road Improvement Scheme. The road works scheme comprises:

- a new roundabout controlled junction.
- alteration to the present junction layout.
- the construction of a new regional road R513 approach to the junction.
- the alteration of the existing N24 approaches to the junction, road and drainage impact attenuation, fencing, landscaping, public lighting, accommodation works and associated site works.

The contractor mobilised on site on 15 August and works are scheduled to take approximately 12 months.

N21 Ward's Cross Road Improvement Scheme

This scheme consists of widening the existing N21 carriageway to the north of the existing carriageway to provide a right-turn lane at the N21/L7091 Ward's Cross junction. The proposed works will also include pavement works, kerbing, new road markings and the installation of road drainage and associated site works along the scheme extents.

Following a tender process, Cóir Infrastructure Ltd., Mountrath Enterprise Park, Portlaoise Road, Mountrath, Co. Laois, have been appointed to carry out the main works contract.

1. Urban & Rural Community Development

Outdoor Recreation Infrastructure Scheme (ORIS)

On 03 August, the Department of Rural and Community Development announced the funding approvals under Measure 1 and the Project Development Measure (PDM) ORIS 2022. Limerick received funding for six projects, totalling \leq 215,411 in grant funding for the following projects:

- Lough Gur Walkway (PDM) Planning/Detailed Design of new walking trail (€50,000).
- Monument Hill Walk, Foynes (PDM) Feasibility Study to re-establish the Monument Hill Walk (€50,000).
- Moore Abbey Loop Walks Upgrade of the Moore Abbey National Trail Loop Walk (€30,000).
- National Walking Trails Map Boards Update all National Walking Trail Map Boards in the Ballyhoura Region (€25,848).
- Appraisal of Usage Outdoor Experiences Install Counters on eight loop walks within the Ballyhoura Region (€29,998).
- Marketing of the Ballyhoura Region Marketing the Outdoors in Ballyhoura as part of Hidden Heartlands (€29,565).

Town and Village Renewal Scheme

• The 2022 Scheme will prioritise tackling vacancy and dereliction in towns and villages for projects that will bring vacant and derelict buildings and sites back into use as multi-purpose spaces or re-purpose existing community/publicly owned buildings to facilitate remote working. Limerick City and County Council submitted the maximum 11 applications allowed under the 2022 Scheme.

The Knights of Glin Experience at Glin Library was officially opened by the Deputy Mayor of the City and County of Limerick, Councillor Kieran O'Hanlon, on 27 August. A large group of people gathered in Glin to watch the Deputy Mayor and Madame Olda Fitzgerald cut the ribbon to the Knights of Glin Experience. This Interpretive Centre, located next to Glin Library, outlines the history of the Knights of Glin through interpretive boards and audio-visual material. Limerick City and County Council has worked with Glin Development Association over the past three to four years to deliver the project, which was funded under the Town and Village Renewal Scheme (2018 and 2019).

CLÁR Programme

Funding approvals under Measure 1 were announced in August under the CLÁR rural funding programme. Limerick received funding for eight projects including the following:

- Martinstown National Primary School Resurfacing of carpark/delineation of parking bays (€20,880).
- Mountcollins AFC Walkways upgrade and erection of perimeter fencing for safety (€22,326).
- Glenroe GAA Installation of LED flood lighting at GAA all-weather sports and recreation facility (€50,000).
- Athea GAA Resurfacing of Club/Walking Track Carpark (€44,573).
- Kilteely Tidy Towns Community carpark resurfacing and delineation of parking bays (€27,911).
- Templeglantine GAA and Camogie Club Development of artificial playing surface for all year-round use/Ball Wall upgrade (€9,788).

- Oola GAA Club Installation of a disabled and wheelchair accessible walkway and fencing for safety (€35,000).
- Kantoher Development Group Remedial works to Ashford village carpark, including resurfacing to allow safe use (€50,000).

Pride of Place

The Pride of Place awards is an annual all-island competition operated by Irish Public Bodies in association with Co-operation Ireland, in conjunction with local authorities in the north and south of Ireland. This year marks the 20th anniversary of Pride of Place. The purpose of the awards is to acknowledge the work being done by communities all over the island of Ireland in partnership with their local Councils. Judging of the nominated projects was conducted face-to-face this year.

The four Limerick groups nominated by Limerick City and County Council to compete in this year's Pride of Place competition were visited by the Judges in August.

- St. Munchin's Community Centre entered under Community Resilience category.
- The West End Youth Centre entered under Community Youth Led Initiative category.
- Glenroe/Ballyorgan Community Council CLG entered under Population 300-1,000 category.
- Adare Women's 2020 Club entered under Community Wellbeing Initiative category.

Environmental Awareness

- Limerick City and County Council hosted the local launch of Gum Litter Task Force Anti-Gum Litter campaign on Howley's Quay in early August.
- Environmental staff from the Council took a stand at the Limerick Show. More than 2,500 people were engaged with during the day and 750 MyWaste Food Waste Recycling Kits were distributed. There was great

interest in preventing food waste, composting and biodiversity.

 Limerick Going for Gold Tidy Town Category interviews on Live 95fm and the Limerick Leader took place throughout August. Congratulations to Kilmeedy, Castleconnell, Askeaton and Patrickswell on being chosen as a 'public vote' finalist to date. This is the last week of live radio interviews and the public vote. The remaining groups are still in with a chance to be chosen as a judge's wildcard finalist.

Limerick Public Participation Network (PPN)

- Limerick PPN Secretariat continues to successfully deliver on its key functions.
- Membership of the PPN continues to grow and now stands at 183. The membership registration form is on the Limerick PPN <u>website</u> and eligible groups in Limerick can register at any time.

Limerick PPN continues to have an active social media presence on its regularly updated website as well as on Twitter, Facebook and Instagram.

2. Tourism

King John's Castle

 In August, the Roses of Tralee visited King John's Castle for a Mayoral Reception as part of the National Rose of Tralee Tour. The Ray D'Arcy Show on RTÈ Radio 1 also aired a programme from the Castle. A number of concerts were held during August in partnership with Dolans.

Open Calls

Open Call for Bursaries

Bursary calls for the Individual Arts Bursaries, Dolores O'Riordan Music Bursary and Tyrone Guthrie Bursary closed on 17 August and are being processed.

Individual Arts Bursary Awards Scheme

Twenty-one applications from individual artists were made to this scheme for Bursaries of up to \leq 4,000 for work/professional skills development.

Dolores O'Riordan Music Bursary Award

Limerick Arts Office, Limerick City and County Council, invited applications from professional musicians to be considered for a Music Bursary of up to \leq 4,000. There were ten applicants for this award.

Tyrone Guthrie Bursary

The Tyrone Guthrie Centre at Annaghmakerrig is a residential workplace and residency programme in Ireland for artists of all disciplines. Two Bursaries for the Tyrone Guthrie Centre were made available in this Open Call and ten applications were received.

Strategic Fund

The Strategic Fund for Culture and Arts Scheme supports applications to national and international funding bodies to help leverage funding, by offering general letters of support, benefit in kind, or a percentage of any funding awarded in the event of a successful application. In August, one letter of support was issued.

Creative Ireland

Limerick Culture and Creativity Strategy 2023-2027

Limerick City and County Council is developing a new five-year Culture and Creativity Strategy for Limerick, as a part of the Creative Ireland Programme. Arts Leaders Associates have been engaged to support Limerick City and County Council for the consultation, research and writing of the Culture and Creativity Strategy 2023-2027. Two Focus Group meetings took place on 24 and 26 August with internal and external stakeholders. The purpose of the Focus Group, facilitated by Arts Leaders, is for key stakeholders to inform the identification of priorities for Limerick's Culture and Creativity Strategy 2023-2027. The results will inform the development of this five-year strategy.

Arts Council Framework Agreement programme

Culture Night

Further events have been registered for Culture Night 2022.

Castleconnell Concerts

A fully live programme of enchanting and beautiful music and song returns to All Saints Church in Castleconnell this Autumn. Castleconnell Autumn Concert Series is programmed by Limerick Arts Office, with financial support from the Arts Council and Creative Ireland. The concerts are presented in partnership with Love Castleconnell. This year's series welcomes Fiachra Garvey, Dean Power, Miriam Kaczor and Ellen Jansson, and the Marmen Quartet to the County Limerick riverside village. The first concert took place on 30 August with pianist, Fiachra Garvey, in All Saints Church in Castleconnell.

River Residencies Arts Council, Invitation to Collaboration

This is a collaborative initiative led by Limerick Arts Office and Ormston House in partnership with Cavan Arts Office, Clare Arts Office and Tipperary Arts Office. It is co-funded by the Arts Council of Ireland through An Invitation to Collaboration award. The River Residencies focus on high quality engagement between artists and communities, exploring themes inspired by the River Shannon. An Open Call took place in 2021 with international artist, Tania Candiani, being awarded the Limerick residency in Glin. Tania Candiani was in residence in Glin during August where she engaged with multiple groups. An artistic film is being made as a part of the residency.

5. Libraries, Gallery & Museum

- Rathkeale Library was delighted to welcome boys and girls from both St. Anne's Primary school and St. Joseph's Boys' National School Summer Camp programme. They enjoyed a tour of the library, a bookbased scavenger hunt, story-time and a Question and Answer session with library staff.
- The end of August brought many young readers to branch libraries to browse the book shelves in preparation for starting school and to collect a "My Little Library" bag." The 'My Little Library Book Bag' initiative is a collaboration between libraries, the Department of Rural and Community Development, and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy. As part of the initiative, a bag, which includes three books, is available free for every child starting school in 2022 to help them to prepare for this big step. Children and their parents or guardians can collect the bags at any library throughout the county.
- There were thirty onsite visits by researchers to the Local Studies Department at Watch House Cross Community Library in August. Twenty of these involved research on the microfilm and digital archives of local and national newspapers, and five on material forming part of the Local Studies and archival collections. Five visits comprised advice sessions on family history and/or research on FindMyPast. Nineteen remote queries were received and resolved. The Department's Decade of Centenaries (DOC) commemorative volume on the Civil War, 'The Inevitable Conflict:' Essays on the Civil War in *Limerick,* was completed and the electronic version uploaded on to Limerick's DOC webpage. Printing of hard copies is underway. Work was also completed on the Department's other DOC project, Limerick-related claims lodged with the Irish Grants Committee in the 1920s; it has also been uploaded on to the DOC page. Some new acquisitions were added to stock.
- Dooradoyle Library welcomed a visit from Our Lady of Lourdes Summer Camp. The group of approximately thirty children, ranging from Junior Infants to Fifth

Class, were treated to stories, nursery rhymes and a treasure hunt. Each child was given a complimentary bag of library goodies to take home. As part of the summer programme of events, Dooradoyle Library hosted an arts and crafts event with staff member Deirdre where children learned how to draw their favourite animals. Regular story-time sessions continued throughout the month. A display entitled 'Michael Collins: A Life,' curated by Dooradoyle Library staff, marked the 100th anniversary of the death of the famous Irish Republican revolutionary at Béal na Bláth on 22 August, 1922.

- Newcastle West Library created the following book/ board displays during the month of August: "I can't remember the book, but the cover is blue!," new Adult Fiction collection, "Poets' Day," celebration of Poets' Day with a display of books for adults and children, and the Michael Collins Centenary Commemoration 2022." The Branch welcomed new members from the Ukrainian Community who were delighted with the selection of Ukrainian and Russian children's books, and access to e-books on the BorrowBox app.
- Newcastle West branch continue to develop use of The Magic Table with the support of the Happiness Programme on the website of Social Ability, the supplier of the table. The branch coordinated a West Limerick local radio interview with Librarian, Julie McLoughlin, on the diverse services and resources available in Limerick Libraries. West Limerick 102fm's Susan Shannon spoke with Julie about the Summer Stars Reading Challenge, resources such as Borrow Box, the "My Little Library" initiative, books in languages other than English, author visits and other library services. Julie also recommended great reads by Limerick writers.
- "Roses from the Heart," an exhibition of 32 tribute bonnets remembering the Kilmallock Union Workhouse orphans transported to Australia, 1849/1850, was opened on 04 August in Kilmallock Library by Sheila Queally. Based on the research of historian, Imelda O'Riordan, author of Lost Girls, each piece was created by a member of the local community as a tribute to the young orphan girls who

left Kilmallock Union for Australia. The girls, some as young as fourteen, were sent as part of the Earl Grey Immigration Scheme. Sheila Queally shared a poignant and eloquent speech, while Eamon O'Riordan of the Kilmallock Historical Society set the era of the workhouses in context. A large crowd attended. The exhibition was on display for the month of August before the work eventually makes its way to Australia. "Roses from the Heart" is the international memorial to all women sentenced to transportation to Australia and the original project is the work of Tasmanian artist, Christina Henri.

- Heritage Week ran from 13 21 August and Kilmallock Library shared a display of very interesting local artefacts on loan from Kilmallock Museum which included butter-making packaging and tools from the Creamery, beverage bottles from W.H.O'Sullivan, Wholesale Tea, Wine & Spirit Merchants and also some artefacts from the Civil War.
- Kilmallock Library invited some wonderful people from St. Joseph's Foundation to be the first to try out the new Magic Table and the laughter that ensued proved its popularity! The group was so enthralled that they have included it on their weekly activities list. The Magic Table (or 'Tovertafel' in Dutch) is an award-winning innovation from the Netherlands, and it uses specially designed technology to help people with mid-to-late stage dementia and those with learning disabilities. It consists of a series of colourful and fun interactive light games projected onto the surface of a table, which respond to hand and arm movements that stimulate physical and cognitive activity as well as encouraging social interaction.
- Kilmallock Library continued its monthly "Little Readers" sessions on 26 August and welcomed an enthusiastic group of 16 pre-schoolers and their grownups for an interactive fun-filled session of rhymes, songs and stories, followed by craft session where each child decorated a star to be placed on our "Little Readers" giant caterpillar.

- The Summer Stars juggernaut continued to gather pace at the City Library as it celebrated the highest ever participation number with over 550 children signing up to take part in the reading challenge. Also in August, the library invited younger readers to enjoy the end of the summer holidays with a special 'Get Outdoors' display of titles. Also on display was a 'Back to School' selection of titles highlighting the best school-related stories and novels from the collection. Adult readers were challenged to take a chance on reading a 'banned' book and borrowing a title that, at one stage, was subject to censorship. Each selected title was accompanied by a short printed explanation of why the book was a cause of controversy on initial publication with the display attracting much comment and debate from intrigued readers. The Sahaja Yoga meditation meetings continued throughout the month with the free weekly sessions taking place every Tuesday evening at 6.00 p.m., regularly attracting an appreciative audience of 20-25 people. Limerick's Writepace continued to meet at the City Library with bi-monthly sessions devoted to providing support, sharing writing strategies, and making progress on writing for all members of this prestigious creative writing collective.
- Watch House Cross Community Library held three public events to celebrate the Summer Stars Reading Programme. On 03 August, 8 to 12 years olds were invited to a dance workshop. The theme of the workshop was based on 'A cover is not the book' from the movie "Mary Poppins Returns." The children enjoyed learning how to combine using a prop, their favourite book, with learning a new dance routine. On 10 August, library assistants, Michelle and Clara, facilitated a Fighting Words Story Creation Workshop. These workshops are designed to promote creativity and writing as a fun and powerful means of selfexpression. The thirteen participants, with tons of ideas, worked together to create a story called, Dean's extraordinary Quest. On 18 August winner of the Children's Books Ireland 2021 Honour Award for Fiction, Pádraig Kenny, visited the library to talk about his book, "The Monsters of Rookhaven." This was the children's book-club title for the month of August and all present were thrilled to meet the author. There was a lively

Question and Answer session with lots of questions about the book, monsters and the publishing world in general! The sensory room had 200 users during the month, including children and teachers taking part in the Summer Programme, which aims to support children with complex needs and those at risk of educational disadvantage.

 During August, the local Parent and Toddler group met twice in Adare Library. The group is a significant and recognised support for new parents in the Adare area. The Mosaic exhibition was taken down on 15 August but before that, it was visited by Irish Public Bodies Pride of Place judges. (IPB Pride of Place, in association with Co-operation Ireland, is an all-island competition that acknowledges the work that communities are doing all over the island of Ireland). Adare's Women's 2020 club is nominated in the category of community wellbeing. The library marked International Dog Day (26 August) with a dedicated book display and a video that was posted on Limerick Libraries Facebook page.

Limerick City Gallery of Art (LCGA)

- PULSE, a significant new initiative by Limerick City Gallery of Art, continued throughout August. Visitor numbers have been very strong throughout the summer with a noticeable volume of tourists from Europe. Obviously, the LCGA is a very attractive tourist destination with the additional bonus of being FREE with significant tourism opportunities.
- LCGA continued to display a selection of watercolours and drawings, including work by Percy French, Walter Verling and Mainie Jellet amongst many other artists. The upper floor galleries houses a selection of more recent acquisitions demonstrating the breadth of the Collection and its importance to supporting artists throughout their careers.
- Islanders' Focus, a photographic exhibition by Croatian artist, was opened on 12 August by the Deputy Mayor of the City and County of Limerick, Councillor Kieran O'Hanlon. This was a collaboration with Irish Aerial Creation Centre with support from Creative Europe.

This was followed by a performance by two artists from Greece.

- Over August, LCGA's Shinnors Scholar ran a series of FREE Yoga and Art summer camps for 7–12-year-olds. The children attended for one session and was hugely popular, with 176 children attending the camps. An additional benefit was that many who participated (and their parents/guardians) were first-time visitors to the Gallery and came from the city and county.
- The Shinnors Scholar, Brendan Egan, finished in LCGA on 31 August. Brendan achieved significant goals during his tenure where he developed an inspirational on-line programme.
- LCGA took delivery of the portrait of Michael Hartnett, by Edward Maguire, purchased by Limerick City and County Council with the help of the Friends of the National Collections of Ireland (FNCI).
- In addition to the acquisition outlined above, LCGA also received three donations of important works.
 Maurice Foley has offered a Tony O' Malley painting on loan for a period of 5 years. In addition to that, a collector in Dublin, with links to Co. Limerick, donated two highly valuable Robert Motherwell works. LCGA accepted these paintings on a ten-year loan on the basis that they will complement our existing collection of mid-century American Abstract Expressionist prints, donated by Jim Sheehy.

Limerick Museum

• On 17 August, the Mayor of the City and County of Limerick, Councillor Francis Foley, performed the official opening of *Unlocking the Secrets of Limerick Museum*, an exciting exhibition of historic artefacts from Limerick Museum in Saint Mary's Cathedral. This exhibition has been curated by the Curator of the Museum and William O'Neill, Historian, and was one of the highlights of Heritage Week in Limerick. It was funded by the Heritage Council.

- Limerick Museum's collection is so large that only some of it can be displayed at any given time. This is a problem in museums all over the world. In 2022, it was decided to reveal Limerick Museum's hidden treasures to everyone by holding an exhibition of some of its most iconic items in Saint Mary's Cathedral. This exhibition highlighted those many objects that have never been on display before and introduced the public to a wealth of 'hidden' objects in the Museum collection. It was a fine example of the collaboration between different cultural stakeholders in Limerick city and county. The Museum worked closely with Dean Niall Sloane, Noreen Ellerker and the staff of Saint Mary's Cathedral, without whose enthusiasm this exhibition could not have been held. 'Unlocking the Secrets of Limerick Museum' continued in Saint Mary's Cathedral until 31 August, but many of the most renowned items will remain on display in the Cathedral on a long-term basis.
- 'Unlocking the Secrets of Limerick Museum' also included the online publication of projects previously stored on obsolete ASKSAM software. This involved updating a large amount of invaluable material, storing it on modern technology and uploading it to the Limerick Museum website.
- On 15 August, as part of Heritage Week, Limerick Museum hosted a lecture by invited speaker, Merrie O'Sullivan, who introduced the lace collection of her grandmother, Amy Whitelegge. The collection included a stunning beautiful wedding dress and a sample of Amy's work, with many intricate stitches. It also displayed a wide variety of filling stitches and tambour, tape lace, Carrickmacross lace and crochet lace, as well as original artistic designs.
- On 03 August, the RTE programme '*Nationwide*' had a feature on the Limerick Wild Geese Festival, which included an interview with the Curator of the Museum. *Nationwide* has a nightly viewership of 250,000.
- On 13 August, the Curator of the Museum also took part in a documentary on RTE Radio One called "The Custom of the Sea" which dealt with the shipwreck of the Limerick cargo ship '*Francis Spaight*' in 1835.

- Limerick Museum has commenced a new collaboration with the Foynes Flying Boat and Maritime Museum. On 09 August, Margaret O'Shaughnessy and Barry O'Kelly from the Foynes Museum visited Limerick Museum and it was agreed that both institutions would collaborate on a number of exhibitions in the future.
- Limerick Museum sponsored the Crafts Section of
 Limerick Show, which was held on 27 August. Also at
 the Show, the Curator of the Museum presented a copy
 of his History of Limerick Lace to EU Commissioner,
 Mairead McGuiness, in the presence of the Deputy
 Mayor of the City and County of Limerick, Councillor
 Kieran O'Hanlon, and the Chief Executive.

The Department of Housing, Local Government and Heritage approved funding for 127 projects across 72 organisations, totalling almost €3.8million. Appeals were being dealt with in August.

Community Information

A first edition of the '*Regeneration Connect*' Newsletter went to print and was circulated to all the households and service providers in the Regeneration communities. A flyer of useful Regeneration contacts was circulated in the St. Mary's Park, Southill and Ballinacurra Weston communities. The flyer for Moyross is being prepared.

Community Activity

Facilitated planning and review sessions took place with the St. Mary's Park Regeneration Committee and proved very productive.

Community Sustainment Unit

The Community Sustainment Unit is comprised of three main strands: (i) Estate Support (ii) Individual Tenant Support and (iii) Tenancy Enforcement/Anti-Social Behaviour.

1. Estate Support

 The main aim of this programme is the provision of supports with a view to improving quality of life and developing community spirit within Council estates. To this end, the Unit works closely with existing residents' associations and encourages the formation of new such groups, supporting the implementation of key actions identified by them to improve their estates. The support provided varies from assistance in provision of minor infrastructural works such as fencing, walls, signage etc., to softer measures such as committee skills training, contributing towards clean-up days, events for children etc.

2. Individual Tenant Support

- The Unit provides a service, supported by the Housing Welfare Officer, of intensive support for tenants who may be identified as vulnerable or in need of such help for any other reason. In addition, there is monitoring of individual tenancies that may require particular attention to prevent problems occurring. There is an ongoing programme to reach out to all tenants in Council estates. During the month of August, 281 such visits were carried out by the Community Sustainment Officers.
- Tenancy Induction training is provided for all newlyappointed tenants. Among other things, the terms of the Letting Agreements which are signed are clearly explained so that the obligations of both the tenants and, indeed, the Council are clearly understood. 24 such inductions took place during August.

3. Tenancy Enforcement/Anti-Social Behaviour

- The Unit deals with in excess of 400 complaints each year, with approximately half of these relating to antisocial behaviour. The Council's policy is to respond to these issues quickly and firmly and it works in close co-operation with An Garda Síochána where necessary. The number of active cases at the end of August was 181. The number of cases closed during August was 68. The Community Sustainment Team secured possession of 11 Council properties during the month following death of tenant, abandonment of property or other particular circumstances.
- The Unit carries out formal Garda checks on prospective new tenants. 65 such formal reviews were undertaken during August.

In August, works on eleven properties were completed by the Local Authority Maintenance Team.

There are three teams in Limerick City and County Council assigned to refurbish properties. As of August, the Local Authority Construction Team is in the process of completing works in 126 properties, Local Authority Maintenance Team 45 properties and the Regeneration Team 19 properties. Approved Housing Body stock transfer in process - 27 properties. 29 properties have no Team assigned yet.

The Strategy and Non-Local Authority Housing Construction Team is currently looking at more sustainable solutions to the issue of vacant properties in the Council's ownership:

The Team is testing variant versions of the scheme to identify the most suitable and viable mix of tenures and unit typologies on the site. A viability analysis of market valuations and projected build costs is now being reviewed.

Limerick City and County Council's Affordable Housing Team, in co-operation with the National Development Finance Agency and Department of Housing, Local Government and Heritage Affordable Housing Team, submitted an application to move to the increased level of subsidy available under the Affordable Housing Fund in August. Decarbonising Together – A Creative Climate Action Fund Project

August saw the Decarbonising Together Projects progressing well and getting the climate conversations started with the citizens of Limerick.

Garryowen Residents' Association and Garryowen Development Project have been working with artists Veronica Santorum and Daniel Clancy to encourage residents in Garryowen to imagine a future where their community has a smaller carbon footprint through a series of community conversation walks, which was reported on by Live 95, Limerick's local radio station, see article <u>Project</u> <u>has inspiring plans for Garryowen - Live 95 (live95fm.ie)</u> The themes of the community walks range from Travel to Home energy and are proving very popular.

Meadowbrook Residents' Association and Workshop Architects met with a member of Limerick City and County Council's Active Travel Team to discuss the Mill Road, Corbally, Active Travel plans and how the proposal will help encourage residents to use active travel.

Limerick Civic Trust and Cracking Light Productions also had a busy month meeting with a member of Limerick City and County Council's Environment, Recreation and Climate Team to discuss Urban Greening as part of their documentary collaboration. They also met with Pat Mulcahy of the Limerick Bell Ringers at St. Munchin's Church where the practice bells have been given a new home by Limerick City Trust, protecting rare species of culture for a healthy community.

The Munster Indian Cultural Association, along with their creative partners Deirdre Power and Chelsea Canavan, organised a site visit and workshop to New Leaf Urban Farm with farmer, Kevin Wallace. The group participated in a workshop on the farm introducing them to diverse practices such as KNF - Korean Natural Farming. (A selfsufficient farming system that involves the culturing of indigenous micro -organisms (IMO) and methods of no dig, composting. The group worked on the farm to assist in clearing the land to prepare for a no-dig approach to the soil.



Customer Services

In August, Customer Services welcomed a total of 2,455 visitors in both Merchant's Quay and Dooradoyle offices.

August saw unprecedented warm weather with three Yellow Weather Warnings issued throughout the month for high temperatures, which in turn led to an Orange Forest Fire Warning issued from the Department of Agriculture. This resulted in the immediate cessation of all Burning of Agricultural Vegetation Permits which were issued for that timeframe. Customer Services telephoned all customers with valid permits to advise them not to burn while the Orange Weather Warning was in place.

The following figures highlight the activity within the Contact Centre:

- Customer Services Call Centre answered 10,130 calls. This represents an average of 460 per day, with the number of calls exceeding 500 on several occasions. 53% of calls were handled at first point of contact.
- A total of 2,476 emails were processed through the Customer Services email platform.
- 2,759 cases were created, with 682 of these logged on behalf of Public Representatives. 3,056 cases were closed, with 689 of these being cases logged by Public Representatives.
- The logging of cases through the MyLimerick portal continued, with a total of 267 cases being logged. Of these, 248 were submitted by Public Representatives.
