I will ask Limerick Metropolitan Council what actions can be taken in cooperation with the Gardai and Park Ranger to increase patrols within the Peoples Park to ensure the safety of visitors and in particular young children.

6. Question submitted by Councillor C. Slattery

I will ask at the next Meeting of the Metropolitan District of Limerick can the dividers on the cycle lane from the Roxboro Roundabout to Kilmallock Roundabout be changed from permanent concrete dividers to a divider that will leave cars pull in to let an ambulance pass. I have been contacted by paramedics about this matter. Lives are being saved in the back of an ambulance and every second counts.

I will ask at the next Meeting of the Metropolitan District of Limerick can an update be provided for the graveyard boundary wall at Mount St. Oliver as funding was provided three years ago and no works have commenced as yet.

8. Question submitted by Councillor C. Slattery

I will ask at the next Meeting of the Metropolitan District of Limerick why was the entrance from Colbert Avenue to Our Lady Queen of Peace School closed was this decided by the School or Limerick Council. As I had a lot of people asking that it be reopened.

I will ask at the next Meeting of the Metropolitan District of Limerick for an update on a footpath being provided on Condell Road, to serve the residents of the new development at Moineir.

Pavement parking can pose a hazard to pedestrians, especially people with sight loss, pushchairs, wheelchair users and other disabled people.

Pavements are not designed to take the weight of vehicles and so surfaces become damaged or subside, presenting a further hazard to pedestrians, particularly those with disabilities.

That the Council will conduct a public awareness campaign about the dangers of pavement parking, that Council will adopt a zero-tolerance approach when a car completely blocks a footpath and that the Council will conduct a pilot programme of zero tolerance and targeted enforcement on Wickham Street/Parnell Street and O'Connell Street for a defined period.
