2. We hereby appoint and delegate full power to _____ of _____ to act for us in all correspondence and other business arising out of this application and we agree to be bound by our nominee’s correspondence and acts.
3. We agree to carry out works required of us under the control and supervision of the Council and to the specification of the Council. We understand that claims arising from any works carried out by us outside the control and supervision of, or in a manner unsatisfactory to the Council, are not covered by the Council’s insurance.
4. We accept the Council’s right to adjudicate whether the works have been carried out in a satisfactory manner prior to the Council contributing to the project.
5. We accept to exclude all vehicles and mechanically propelled plant from the works we will carry out which do not have proper Motor Insurance Cover.
6. We undertake to report immediately any accident or claim to the Council arising out of the works and accept that the Council will have sole control over the handling or settlement of the claim.
7. We understand that Sub-Contractors employed by community groups must satisfy minimum requirements in relation to Public Liability/Employer’s Liability & Motor Insurance and Health & Safety requirements.

8. We undertake to be bound by the scheme's exclusion of claims made for injury, loss or damage to individual persons who are part of the group, employees of persons who are part of the group, or family members of persons who are part of the group.
9. We understand that once the works have been accepted as satisfactory by the Council, then the Council's insurance will cover the works.
