### **Data Protection Privacy Statement for**

The Limerick Public Realm Strategy, which is supported within the existing Limerick Development Plan 2022 - 2028.

#### **Who we are and why do we require your information?**

Limerick City and County Council seeks to promote the economic, social and cultural development of Limerick City and County and in doing so contribute significantly to improving the quality of life of its people. The delivery of high quality services, tailored to meet the needs of all our customers, remains one of Limerick City and County Council's core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment. In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of Limerick City and County we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being sought or provided, the information sought may include 'personal data' as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past, current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

#### **Why do we have a privacy statement?**

Limerick City and County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with Limerick City and County Council that we will ensure the security of the data you provide to us. Limerick City and County Council creates, collects and processes a significant amount of personal data in various multiple formats on a daily basis. Limerick City and County Council's commitment is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

#### **Data Protection Policy**

Limerick City and County Council has a detailed Data Protection Policy, which outlines how we as a public body are committed to ensuring the security of any personal data you provide to us.

### **What is the activity referred to in this Privacy Statement?**

The activities referred to in this Privacy Statement vary based on the form of public engagement being carried out throughout the life cycle of the Strategy, which is described here. There will be 4 rounds of public consultation, to correspond with each stage of the Strategy. The first early engagement piece involves an anonymised online survey, which will be linked through MyPoint, and which will close at the end of 2023. LCCC will not publish any personal data on MyPoint for general public viewing.

The second, third and fourth rounds will consist of in-person events held in various places in the City Centre between early 2023 and summer at locations to be confirmed closer to the time.

### **What is the basis for making the processing of personal data in this activity lawful?**

As per Article 6 of the General Data Protection Regulation, processing of information is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller. In this case, the production of the Public Realm Strategy is supported within the current Development Plan. The requirement for a Public Realm Strategy is supported by existing policies and objectives at European, National, Regional and Local level. Objective CGR 02/Pg 49 of Volume 1 of the Development Plan which deals with Place-making, Universal Design and Public Realm states:

“It is an objective of the Council to: ...

B) Prepare and facilitate implementation of Public Realm Plans for settlements including Limerick City, Adare and Rathkeale.

The processing of information will support the implementation of national policy and identify opportunities within the public realm for projects, which will attract funding from the National Development Plan 2018 -2027.

### **We require your contact details**

In order to communicate with you, you will be asked for contact details. You do not have to provide all contact details but providing more, such as email, phone, address, makes it easier to communicate. Please note that to help protect your privacy, we take steps to verify your identity before granting access to personal data. These contact details may also be used to verify your identify.

### **What other items of personal data do we need to undertake this activity?**

We do not require any further personal data to undertake this activity.

### **Is the personal data submitted as part of this activity shared with other organisations?**

Limerick City and County Council may, to fulfil statutory or regulatory obligations or in the public interest, from time to time, have to share personal data with other organisations or entities (in Ireland or abroad). Where this is required, Limerick City and County Council shall have regard to the security and integrity of the data and will minimise the data shared.

In this process, the data will be shared with the following recipients:

Sharing of data between Limerick City and County Council (LCCC) and Land Use Consultants Ltd. (LUC) will take place based on the findings of these activities in order to inform how the Limerick Public Realm Strategy takes shape over the coming months. As these companies are processing data on LCCC's behalf, there is a Data Processing Agreement in place between LCCC and LUC.

In this activity, if the personal data is to be transferred to a different country, it will be transferred to the following countries (if there are no countries listed, it is not intended to transfer the personal data abroad).:

Data will be transferred to the UK (adequacy agreement in place to facilitate this sharing).

**How long is this personal data held by Limerick City and County Council?**

Limerick City and County Council has a detailed record retention policy which goes in to more detail of the time period for which your personal data will be retained by Limerick City and County Council and what will happen to it after the required retention period has expired.

The data processed as part of this activity will be retained for the following period(s):

Under the National Retention Policy for Local Authorities 2001, and as this is an Urban Renewal Project, the information garnered from public engagement events and surveys will be retained for the lifetime of the strategy + 15 yrs and then offered to the LCCC archivist for archiving. **What will happen if the requested personal data is not provided?**

Applications/Submissions may not be processed.

**Your Rights**

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by Limerick City and County Council. You also have the right to data portability. In certain circumstances, blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you.
