The issues referred to in the Council's motion relate primarily to the manner in which social welfare schemes assess income from other sources. It is important to emphasise that eligibility for social welfare supports is a matter for the Minister for Social Protection and I do not have any statutory function in that regard.

However, I can assure the Council that the issue of disabled artists participating in the basic income scheme is a matter which I take seriously. The issues around Disability Allowance are something my officials and I were aware of from the outset of planning this intervention. Stakeholder engagement has been core to the policy development process for the Basic Income for the Arts and this included a stakeholder forum on 15 December 2021, which over 150 people attended, representing 50 resource organisations and representative organisations, including disabled artists and representatives from Arts and Disability Ireland. In addition, my Department held a public consultation throughout the month of January and the impact of such a scheme on artists with disabilities was a theme which was raised throughout the consultation.

I accept that disabled people face additional barriers and costs in order to take up employment. The BIA is a support to help artists develop self-sustaining self-employed creative practices. Government has agreed that the National Disability Inclusion Strategy Steering Group, which is chaired by Minister Anne Rabbitte, will consider issues facing disabled people, this is a whole of Government issue and not just a basic income issue.

I have met with the NCFA (National Campaign for the Arts) and DADA (Disabled Artist & Disabled Academics) on these issues. These groups have also participated in the stakeholder forum last December.

The pilot scheme is a three-year research programme to examine the impact a basic income style payment could have on artists and creative arts workers and their creative practice. A key research question will be the impact such a payment could have on artists with disabilities.

I was determined since the outset of the BIA pilot scheme that artists with disabilities would be in a position to participate in the scheme to the greatest extent possible within the legislative framework to ensure the research captured the experience of disabled artists. To that end bilateral engagement has been ongoing between my Department and the Department of Social Protection, to get agreement that the payment will be treated as earnings from self-employment and can be taken into account in earnings disregards that applies to many social welfare payments including Disability Allowance. That means that the basic income for the arts will be treated like any other income a person on social welfare earns from employment.

The actual impact of the Basic Income on a person's welfare entitlements will depend on each individual's circumstances, applicants will need to engage with the Department of Social Protection on the matter.

The Department of Social Protection published a guide to the Interaction of the Basic Income for the Arts Pilot Scheme with DSP Payments (<a href="https://www.gov.ie/en/publication/bd818-interaction-of-the-basic-income-for-the-arts-pilot-scheme-with-dsp-payments/#">https://www.gov.ie/en/publication/bd818-interaction-of-the-basic-income-for-the-arts-pilot-scheme-with-dsp-payments/#</a>) on Gov.ie on 13 April to assist all applicants for BIA in receipt of DSP supports including those with disabilities.

The Department of Social Protection has also undertaken to engage directly with disabled artists who are selected for the pilot to help them understand the impact accepting the payment would have in their individual circumstances.

I believe that the Basic Income for the Arts has the potential to help artists and creative arts workers including those with disabilities to overcome labour market barriers by creating a self-sustaining creative practice, operating on a self-employed basis. It is worth noting that of the approximately 9,000 applications received for the basic income for that arts pilot scheme 6.9% of the applications are from those with a disability.

I trust that this information is of interest to the Council.

Thank you for your letter dated 2 December, 2022. In relation to point a) raised in your correspondence, women's health is a key priority for the Minister and for this Government. The Programme for Government laid out our commitment to improving women's health outcomes and experiences − a commitment since backed up with €69.2 million in funding in Budget 2023 and €31 million in funding in Budget 2022. In March this year, on International Women's Day, the Minister launched the Women's Health Action Plan 2022-2023, laying out the actions that the Department will take to deliver real change for women in Ireland. As part of this work, the Department will continue to listen to women, women's health advocates and women's health professionals. The Minister looks forward to this ongoing engagement as work continues to build a responsive health service for women in Ireland.

I also wish to acknowledge your concerns raised in point b) and c) of your correspondence and provide information on the current status of the Patient Safety (Notifiable Patient Safety Incidents) Bill 2019.

The Patient Safety (Notifiable Patient Safety Incidents) Bill 2019 provides the legislative framework for a number of important patient safety issues, including the mandatory open disclosure of a list of notifiable patient safety incidents and the notification of the same externally to the Health Information and Quality Authority, Chief Inspector of Social Services, and the Mental Health Commission, as appropriate, to contribute to national learning and system-wide improvements. This mandatory requirement for open disclosure will ensure that patients and their families receive appropriate timely information in relation to an incident that may have occurred in relation to their care.

The Bill went to Dáil Report stage and was presented to the members of the Dáil by the Minister for Health on Wednesday 7th December 2022. It was then agreed that the Report Stage discussion of the Bill be adjourned until January, to allow for preparation of a further amendment in relation to patient requested reviews of their cancer screening.

This additional amendment that will be introduced in the Bill will place further obligations on health services providers to provide full information to patients about their patient requested reviews.

The Minister for Finance, Mr Michael McGrath TD, has asked me to reply to your letter of 13 December 2022, on behalf of Limerick City and County Council, concerning the Residential Zoned Land Tax.

The Residential Zoned Land Tax (RZLT) was introduced in Finance Act 2021. The purpose of this tax is to increase housing supply by encouraging the activation of development on lands which are suitably zoned and appropriately serviced. It aims to bring those lands which have benefitted from investment in services and are capable of being developed forward for housing. The tax is an action contained in Housing for All, the Government's plan for housing, to increase housing supply and is supported in the Programme for Government. The Department of Housing, Local Government and Heritage published section 28 Guidelines for Planning Authorities on the Residential Zoned Land Tax on 29th June 2022, which provided guidance on identifying the land which is in scope for the tax.

In order to make landowners aware of the 1 January 2023 deadline for submissions to local authorities regarding the zoning status of their land, both the Department of Finance and the Department of Housing, Local Government and Heritage undertook a significant communications campaign. This included national newspaper advertisements in nationally distributed newspapers, print advertisements in national newspaper industry-focused supplements, statutory notices in local newspapers, print advertisements in local newspapers and local radio ads throughout the country. Comprehensive informational resources were also made available online on the gov.ie/RZLT webpage, individual local authority websites and Revenue's Tax and Duty Manual published on revenue.ie in July 2022.

A concerted, targeted digital website and social media campaign also took place providing links to the aforementioned RZLT informational gov.ie site, and further amplifying awareness of the Residential Zoned Land Tax deadline for submissions, which was on 1 January 2023.

It is not possible to extend the 1 January submission deadline as it is set out in legislation, however as provided for under the relevant legislation minor discretion to accept submissions after 1 January is available to local authorities in exceptional circumstances.

I trust that this explains the position on this occasion.

At the December meeting of Monaghan County Council the members passed the following resolution and I was directed to forward same to you for attention.


That this Council calls on the Minister for Health, Department of Health and the HSE to put in place proper, sensitive procedures to avoid any future retention of a baby's organs, at post-mortem, without the express permission of the parent, to request that:

- Clear, written communication on consent forms be discussed with families at the time of death/prior to post-mortem taking place
- Best practice models be examined from other countries to ensure the Irish system is fit-for-purpose & with proper oversight
- Communication of post-mortem results be respectful and delivered by meeting with assigned medical professional – clear definition of this process should immediately become standard procedure for all hospitals
- Post-mortem documentation should include a clear, concise and fully completed document for families
- In cases where organs need to be retained; reasons must be clearly explained and a swift timeframe for their return must be communicated to parents.

Monaghan County Council demand that an investigation take place into the cases outlined by Primetime (RTE) on 3rd November 2022 and any other similar case that were not highlighted and that:

- Families who have had organs from their baby retained, be informed of what was taken and why, and what happened to the organs. These families should be afforded an in-person meeting to be given details.
- An independent inquiry takes place to determine why Consultant A was continuously used as a private pathologist after being found to be negligent in his former public-sector pathology role. This inquiry should also find reason as to why earlier recommendations, made by independent reviews, were not implemented.
- Clarification is needed on whether Consultant A is still conducting perinatal post-mortems.

I refer to your correspondence dated 2nd December 2022 regarding a motion that was adopted by Councillors at the November 2022 meeting of Limerick City and County Council seeking "to have bus shelters constructed where there is a bus stop".

There are in excess of 10,000 bus stops across the State with just over 2,000 of those stops currently having a bus shelter. Bus shelters are expensive to install and maintain – based on the required electrical arrangement, each new bus shelter can cost up to €25,000 (with wheelchair accessible stops sometimes costing much more), meaning that up to €200 million would be required to fulfil the objective of the motion. It is worth noting that we are not permitted under statutory regulation to light the bus shelter from the general public lighting system and, instead, each bus shelter has to be equipped with a separate individual electrical supply connection, adding to overall cost.

It is also the case that many bus stops locations are unsuitable for the installation of bus shelters due to underground services, width issues, sight line issues, access issues, negative impact on affected parties / adjacent premises, or similar other items.

Notwithstanding the above, the NTA fully acknowledges the importance of bus shelters and we do have a comprehensive programme for rolling out bus shelters on a prioritised basis.

We trust that the above information clarifies the position.
