



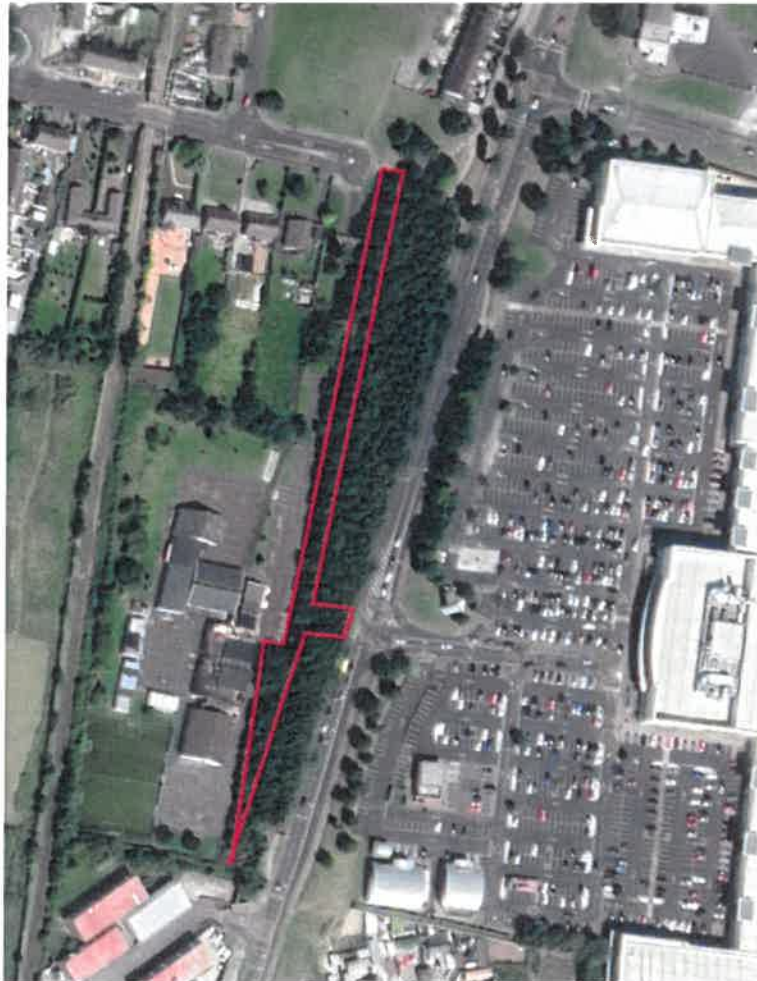

Proposed Land Transfer and Lease Disposal to St. Brigid's National School



1. Introduction

It is intended that the following proposed disposal of Limerick City and County Council's land in the form of a Deed of transfer of 0.187 hectares (0.461 acres) and 0.0137 hectares (0.0339 acres) in the form of a long term lease (map and photo attached in this report) will be included on the Agenda for the March Full Council Meeting:

2. Description and Location of Property

The subject land comprises 0.187 hectares (0.461 acres) to be disposed by Deed of Transfer and 0.0137 hectares (0.0339 acres) to be disposed by Lease to the Trustees of St. Brigid's National School, Singland, Limerick.

3. History of the Property

The LCETB have requested the extra land in order to facilitate the upgrade of the ingress and egress of the St. Brigid's National School. This upgrade will provide safer pedestrian/cycle and vehicular access. A portion of the land is being disposed of in the form of a lease to allow for possible future Bus Connects projects.


4. Key Elements of Proposal

A portion of Folios LK25596, LK5308 & LK67245F to be transferred to the Trustees of St. Brigid's National School (see map AG/5129, area highlighted in red to be transferred). Area to be transferred is 0.461 acres (0.187 Hectares), land at Singland, Limerick.

A portion of Folio LK5308 to be Leased to the Trustees of St. Brigid's National School (see map AG/5130, area highlighted in red to be leased). Area to be leased is 0.0339 acres (0.0137 hectares), land at Singland, Limerick.

5. Executive Recommendation to Council

The proposal before the Members is to note the proposed freehold disposal of 0.461 acres (0.187 Hectares), land at Singland, Limerick and the proposed disposal in the form of a lease 0.0339 acres (0.0137 hectares), land at Singland, Limerick for a consideration of €1 to the Trustees of St. Brigid's National School. St. Brigid's National School to cover Limerick City & County Council's legal costs.

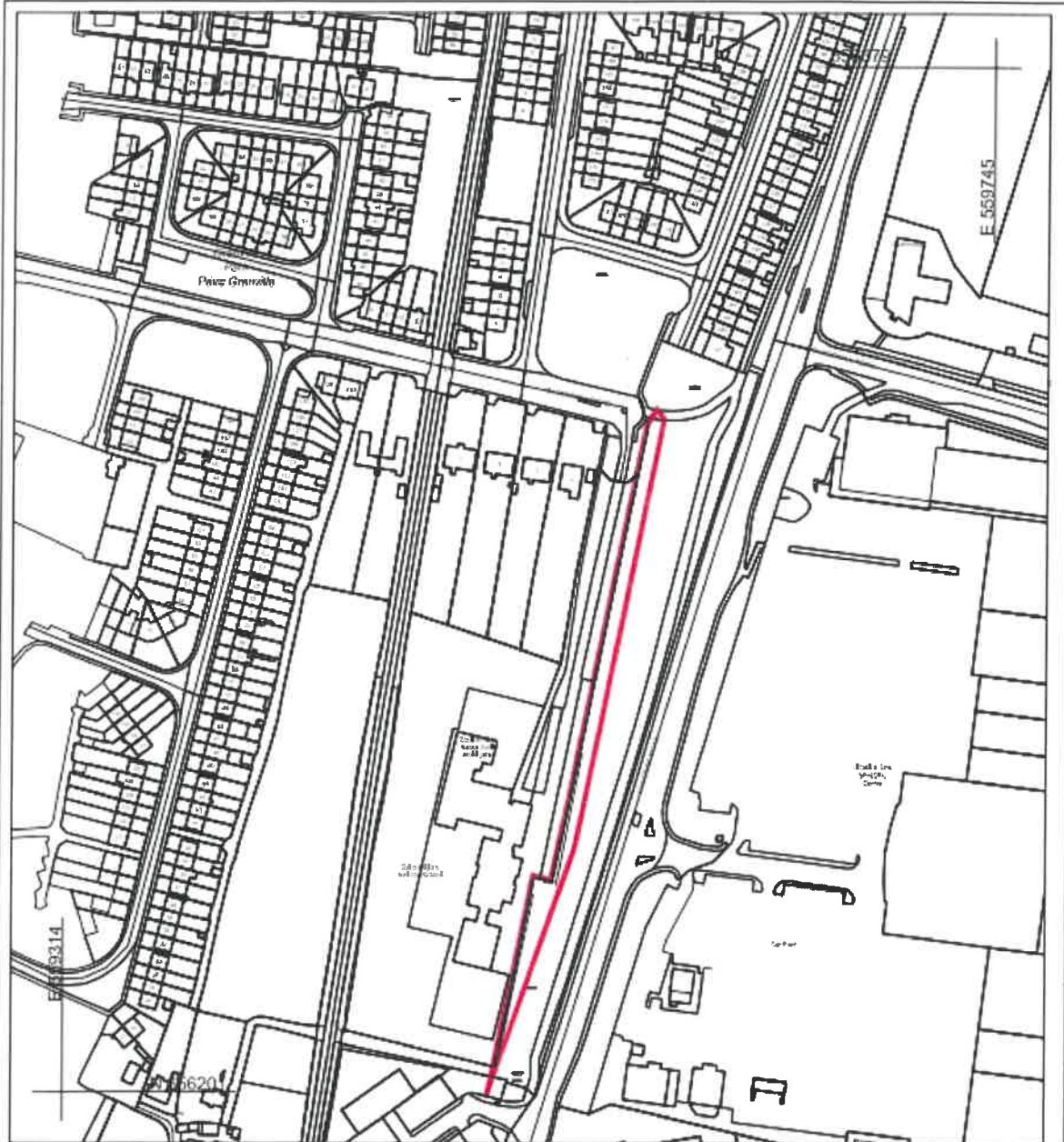
