Economic Development and Enterprise Directorate

1. Trade & Investment

- OMC Technologies Engineering Firm announced the creation of 40 new jobs, following a significant investment of €4m in the company. The investment will include an upgrade of their Head Office on Ballysimon Road, Limerick.
- Peregrine Technologies, headquartered in Nexus Innovation Centre, announced the creation of 20 new jobs after receiving an investment of €17.7m from the European Innovation Council Accelerator.

International Relations

- The Mayor of the City and County of Limerick, Councillor Francis Foley, supported by the Trade and Investment Department, welcomed the Norwegian Ambassador to Ireland, Ms. Mari Skåre. The purpose of the visit was to discuss opportunities for collaboration and strengthening of relationships between Norway and Limerick. Following the meeting at Corporate Headquarters, Merchant's Quay, the Ambassador visited King John's Castle and was given a guided tour of the Castle.

2. Local Enterprise Office (LEO)

LEO Employment Survey 2022 results were published in January showing LEO Limerick ranking joint 5th nationally with jobs created and supported in 2022.

The results summary at 01 January for LEO Limerick is as follows:

2022 was the 9th year showing year-on-year growth for LEO Limerick supported businesses. The new figures show that the LEO Limerick financially supported 305 small businesses in their portfolio across the county; these companies, in turn, employ 1,815 people.

3. Innovate Limerick

The ENGINE Collaboration Centre in Upper Cecil Street, Limerick, is now open for bookings and events. A number of events were held there during January, including the Monthly Meeting of the Limerick Metropolitan District; LEO Marketing Workshop and Start-Up Grind.

Film in Limerick

Writers' Factory

The Third Edition of our popular 22-week "Writers' Factory - Introduction to Screenwriting Course" continued, with weekly classes for a cohort of 20 local emerging screenwriters. The programme is supported by the Limerick and Clare Education and Training Board.

Film in Limerick Delegation to the European Film Market (EFM)

A call was made in January for local emerging producers to join the first in-person delegation to EFM in Berlin since 2020. Continuing our relationship with Limerick and Clare Education and Training Board, Film in Limerick is offering bursaries to locally based producers to attend and network at the market. The European Film Market (EFM) is the business centre of the Berlin Film Festival and one of the top international film markets in the world attended by over 8,300 international industry professionals.

Engine Shorts

'You're Not Home,' a short film made as part of Film in Limerick's Engine Short Film Scheme, has been selected for the prestigious SXSW Film Festival in Austin, Texas. The festival is regarded as one of the top film festivals in the world. The film, made on location in Limerick and Clare with local company Carbonated Comet, was produced by Greg Burrowes and directed by Derek Ugochukwu.

Munster Film and TV Crew Academy

Several new training courses were delivered as part of the new Munster Film and TV Crew Academy, in collaboration with Screen Ireland:

- **Train the Trainer Course** – this three-day course is aimed at training new tutors to teach courses for the crew academy, with instructions and advice on how to create and develop lesson plans and effective presentation skills.
- **Final Draft for Screenwriting** – this short course teaches emerging screenwriters and producers to use the industry-leading software for Film and TV screenwriting.
- **Introduction to Extras Coordinating** – This two-day course took place at Troy Studios and looked at the role of the Extras Coordinator. Taught by West Coast Casting, recent local productions such as the God's Spy feature film were used as examples to teach the skills and requirements of the role and the course looked at how to find work in the industry.

Local Filming

The 22 million euro Irish-Belgian feature film 'God's Spy' filmed in Limerick, as well as Clare and Tipperary, in January. Set in 1940s Germany, several Limerick locations were used, including Cleeves which doubled for Berlin airport, and Pery Square which stood in for 1940s London.

Film in Limerick worked with the producers to bring the film to Limerick and assisted with locations, crewing and production office space at the ENGINE building in the city.

Film in Limerick is also working with two upcoming TV series that are currently in pre-production and planning to film in the region shortly - 'Hidden Assets' Season 2 and 'Blackwater.'

X-Pollinator Talent Development Initiative

X-Pollinator, a talent development initiative set up to address the lack of gender diversity in the Irish screen industry, ran a week-long lab in Adare in January. Run by Blinder Films and supported by Screen Ireland, the immersive residential talent development lab was held for twelve diverse female filmmakers.

4. Forward Planning

- Work commenced on the preparation of the Newcastle West Local Area Plan with the publication of the First Issues public consultation document on 28 January.
- Material Alterations to the Draft Castleconnell Local Area Plan were placed on public display for a period of four weeks from 28 January.
- The Rathkeale Local Area Plan was adopted by the Elected Members of the Municipal District of Adare-Rathkeale on 10 January.
- Work was ongoing on the preparation of the Draft Abbeyfeale Local Area Plan. Consultation took place within local schools, which involved the participation of 125 students.

5. Digital Services

Digital Services began a mobility data pilot in January and now has access to mobility data for seven districts in Limerick city centre from two providers, Three Ireland and Huq, with a view to validating their accuracy throughout 2023 through cross-referencing exercises. This will allow Limerick City and County Council to determine tourist and visitor numbers for the city centre.

In addition, Digital Services has access to LinkedIn's Talent Insights product for 2023 which will provide intelligence on Limerick's talent strengths, deficits and employment trends.

6. Limerick Twenty Thirty

Opera Square

Progress Update

- Preferred tenderer for the next contract, the Basement and One Opera Square has been selected and a tender sum agreed. The Limerick Twenty Thirty Board has approved the selected tender.
- The full application on the planning amendment, including the Environmental Impact Assessment Report (EIAR), is being prepared.

Communications Update

- The graphics for the Opera Square hoarding have been designed by Limerick Twenty Thirty's Branding and Marketing Consultant and include collaborations with TUS Limerick School of Art and Design and Limerick City and County Council branding Consultant, M&C Saatchi.

Cleaves Riverside Quarter

Progress Update

- The Masterplan is being progressed by the Design Team. The Masterplan will focus on expediting delivery of residential units, and utilisation of the €34.5m Urban Regeneration and Development Fund grant. The Technical Analysis Report to support the final Masterplan and Vision Document is 85% complete.
- A Consultation Strategy has been implemented to ensure a comprehensive engagement with both targeted stakeholders and the general public for the Masterplan process.

Communications Update

- In line with the Consultation Strategy, a Stakeholder Consultation with Senior Technical Staff from Limerick City and County Council was held on 19 January.

1. Urban & Rural Community Development

PRIDE OF PLACE: AWARDS 2022

The Pride of Place Awards is an annual competition organised by Co-Operation Ireland and sponsored by IPB Insurance. For the 2022 Pride of Place Competition, the Council nominated four groups:

- **Adare Women's 2020 Club:** which promotes health and wellbeing for women of all ages, running activities such as a book club, arts and crafts, walking group and social gatherings.
- **Glenroe Ballyorgan Community:** The Community Council has driven a number of significant initiatives to bring new energy to this rural community. It succeeded in having the Glenroe Community National School re-opened, while Coolfree Pre-School was set up in the former Ballyorgan National School. Other projects include installation of modern dressing rooms at Glenroe GAA complex, a community walkway, astro-turf facility and local biodiversity projects.
- **St. Munchin's Community Centre Killeely-Thomondgate:** This is a busy community centre serving a wide catchment area of disadvantaged communities on the northside of Limerick city. Services include community café, meals-on-wheels, school lunches, catering for events/functions, hair and beauty salon, flower shop and photographic studio, community education and training and environmental projects, including allotments. St. Leila's School, within St. Munchin's complex, is being used as a refugee rest centre for Ukrainian refugees.
- **West End Youth Centre, Ballinacurra Weston:** The Centre is based in the heart of Ballinacurra Weston. It provides young people with opportunities for social and personal development and recreation in a safe space, offering programmes such as drug and alcohol

education, sexual health, healthy eating and LGBTQI+ inclusion, regular clubs including cooking/baking, arts and craft and games/sports. The West End Youth Centre has 80-100 young people from the community coming through the doors on a weekly basis.

The Limerick groups featured strongly in the 2022 awards when the event was held on 21 January in Dublin. The West End Youth Centre took first place in the Community-Based Youth-led Initiative in the Cities competition, Glenroe Ballyorgan, Runner-Up in communities in the Population Category 300-1,000 and St. Munchin's Community Centre Runner-Up in the Community Resilience Category.

AGE FRIENDLY

A Workshop was held on 30 January for members of the Age friendly Alliance to review and assess the First Age Friendly Strategy against key Age Friendly themes. Actions to carry forward to the second Age Friendly Strategy were outlined for discussion. Results of the Age Friendly survey and consultation with older people in the City and County through focus groups, visits to nursing homes and Interviews with external stakeholders, were summarised. Findings from this work formed the basis for discussion and consultation at this Workshop and now provides the material for the first draft of a new Age Friendly Strategy.

LOCAL COMMUNITY DEVELOPMENT COMMITTEE (LCDC)

The Local Community Development Committee meeting took place on 31 January.

Public Participation Network (PPN)

- Limerick PPN launched its series of [Podcasts](#) focusing on the valuable work being done in the community/voluntary, social inclusion and environmental sectors of Limerick.

- Membership of the PPN continues to grow and now stands at 189. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time.
- There were three linkage group meetings in January: Home and Social Development; Economic Development, Enterprise and Planning; and Community Leisure and Culture.

Environment Awareness

- The first Sustainable Gardening Course of 2023 took place in Adare on 28 January in collaboration with Adare Tidy Towns.
- Limerick City and County Council Pilot Cloth Nappy Incentive Scheme was launched on 30 January in collaboration with the Environmental Protection Agency and Voice Ireland. 20 Limerick families will be provided with a voucher number to be used to buy a cloth nappy starter kit worth €100 from partner retailers.

HEALTH AND WELLBEING

- Consultation with the Community Response Forums in the city and county concerning the allocation of the Healthy Ireland Ukrainian Health & Wellbeing Fund has commenced. The purpose of the programme is to promote health and wellbeing of Ukrainian refugees seeking protection in Ireland. The types of activities that can be supported under this fund include for example yoga, arts & crafts, art therapy, outdoor activities such as woodland walks, family day excursions, cooking programmes and gardening programmes and/or any activities that can support health and wellbeing.
- Healthy Ireland continue to have an active social media presence on its regularly updated Twitter page.

Tourism Industry and Trade Events

Arts Office

The final Community, Leisure and Culture Strategic Policy Committee sub-committee meeting for the Recovery of the Arts and Culture Sector in Limerick took place on 31 January.

Open Calls for Bursaries

Limerick Grants under the Arts Act

Limerick Arts Office advertised for applications from individual artists or organisations under the 'Grants under the Arts Act' Scheme. Limerick City and County Council offers grant funding to amateur, community or voluntary groups, or organisations, and individual arts practitioners, which in the opinion of the authority, will stimulate public interest in the arts, promote the knowledge, appreciation and practice of the arts or assist in improving the standards of the arts. Open Call to artists went live in January.

Artists' Apartments, 1-2 John's Square Call-Out 2023

The Artists' Apartments create conditions for affordable living spaces for individual artists and keep artists living and working in Limerick City, by encouraging living and working within the urban context. The apartments provide subsidised living spaces in recognition that artists and many individuals working in the arts are on modest income levels. Open Call to artists went live in January.

Strategic Fund for Culture and Arts Scheme 2023

The 2023 Strategic Fund for Culture and Arts Scheme was opened by Limerick City and County Council Arts Office. The purpose of the Scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. In January, three letters of support were issued.

The National Mentorship Programme Call-Out

Limerick Arts Office supports the Irish Writers' Centre National Mentoring Programme for Literature, ensuring that at least one writer or poet from Limerick benefits from a literature mentoring relationship. This opportunity is available to writers of literary fiction, creative non-fiction, children's/young adult fiction and poetry. The mentoring process involves four meetings between the selected 'mentee' and their chosen professional writer over a six to eight month period. The mentor will read the mentee's prose or poetry, in advance of each meeting, and share critical feedback and advice. The Open Call went live in January.

Centre Culturel Irlandais Artist Residency Programme

The Centre Culturel Irlandais Annual Residency Programme in the city of Paris offers great opportunities for artists of all disciplines. Limerick Arts Office, Limerick City and County Council, is supporting a one-month residency. Applicants must be based in the City or County of Limerick, with professional involvement in creative practice. The call closed on 12 January.

Creative Ireland

Limerick Culture and Creativity Strategy 2023-2027

Limerick City and County Council developed a new five-year Culture and Creativity Strategy for Limerick, as a part of the Creative Ireland Programme. Arts Leaders Associates have been engaged to support Limerick City and County Council for the Consultation, Research and Writing of the Culture and Creativity Strategy 2023-2027. The Strategy was adopted by the Council on 23 January.

CREATIVE IRELAND FUNDED PROJECTS

Creative Ireland Limerick secured a total funding allocation of €191,161 (€161,161 Core funding + €30,000 Cruinníu na nÓg funding) to support Limerick creatives and to bring creativity to our communities.

Creativity in Older Age - Musicians on Call

Musicians on Call was a project where professionally trained musicians worked in healthcare settings, in an appropriate and sensitive manner, to connect music-making opportunities to residents and healthcare staff in Nursing Homes and Community Hospitals. The project was delivered in collaboration with, and led by, the Limerick Arts Office, Age Friendly Limerick and Healthy Limerick, delivered in partnership with Artistic Partner Music and Healthy Ireland, Health Service Executive (HSE) and Clare County Council and Tipperary County Council. The professional healthcare musicians worked in nine settings and the project evaluation was completed in January.

Strategic and Legacy funding - Restorative Justice

The Restorative Justice Steering Group is developing a theatrical production that can capture and communicate the experiences of victims, offenders and restorative justice workers, placing context on the crime, the impact of the crime and positive outcomes from taking a restorative approach. For such a project, the process of pre-development is important to identify stakeholders, the appropriate creative practitioners, what they would need, what the restorative justice project could bring in terms of access to experiences of people. Restorative Justice have engaged a practitioner to undertake this work.

Visual Artists Ireland a Visual Artists Guide Funding and Applications Webinar and Clinics: 12 January. Training delivered in partnership with Clare and Tipperary Arts Offices.

Library

- January proved to be a busy month at the City Library with several new and returning events and activities. The first in a new series of confidence building classes began on 24 January. Organised by the Limerick Mental Health Association and with a tutor from the Limerick and Clare Education and Training Board, these classes are for adults who wish to build their skills, abilities, talents, and interests and become more confident through learning. On Monday mornings throughout the month, the Library hosted a series of Personal Development Classes for new migrants and asylum seekers organised by Paul Partnership. Also on Mondays, the University of the Third Age (U3A) attended in the afternoon on 09, 16 and 23 January for their ongoing book club series, as did the Spiral Book Club on 18 January. Award winning Limerick author, Helena Close, visited on 25 January for a creative writing workshop with students from Laurel Hill. The students thoroughly enjoyed this immersive introduction to writing skills and were encouraged and inspired to go on and create their own stories. Other primary, secondary and pre-schools visiting the City Library in January were St. John the Baptist Boys' National School on 06 January; Coláiste Mhichíl Secondary School on 18 January; St. Michael's Infant School, Scoil Iosagáin Boys' Primary School and St. Michael's National School, all on 20 January. Poppins Pre-School visited on 25 January and St. Mary's National School on 26 January. Author and storyteller, Róisín Meaney's monthly story time took place on 21 January and was as lively and fun as always with an appreciative and interactive audience. The monthly Spanish language story time 'Cuenta Cuentos' also returned for 2023 with a lively group of 25 children and adults attending the interactive bilingual story session on 17 January. The Library's own weekly Toddler Story Time also continued to entertain some wonderful young readers with story and song every Wednesday morning at 10.30am.
- Dromcollogher Library was featured in the RTE TV

Nationwide programme broadcast on 30 January. Featuring the story of the 1926 fire disaster, which claimed the lives of 48 people, the programme included interviews with locals and the author of a new play about the subject, Charlie McCarthy. The library was built on the site of the fire to commemorate the tragic event.

- The Parent, Baby and Toddler group continued their weekly meetings in Adare Library. The group is a valued support to parents and has attracted many new members. Junior and Senior Infants from Our Lady's Abbey called in to the branch for a class visit. More than 30 girls learned more about how the library works and how to find books for their age group. The month finished with a book club meeting with the Adare Women's 2020 Club.
- There were 26 onsite visits by researchers to the Local Studies Department at Watch House Cross Community Library in January. Of these, 15 involved research on the microfilm and digital archives of local and national newspapers, six on material from the Local Studies collections, while five visits related to family history research on our databases. Twenty-one remote queries were received and fully or partially resolved. Work continued on the Department's primary Decade of Centenaries project for 2023 – an edited collection of essays on Protestant life in Limerick during the revolutionary period, several new acquisitions were added to stock.
- First year students from Crescent College Comprehensive Secondary School visited Dooradoyle Library to avail of library services as their own school library is being refurbished. 'Close-Knit Friends,' the Library's new weekly knitting group, met for the first time on 18 January. Parents and children enjoyed a special story-telling session on 21 January and regular story-time sessions took place throughout the month. Dooradoyle Library's book club members met for the first time this year on 26 January to discuss 'The Snow Child' by Eowyn Ivey, which they thoroughly enjoyed. The Home Energy Saving Kit continued to be popular

amongst library members and is available for loan on a weekly basis.

- As part of Limerick Library's developing Outreach Programme, two staff members paid a visit to St. Vincent's School, Lisnagry, on 30 January for a series of story-telling events. The sessions included stories, songs and nursery rhymes.
- Limerick Libraries recently acquired a number of C-Pen Readers, which are available to borrow from selected branches. The C-Pen Reader Pen is a robust portable, pocket-sized device that reads text out aloud with a human-like digital voice. Reading pens make reading content more accessible, helping give students independence, increase reading speed and fluency, and enhance comprehension. It is a helpful tool for a wide range of readers, from those with reading and learning difficulties, particularly dyslexia, to anyone learning English as a foreign language.
- A class from Limerick and Clare Education and Training Board visited Kilmallock Library to view the exhibition titled Person/Presence/Perception. The focus of this exhibition is people - the many ways they are represented in artworks and the responses elicited by the viewer. The branch was delighted to welcome Sunshine Kids, Kilfinane Pre-School, for a session of song, stories and craft, which was enjoyed immensely by both staff and pupils. Little Readers continued with the first session of 2023 being held on 27 January. Young readers started the New Year with a fun-filled interactive session of rhyme, song, story and craft whilst their adults enjoyed a chat and a cuppa! The local Bridge Club continued to meet during the month. These two-hour sessions allow longstanding members to share their card skills with those new to the game.
- Library staff attended the first meeting of 2023 of the Rathkeale Youth Network to discuss continued collaborative work between all the partners involved. Rathkeale Library donated withdrawn children's stock to the Network for use by the groups of children and young people who attend the Rathkeale Youth Space.
- Watch House Cross Library welcomed the return

of classes to its dedicated computer room. Weekly classes took place in Literacy through computers, Fetac Level 2 Computer and Internet, and Driver Theory Support. Age Action Ireland has begun a new eight week programme for seniors where learners can bring their own device to class; laptop, tablet, iPad or smart phone and each person is assigned a tutor. The Mindfulness and Healthy Lifestyle programme continued to run weekly on Wednesdays from 10am to 12 Noon. The weekly story time was held on Thursdays at 4pm throughout January and is targeted towards children from babies to six year olds. Story time is a great way to introduce children to the world of books and these events are interactive with lots of involvement from the children being encouraged. The weekly Parent and Toddler event was well attended with an average of 20 parents with babies and toddlers enjoying play, songs and rhymes on Friday mornings. Colleagues kindly donated Lego for the launch of the new Lego Club on 06 January. The club is for children between the ages of seven and 12 years and runs from 3.30 p.m. to 4.30 p.m. on Fridays. Each week up to 20 children were busy working to a theme, with their creations on display in the children's library. There are now four book clubs meeting in the library each month, two adult groups and two for children. The seven to nine year old book club is a new venture, and held its first meeting on 23 January reading 'The Legend of Kevin' by Philip Reeve; this is a great way for children to learn to interact with one another and there are lots of fun activities to be enjoyed. Watch House Cross Library was delighted to see classes from local primary schools visiting to browse, chat to staff about the latest books and head back to school with a book to enjoy. The branch received visits from Thomond Primary School 3rd class and Corpus Christi 2nd class. An eight-week programme designed to provide information and support for those seeking asylum started on 26 January with 24 participants. Paul Partnership, working with the Limerick and Clare Education and Training Board, supported new arrivals at Knockalisheen Accommodation Centre. The Sensory Room had 65 bookings during the month with 160 users in total.

January with "Folktales from Far Away" with Simone from Story Gate telling magical stories from all around the globe. The branch also welcomed Autism Spectrum Disorder (ASD) units from local schools to make use of the Magic Table and other sensory equipment.

Limerick City Gallery of Art (LCGA)

- Brian Fay's exhibition, ***The Most Recent Forever***, attracted very significant visitor numbers with **6,227** to date. This exhibition received an Arts Council touring grant. There has been a noticeable number of group visits from LSAD (Limerick School of Art and Design), Limerick and Clare Education and Training Board (LCETB), amongst others.
- The ***Jim Kemmy Remembered*** exhibition attracted a large audience with the additional attraction of the newly acquired portrait of Michael Hartnett. The Maire and Maurice Foley Collection included a number of works on long term loan (14) from Maurice Foley, in addition to five significant works of art that have been donated to the Permanent Collection. The works in the exhibition are by important Irish artists who are not in the Permanent Collection. Both these exhibitions finished on 22 January. A new selection of work has been selected from the Permanent Collection and will be open to the public from 30 January.
- Research continued for the 2023/24 exhibition programme, with site visits from artists and curators.
- The University of the Third Age (U3A) groups continued to meet in the Gallery on a fortnightly basis for their poetry and music groups. The Director/Curator led a tour of the current exhibitions for a group, which was well attended.
- Several school groups continued to visit the Gallery, including groups from Galway and Clare and a group from the Limerick and Clare Education and Training Board in Limerick.
- On 19 January, Her Excellency, Ms Larysa Gerasko, Ambassador of Ukraine, visited Limerick Museum, where she performed the official opening of ***Shelter***, an exhibition of children's drawings from Ukrainian bomb shelters. The opening ceremony drew a large crowd, including many from the local Ukrainian community. The Curator greeted Ambassador Gerasko in Ukrainian: 'laskayo prosymo do Muzeyu Limeryka,' meaning 'welcome to Limerick Museum.' The Deputy Mayor of the City and County of Limerick, Councillor Kieran O'Hanlon, spoke of the natural affinity that Ireland has with Ukraine due to the historic and cultural parallels between the two countries. He thanked the Ambassador for sharing this collection of children's drawings with the people of Limerick. In reply, she spoke of the terrible suffering that the Ukrainian nation has undergone over the past twelve months and thanked the people of Limerick for their support. Curated by Maurice Quillinan, ***Shelter*** is a deeply moving exhibition. Drawing is a child's first response to any situation, be it happy or sad, and these drawings convey the anguish of lives uprooted, families uprooted and a whole country uprooted. They are visceral in nature but also tender in emotion.
- From 21 January, Limerick Museum extended its opening hours to include Saturdays. The Museum's new opening hours are Monday to Friday 10.00am-5.00pm and Saturday 10.00am-1.00pm and 2.00 pm-5.00 pm.
- Limerick Museum commenced a collaboration with the School of Archaeology in UCD and Abarta Heritage, who are working on an Irish Research Council-funded project dealing with the archaeology of the Irish revolutionary period (1916-23) in East Limerick. The Museum has a large collection of objects relating to the Irish Revolution.

Regeneration

The Council has appointed KPMG to prepare a status update of the Limerick Regeneration Framework Implementation Plan (LRFIP 2014-2023). The document will assess the current position and make recommendations for the future strategic direction of Limerick's Regeneration Programme. KPMG undertook focus groups in Moyross, Southill and St. Mary's Park in January with a range of residents, service providers and stakeholders with more focus groups planned.

Economic

Outreach to Employment Programme

A meeting of the Project Team was held to identify priorities of the group for the year. The Project Team will focus on these priorities through the various community mentors working across the four Regeneration areas. The Outreach to Employment Co-ordinator continued to meet with employers to expand the range of employers currently engaging with the programme. Work continued on this initiative and enquiries can be made to outreachtoemployment@limerick.ie

Social

Economic and Social Intervention Fund (ESIF) Update

The 2023 Economic and Social Intervention Fund (ESIF) grants were approved by the Department of Housing, Local Government and Heritage and letters of approval have been sent out to all applicants. Grants to the value of €3.715 million have been approved for 190 projects across the city.

Housing Developments

- Construction of the new eight-unit social housing development at Sheep Street/Athlunkard Street on King's Island is ongoing.
- Construction of the new 57-unit social housing development at Cosgrave Park and Dalgaish Park, Moyross, is ongoing.
- Construction of the new 37-unit social housing development at Churchfield (Phase 2) Southill, is ongoing.
- Construction of the new 18-unit social housing development at Cliona Park (Phase 3), Moyross, is ongoing.
- Construction of the 14 partially-constructed units by the Peter McVerry Trust in Delmege Park, Moyross, is completing. Tender assessment for the procurement of a replacement contractor for the construction of the remaining units in Delmege Park, Moyross (6), Hartigan's Villas, Moyross (4) and De Vere Court, Southill (14) is now completed with a recommendation prepared for the Department of Housing, Local Government and Heritage.
- Tender preparations are currently being completed for the 27-unit Orchard Site, King's Island.
- Tenders for consultancy services for the design of the proposed 20-unit Cliona Park Phase 4 social housing development in Moyross have been received. Assessment processes have been commenced.
- Construction Works are completing on Thermal Upgrade Contract no. 122, St. Mary's Park.

Revised stage 4 submissions have been issued to the Department on foot of the ancillary retender processes. Consequently, authorisation to advance three contracts to construction stage is awaited.

 - Thermal Upgrade Contract No. 127, Ballinacurra Weston (12 units) - Pending approval to construction stage.
 - Thermal Upgrade Contract No. 128/129, St. Mary's Park (25 units) - Approved to construction stage.

Community Facilities

Southill Play Facilities - A presentation was given to the Southill Regeneration Committee on 24 January on a draft design of a play space for Southill based on the findings of a community consultation survey. The proposal for an outdoor play and activity space for children, young people and adults was endorsed by the committee.

Ballinacurra Weston/Prospect - Congratulations to the team and young people in West End Youth Centre in Our Lady of Lourdes Community Centre who won the national Pride of Place Awards Category 6 - Community Based Youth Led Initiative category (city). A great accolade to an understated service.

King's Island Community Centre - A project brief and associated funding request for the King's Island Community Centre, inclusive of a new build element and partial refurbishment of the existing Community Centre, was submitted to the Department of Housing Local Government and Heritage in January. The project brief was developed and endorsed by a King's Island Community Centre Working Group with the brief and associated proposal endorsed by the St. Mary's Park Regeneration Committee.

Community Activities

Regeneration Connect Newsletter winter edition was circulated to all the houses in the Regeneration communities with a range of articles including events happening in each of the areas.

Southill

The launch of the 'Stronger Together - Southill Community Collaborative Planning Project' took place in the community on 25 January with many residents and service users turning up to show their support. The Mayor of the City and County of Limerick, Councillor Francis Foley, was delighted to support this partnership between Southill Hub, Southill Family Resource Centre and Tait House Community Enterprise.

An independently facilitated Workshop took place with the Southill Regeneration Committee on 24 January where new terms of reference were agreed which will see the committee focusing on strategic issues to improve quality of life in Southill, and also the expansion of the membership to include the parents council, third level education and enterprise - to name just a few.

As of January, the Local Authority Construction Team was in the process of completing works in 135 properties, Local Authority Maintenance was working on 79 properties and the Regeneration Team had 29 properties. Approved Housing Body stock transfer in process – 27 properties. 11 properties were in the process of being assigned to a Team.

Project Updates

Affordable Housing Fund (AHF)

Toppins Field Lands

An application for consideration for funding under the Pilot programme for Local Authorities regarding delivery methods/efficiencies for Affordable Housing and an examination of differing construction options on a live sample basis (Modern Methods of Construction/ Off Site Construction); Lot 2 Development with 50 – 150 Homes, was submitted to the Housing Agency in January. Three research projects are being shortlisted for funding by the Department of Housing, Local Government and Heritage, in collaboration with the Housing Agency. The integrated Design Team, led by Allies and Morrison / Cullen Payne Architects, completed an updated order of magnitude costings and this was combined into an ongoing application under the Affordable Housing Fund by the Limerick City and County Council Affordable Housing Team. The Team's traffic engineers held meetings with the Limerick City and County Council Operations and Maintenance Services and the Active Travel Department on the potential for synergies between projects in the area and possible upgrades to the infrastructure.

Curragower Lands

The Design Team Consultants were briefed at the start of January and work has begun on developing the current viability study into a preplanning design project. Archaeological and Site investigation tenders were sent

out for procurement. Pre-planning Design is underway and meetings were held with Limerick City and County Council Operations and Maintenance Services and Limerick City and County Council Property. Design risk assessments were carried out.

Sonnys Lands

An updated order of magnitude costings was done by the Limerick City and County Council Affordable Housing Team, and utilised by the Housing Agency, in updating viability modelling done to reflect the increased level of subsidy made available. An Affordable Housing Fund application is underway using these new viability figures.

- A Workshop for Councillors was held in January to discuss the proposals.

Decluttering Project

- A survey of existing city centre signage was carried out in January.

Limerick Public Realm Strategy

- The Online Survey which ran for six weeks until 12 January is closed. A total of 864 participated in the survey. Preliminary findings from the survey have been distributed from Consultants LUC to Limerick City and County Council.
- A Workshop took place with Metropolitan District Elected Members on the Public Realm Strategy currently being prepared for Limerick City Centre. Now in Stage 2 of the Programme, the Members were updated on the Information Gathering/Context Appraisal that took place across Stage 1, the Online Survey results from the first round of engagement, and future engagement events.

King's Island Walled Town

- The first internal Steering Group meeting of King's Island Walled Town took place on 30 January. The meeting included representatives from Regeneration, Tourism Arts Office, Property Services and Roads. The purpose of the internal Steering Group is to coordinate work in the area across the Directorates involved.

- Construction of a residential development comprising a four-storey apartment block consisting of 21 no. apartments, storage for bins, bikes and lock-ups and all ancillary site development works to include connections to the public water main, foul and surface water drainage, access roads, footpaths, vehicle parking, landscaping, boundary treatments and site development works above and below ground on lands at the at the Junction of the Childers Road/Greenfield Road, Rosbrien, Limerick.
- A development comprising demolition of existing showroom/sales building, storage sheds, single-storey derelict dwelling house and all other structures and boundary walls on the site. The construction of a new building of a total gross floor area of 4,208 square metres, ranging in height from three to seven storeys, to provide 122 no. student bed spaces (22 no. apartments) with an internal courtyard providing vehicular access from Old Clare Street to 4 no. staff parking spaces, 68 no. bicycle parking spaces, private open space, bin store and ESB substation. 4. Urban Innovation

SMARTLAB Project Launches at the Citizen Innovation Lab

The project was launched at the Citizen Innovation Lab, and the first drop-in sessions took place on 26 January.

This energy research project offers the opportunity for people in Limerick to install free smart sensors to monitor and reduce building energy use. The SMARTLAB project is funded by the Sustainable Energy Authority of Ireland (SEAI) Research Development and Demonstration (RD&D) Funding Programme. Limerick City and County Council, Integrated Environmental Solutions, The Convex Lens and

Carrig Conservation International are all project partners and the project is led by the University of Limerick.

The initiative is to test new ways to make buildings smart-ready, so they can better respond to the needs of occupants, cost less to run, and be ready to interact with a future decarbonised energy grid. Local building owners and occupants were invited to join the project, receiving free energy monitors and environmental sensors to install in their buildings, and free expert analysis of how healthy and energy efficient their building currently is.

Up to 100 building owners and occupants in Limerick city were invited to install sensors provided by SMARTLAB to monitor their building's temperature, humidity, and carbon dioxide levels. The project team will support participants to understand far more about how their buildings use energy, giving them more power to lower energy costs and make good decisions about their building's future.

The SMARTLAB project will use a living lab approach and work with project participants to explore the real-world challenges and opportunities of making buildings smart ready. Project outcomes will be used to create policy guidance concerning the adoption of the European Union Smart Readiness Indicator in Ireland.

Technical Support Instrument (TSI)

A kick-off meeting of the Technical Support Instrument (TSI) was held in January between Urban Innovation project partners and consultants. This project is a European Union programme operated by Directorate-General for Structural Reform Support (DG Reform) that provides tailor-made technical expertise to European Union member states to design and implement reform. The project seeks to establish a model of sustainable investment that would support the retrofitting of historic building across Limerick. It combines a request from the Office of Public Works (OPW) to develop specific advice for historic buildings and the development of a training programme for public sector staff. The European Union

appointed a consortium of consultants led by an economic consultancy firm based in Brussels and Rotterdam, Trinomics, to carry out this work, together with a number of sub-contractors, including Technical University of the Shannon – Midlands Midwest.



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the contact centre throughout the month of January:

- Customer Services Call Centre answered 11,698 calls. This represents an average of 557 per day, with the number of calls exceeding 600 on several occasions and reaching as high as 656. 69% of calls were handled at first point of contact.
- A total of 3,497 emails were processed through the Customer Services email platform.

- 3,606 cases were created, with 724 of these logged on behalf of Public Representatives. 3,284 cases were closed, with 717 of these being cases logged by Public Representatives.
- Of these 3,606 cases, Customer Services staff logged 67% of same.
- The logging of cases through the MyLimerick portal continued, with a total of 257 cases being logged. Of these, 232 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests, with 88% of housing maintenance cases for the Limerick Metropolitan District being logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 112 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 101 were applied for and 86 issued.
- Customer Services staff welcomed a total of 2,481 customers at both the Merchant's Quay and Dooradoyle offices.
