QUESTIONS

7. Question submitted by Councillor S. Hartigan

I will ask at the next Meeting can Limerick City and County Council please provide a legal opinion on the rights of a person to record a public Council meeting, whether in person or online; and to outline, if there is a legal barrier to recording, what sanctions can Limerick City and County Council impose if a meeting is recorded by an individual.

REPLY: The Standing Orders for Meetings, which are adopted by the Elected Members, state that no cameras of any kind, or sound recording, or communication equipment may be used by any person at Meetings of the Council, without prior approval of the Council.

The Meetings Administrator also begins each Meeting by outlining the requirements of Standing Orders that any recording is prohibited, i.e. that no recording of the Meeting and its proceedings by any person, including Elected Members and attending members of the public and media, shall be allowed.

The Standing Orders also state that any Member of the Council, or any other attendee, who, in the opinion of the Mayor, transgresses any Standing Order or refuses to obey the ruling of the Mayor, may be called to order by the Mayor.

If (s)he persists in her/his refusal to obey the ruling of the Mayor, then the Mayor may suspend her/him for the remainder of the sitting. The Standing Orders also outline that the provisions of Section 57(d) of the Local Government Reform Act 2014 shall apply in relation to disorderly conduct. The legislation provides for sanctions, including, for example, suspension from meetings and a reduction in remuneration.

Separately, the recording of a meeting may not be in compliance with the General Data Protection Regulation (GDPR) and, depending on the circumstances, there may be legal remedies available therein to an attendee at a meeting who believes a recording was possibly made and who wishes to contest same.

8. Question submitted by Councillor J. Scanlan

I will ask at the next Meeting (a) how much of the Council-approved loan to Easy Bikes has been drawn down and what the outstanding balance stands at, (b) how many bicycles were purchased, (c) where are these Bikes stored, and (d) what is the connection with the Limerick Bike Hire and how does the name change impact on this Council's Loan Agreement.

REPLY:

- (a) How much of the Council-approved loan to Easy Bikes has been drawn down and what the outstanding balance stands at:** The loan of €300,000 to Lazy Bike Tour Company is fully drawn down. The loan payments made to date are €23,300 in line with the agreed payment schedule.
- (b) How many bicycles were purchased:** To date, Limerick Greenway Bike Hire has purchased approximately 300 bikes.

- (c) **Where are these Bikes stored:** All bikes are stored locally, in Co. Limerick.
- (d) **What is the connection with the Limerick Bike Hire and how does the name change impact on this Council's Loan Agreement:** The loan agreement with Limerick City and County Council is with The Lazy Bike Tour Company Limited. This loan is personally guaranteed and is registered with the CRO (Companies Registration Office). Limerick Greenway Bike Hire Ltd. is the name of the company they have set up to operate from the Limerick Greenway Hubs. This does not impact on the loan agreement.

9. Question submitted by Councillor J. Scanlan

I will ask at the next Meeting how much money has been spent by our Authority on Consultancy Services in each of the years 2018 through to 2022.

REPLY: Section 14 of Schedule 10 of the Local Government Act outlines that the Minutes of the proceedings of a Meeting of the Council shall be drawn up by the Meetings Administrator and shall include:

- The date, place and time of the Meeting;
- The names of the Members present at the Meeting;
- The names of the senior employees of the Local Authority present at the Meeting;
- Reference to any report submitted to the Members at the Meeting.
- Where there is a roll call vote, the number and names of Members voting for and against the Motion and those abstaining.
- Particulars of all Resolutions passed at the Meeting and such other matters considered appropriate.

This provision is included in the Standing Orders of the Meeting. The written Minutes of the Meeting form the record, are publicly available and are intended to capture the information as set out in the legislation.

With regard to the video recording of Meetings, this topic is currently being considered by a Working Group of the Corporate Committee of the Local Government Management Agency (LGMA). The Data Protection Officer Network is also considering the options. In light of the processing of personal data involved, there are a number of factors to be considered including the legal basis for the recording, as well as compliance with principles such as data minimisation, transparency, purpose limitation and storage limitation. Processing personal data in this manner would have to demonstrate that the processing is necessary, proportionate and justified. The Committee will take a risk-based approach and arrange for a Data Protection Impact Assessment to be carried out which will be available to each local authority for consideration.

The Meetings Administrator also read the Reply to the earlier Question No. 7 on the agenda, submitted by Councillor Hartigan, in relation to the same matter, a copy of which had been circulated to the Members prior to the Meeting.

The Members discussed the merits and risks of recording Meetings and the remedies available if someone were to record the meeting without permission.

Following further discussion, Councillor Hartigan stated that he was happy to defer the Motion if legal advice were sought on the matter. The Chief Executive agreed to the request to seek formal legal advice on the matter.

12. Notice of Motion submitted by Councillor J. Leddin

I will move at the next Meeting that Limerick City and County Council invite Irish Rail to a Council Meeting to update Members on the planned refurbishment of the railway line from Limerick to Foynes and discuss potential of disused Mungret line.
