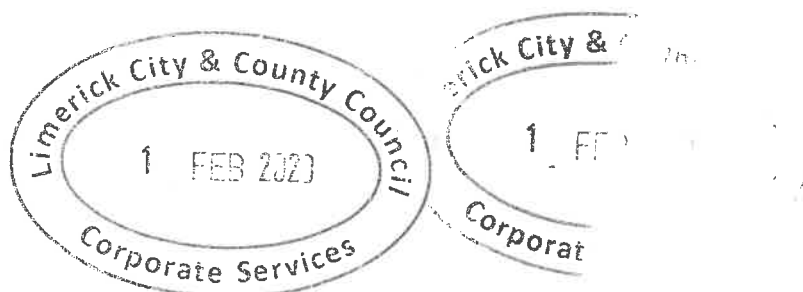

Summary of Conference Content


Briefing on budget 2023 covering the primary changes in taxation including USC rates, personal tax bands and the overall Social Protection budget of €23.4 billion, Overview on the Government cost of living supports to include long term social welfare and those on disability lump sum payment schedules and eligibility guidelines.

Overview on the new Child Benefit rates, Xmas bonus and Fuel allowance payments. Briefing on the employment programmes and also overview on the various supports to help offset energy costs. Separate briefing on the main taxation changes together with presentation on new vacant homes tax, and carbon tax changes. Presentation also on the Ukrainian credit guarantee scheme, small firms investment efficiency scheme and additional supports for agri sector. Other areas included housing and capital allocations for social and affordable houses, supports for homeless services and the main regeneration schemes.

Information also on Health budgets, Environment, Justice, Education and Transport in terms of main changes included as part of the new budget.

Report on Trip to Tallinn, Estonia
18th to 21st January 2023

A delegation recently travelled to Tallinn, Estonia to attend the European Green Capital 2023 conference. The delegation from Limerick attended because of Limerick being awarded the Green Cities award in 2020.

The delegation comprised of Mayor Francis Foley and Ms. Nuala O'Connell, Senior Planner, Planning Environment and Place Making.

The delegation took part in a number of events with the objective of:

- Fostering closer links with other European Green Cities.
- Sharing and learning from best practice in other cities.
- Developing relationships and contacts from local authorities from across Europe.

I am satisfied that these objectives were met during the course of the events attended. Travel took place on 18 January, 2023 from Dublin to Helsinki and onward from Helsinki to Tallinn.

On 20th January the delegation attended the event Conference entitled "Fantastic Beasts: Making European cities safe, inclusive, resilient and sustainable" which covered topics including building ecosystems for green and healthy cities; shaping inclusive and just cities; involving citizens, organisations and businesses in city governance; rethinking governance at local level; and realising Sustainable Development Goals in European cities.


On the evening of 20th January the delegation attended a gala dinner which provided further opportunities for networking and discussion.

Report on Mayoral visit to Birmingham, England – 23rd to 25th February 2023

A Chomhairleoir, a Chara,

As members will be aware, at the invitation of the Limerick Association Birmingham, I travelled to Birmingham, England from the 23rd – 25th of February 2023. I was accompanied on this trip by Vincent Murray, Director of Service, Economic Development & Enterprise.

Limerick City and County Council has a long-standing relationship with the Limerick Association Birmingham. As Mayor of the City and County of Limerick, I was honored to be invited to meet the Lord Mayor of Birmingham and also to attend the association's annual Grand Dinner Dance at St. Francis Centre, Wretham Road, Birmingham.

The Limerick Association Birmingham is a community group, which provides various economic and social support and cultural services to the Limerick diaspora, and indeed wider Irish community, in Birmingham. Limerick City and County Council are committed to working with our diaspora networks to promote and share Limerick culture more widely around the world. During this trip, I also took the opportunity to promote Limerick as the business investment location of choice for Foreign Direct Investment (FDI) and Indigenous Companies.

The meetings and events, which I attended during the course of our visit, are summarised below:

1. On my first engagement, I had the opportunity to tour Birmingham City Centre to look at the various transformational projects across their city Centre and to see first-hand how the city Centre is reinventing itself as a sustainable and cosmopolitan city.
2. Later that evening, I had a meeting, presentations and dinner with officials from the Limerick Association Birmingham on their ongoing programs.
3. On the second day of my visit, I had the pleasure of meeting with Eileen Schofield, Chairperson of the West Midlands Irish Business Group (WMIBG). Eileen is one of the founding members of the WMIBG, which was formed in 2008 to bring first and second

generation Irish business professionals together in an informal way to engage and network. This meeting gave Vincent Murray and I the opportunity to update Eileen on the various economic developments projects, which are taking place across Limerick City and County.

4. Later that morning I had a meeting with the Birmingham Chamber of Commerce. Here I met with Mandy Haque. Ms Haque has direct responsibility for all International activities for the Greater Birmingham Chambers of Commerce including the Transatlantic Chamber, the Commonwealth Chamber, export and import documentation, translations, international programmes, training and the delivery of the international trade programme on behalf of the Department for International Trade. She is also Vice President of the British American Business Council globally. This again was a fantastic opportunity to promote Limerick as an international investment location and the Chamber and very keen to link business in Birmingham with opportunities in Limerick and vice versa. I took the opportunity to invite Mandy and a delegation from Birmingham to visit Limerick on a trade mission in the future.
5. In the afternoon, I paid a courtesy visit to the Deputy Leader of Birmingham City Council, Councillor Brigid Jones. Councillor Brigid Jones informed me she had visited Limerick last year and was very impressed with her visit. Councillor Jones is the Labour Member for Bournbrook and Selly Park and the Deputy Leader of Birmingham City Council. She becomes leader of the Council when the leader is not available and has accountability for the review and improvement of all council services, management of all corporate resources of the council, and oversight of the management of services and delivery of outcomes. It was very interesting to get some insight into the workings of Birmingham City Council and to hear about the challenges and opportunities, which they face.
6. On the final day of my visit, following her invitation I visited the Lord Mayor of Birmingham, Councilor Maureen Cornish at Birmingham City Hall. On this visit I was accompanied by Key officers of The Limerick Association and Vincent Murray. In addition to her work as a Lord Mayor, Maureen serves the community as a local magistrate, has done for the last ten years, and is a school governor for Arthur Terry School. Maureen has always been passionate about helping and supporting young people and their families. Her practical life experiences in courts and schools made her an ideal candidate for Mayor. In our meeting we discussed the role that Irish people play in the development of Birmingham and we discussed how our two cities could cooperate better across economic and cultural activities.

7. That evening I attended the Limerick Association of Birmingham, Annual Grand Dinner Dance at St. Francis Centre. I was the joint guest of honor at this event with the Lord Mayor of Birmingham, Councillor Maureen Cornish and the Most Reverend Bernard Longley the Archbishop of Birmingham, head of the Archdiocese of Birmingham. It was great to meet so many Limerick people at this event and to hear about all the great work the organisation is doing with the Limerick diaspora community in the region and also to meet the various Limerick people who have made Birmingham their home.

I am satisfied that suitable engagement with our diaspora and the business community in Birmingham was achieved during this trip and that further opportunities will arise. I am particularly pleased with the passion, pride and energy for Limerick, which I experienced from meeting Limerick's people abroad.
