


**MEETING OF THE METROPOLITAN DISTRICT OF LIMERICK to be held on Monday, 20<sup>th</sup> March 2023.**

**Notice of Motion submitted by Councillor C. Slattery**

I will move at the next Meeting of the Metropolitan District of Limerick that Limerick City and County Council change their policy when it comes to payment of grants such as Housing Adaptation grants for people with a disability, Housing Aid for Older People and Mobility Aids Grants and instead of lodging the grant that has been approved to the applicants bank account the grant should be paid directly to the contractor bank account who has completed the job.

**REPLY:**

- The Housing Adaptation Grant for Persons with a Disability, Housing Aid for Older People and the Mobility Aid Grants are grants which are available to private householders. The housing aid grants are works carried out to private houses, where the householder & approved grant applicant engages directly with the contractor. The Council administers the scheme and approves an applicant for a grant but does not recommend or engage contractors to carry out works to the approved applicant's property as this is the responsibility of the householder.
- Once an applicant is approved for a grant, it is the decision of the householder to engage a contractor to carry out the works. Applicants are advised at the time of approval that payment of the grant will be made directly to them. If there are future issues with workmanship or payment queries this is between the contractor and the applicant and Limerick City and County Council has no liability.
- Under the Revenue Guidance Notes for Government Payments, Local Authorities are required to file an annual return of payments made in the previous year which includes the Tax Reference details of those receiving payment. The payments made to approved applicants for the housing aid grants noted above would also be included in this report. Any contractor employed directly by the Council to carry out what would be deemed construction works is subject to Relevant Contractor Retention Tax and details of the contract must be filed with ROS by the Council. Local Authorities are deemed principal contractors and if the practice of paying contractors instead of the approved housing grant applicants for works under the Housing grant scheme, it could be deemed that the RCT system would apply.
- In exceptional circumstances we do authorise payment to contractors where an applicant does not have a bank account. These are considered on a case by case basis.

**REPLY:**

Safety fencing has been erected by Limerick City and County Council around some dangerous structures sites in accordance with Section 3 of the Local Government Sanitary Services Act 1964. Temporary safety fencing is sometimes required to minimise the health and safety risks posed by these dangerous structures to the passing public. Installed safety fencing can only be removed once the risks have been resolved but we aim to ensure that it's duration on site is minimised to ensure minimal disruption where possible.
