How do I avail of the Vacant Property Grant Allowance Scheme assistance?

- 1. Property must be vacant on the Date of Making of the Rate 2nd February 2023
- 2. Auctioneers letter must be provided as proof that property is / was available for letting and must state that property is 'to let' for the relevant period.

 OR:
 - If the property is vacant for a period to allow for completion of repairs, then details of works, with receipts for works etc. must be submitted with this application.
- 3. Photographs of the property showing external and internal image of property must be provided as proof that the property is maintained to a level that would allow its use for commercial purposes i.e. fit for beneficial occupation.
- 4. Completed Vacant Property Grant Allowance Scheme Form must be returned with payment as per above see reverse.

If a Vacant Property is sold, the Commercial Rates for 2023 are due IN FULL

Failure to make a valid application within the calendar year will mean that the rates liability is deemed due in full for the year on the property and may result in legal action.
